## Government Notifications

### THE ESALA FESTIVAL (PERAHARA) OF AMMADUWA SMALL KATARAGAMA DEWALAYA IN 2013

01. The Esala Festival in year 2013 will be started on 04th October, 2013. After finishing the Pirith Ceremony; it will start on 05th October in the auspicious time.
- From 09th to 13th October Kumbal Perahara,  
From 14th to 18th Dewala Perahara,  
From 19th to 23rd October Randoli Perahara.
- On 24th October early in the morning, the historical Water Cutting ceremony will be finished in “Diyabole Pokunu Mukalana” (the jungle).
02. The location of the Dewalaya  
North by the jungle which situated in back side of the Dewalaya.  
South by Ranwala Ammaduwa Road;  
East by Mr. Dewagiri Kapumahaththaya’s land (home garden);  
West by Mr. Heennilame’s land (home garden)
03. It is not responsibility to enter, deliver, help or produce the food items in the camp site, with venereal diseases or other serious diseased people. Specially food cabins, food restaurants, bakeries, dansala, etc.
04. It is prohibited to take a cattle or any kind of animal to the camp site without a written permission by the District Secretary.
05. It is prohibited to transport vehicles and walking in or out and near the camp site. But the help of 07th Regulation the bulls and bullockcarts can enter the parking places. This Regulation will not cause for parking bulls and bullock carts for their separate sections.
06. All bakeries, food cabins, Food making places, food restaurants, dansal and buildings for business activities are in the camp site. There should be wood dustbins with lids or metal dustbins with lids. They must be thickness of 1 1/2 meteres of the capacity.
07. All remaining drinks likes tea, coffee, milk etc. and discarded cooking items should not throw here and there in the camp site. All rubbish or discarded things should put into the dustbins according to the 19th Regulations. It somebody throws this dust on the ground or near the floor and it is seen by the owner, head resident or licensed owner can take legally action to avoid that work. If they do not concern this warnings they may be the unlawful persons.
08. On the view of the District Secretary, someone who breaks the 15th, 16th, 17th, 18th or 19th Regulations and carry out a bakery, food cabin, food making hut, restaurant, dansal or threading place in the camp site can prohibite such

- activities. Further these place can be close. It there are licences, it also can be cancelled by the Authority.
09. There are some persons who are suffering from venereal diseases or other serious diseases should not associate with people in the camp. If somebody has known it, they must be reported immediatly to the Police or Physical Health Officer.
10. It is not permission to enter or help to the bakery, food cabin, food restaurant etc.. with venereal diseases or other serious diseases people. They should not even make food or serve food to the people.
11. If an owner of food restaurant, food cabin, a dansal or a pilgrim rest should not give accomodation for some period to stay, to those diseased people if it reveal, the owner must inform immediatly to a Doctor, or P. H. I. or a Police Officer.
12. Under the 07th Regulation begging and donation should not reserve places not in the camp site with money or other ways. Anyone should not donate money or serving money or somethings in the camp site.
13. According to 07th and 10th Regulations, someone should not remove a notice, name board unlawfully.
14. A District Secretary, a Doctor and P. H. I. or Police Officer.
- (a) Can take legally action to enter to the land in the camp site.
- (b) According to 07th regulation, a name board, a notice can display in the camp site. To struck a pole or make any building in the camp site has a leagally authority.
