NOTIFICATION MADE UNDER STATE LAND REGULATION No.21 (2)

IT is hereby notified that for the Cultivation Purpose, Arabha Waththage Thanuja Nishanthi Rodhdhriigo has requested on lease a state land containing in extent about 19.65 Ph. forming a portion of Lot Number B as depicted in the Tracing No. of TSS/2009/287 and situated in the Village of Yodhakandiya No. 13 which belongs to the Grama Niladhari Division of Ranakeliya coming within the area of authority of Tissamaharama Divisional Secretariat in the District of Hambantota.

02. Given below are the boundaries of the land requested :-

On the North by : Land of P. A. Andaraya's ;
On the East by : Land of D. A. Malini ;
On the South by : Land No. A & road for village ;
On the West by : Land of D. A. Siripala.

03. The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions and the following conditions :-

(a) *Terms of the Lease.*— Thirty Years (30) (from 15.06.1995);

The Annual rent of the Lease.— 4% of the undeveloped Value of the land as per valuation of the Chief Valuer in the year 1995. This amount of the lease must be quinquennially revised in such a manner that the amount as a result of the revision will be not less than 50% of the amount that just preceded.

Penalty .- Treble 4% of the developed value of the land;

- (b) This lessees must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary ;
- (c) The lessees must not use this land for any purposes other than for the purpose of cultivation ;
- (d) The lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary and by other institutions ;
- (e) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease ;
- (f) No sub - leasing can be done until the expiry of a minimum period of 05 years from 17.09.2012;
- (g) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse;

If acceptable reasons are not submitted to me in writing within six weeks of the date herein below to the effect that this land must not be given on lease, the land will be leased out as requested.
