Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication i.e. Notices for publication in the weekly *Gazette* of 20th December, 2013 should reach Government Press on or before 12.00 noon on 06th December, 2013.

A BILL TO AMEND THE SRI LANKA INSTITUTE OF INTERIOR DESIGNERS (INCORPORATION) ACT No.02 OF 1998

I, John Amarathunga, MP do hereby give notice under Standing Order No. 48 of Standing Orders of Parliament of the Democratic Socialist Republic of Sri Lanka, that I propose to introduce in Parliament a Bill entitled "A Bill to amend the Sri Lanka Institute of Interior Designer (Incorporation) Act No.02 of 1998"

The aim of the Bill is to amend the Section No. 04 of the act under the General Powers of Corporation, to include the following :

1. Membership in the Corporation is a requirement for all Practitioners in the field of Interior Design and Recognition of the Professional Status and Licence for practice of an Interior Designer, Interior Architect, Interior Technologist and Interior Decorator will be for those who have obtained approval from the Corporation fulfilling the requirements and abiding by the Rules and Regulations and Ethical Code of Practice.

2. The Corporation will be the responsible body to award Charter Status (Chartered Interior Designer) to those who specialize and qualify for such recognition in the field of Interior Design.
3. The Corporation will provide a Quality Assurance Certificate for Market Acceptance on such Interior Products of good Designer value and production quality.
4. Recommendation by the Corporation will be necessary for the awarding of Certificates for competency in Technical Skills in the field of Interior Decoration and Interior Technology.
5. The Corporation will assist in Curriculum Development to establish high standards in Interior Design Education.
