By Laws

DEHIOWITA PRADESHIYA SABHA

In terms of the powers vested by me under Section 123 of Pradeshiya Sabha Act, as the Minister in Charge of the subject of Local Government, I hereby declare that I have approved the following by-law imposed by the Dehiowita Pradeshiya Sabha of the administrative Jurisdiction of Sabaragamuwa Provincial Council by virtue of the powers vested in it under Section 122 and 126 of Pradeshiya Sabha Act No. 15 of 1987.

By-Laws Relating to Regularize, Control and Charge Fees on the Crematorium of the Dehiowita Pradeshiya Sabha

- By virture of powers vested in with the Dehiowita Pradeshiya Sabha under Section 122 of the Pradeshiya Sabha Act No. 15 of 1987, the By-laws in this part are cited as the By-laws relating to regularize, control and charge fees on the crematorium of the Dehiowita Pradeshiya Sabha.
- (a) No dead body shall be cremated in any crematorium owned by the Council without a licence issued by the Chairman or an Authorized Officer.
 - (b) Unless a Magistrate or an Inquirer in to Sudden Deaths has granted permission to cremate a dead body on completion of an inquiry made in respect of it by the said Magistrate or the Inquirer into Sudden Deaths, under the Criminal Procedure Code Act, No. 15 of 1979, the Chairman or the Authorized Officer shall not accept it for cremation or issue a licence to cremate it.
 - (c) Unless the relevant crematorium of the Dehiowita Pradeshiya Sabha has been named in the 7th Column of the Death Certificate of a deceased, under "Cause of Death and the place of the burial or cremation' the Chairman or the Authorized Officer shall not accept the dead body for cremation or issue a licence to cremate it.
- (a) While it is possible to determine by Resolution approved by the Dehiowita Pradeshiya Sabha the charges for the cremation of a dead body it shall be amended from time to time on such approval of a Resolution.

- (b) While charges levied or amended from time to time under paragraph (a) above shall be published in the Gazette it shall be prominently displayed at the place where applications are received for booking the crematorium and at the crematorium.
- (c) Anybody expecting to cremate dead bodies at the crematorium of the Dehiowita Pradeshiya Sabha shall pay the charges set out in the first Schedule of this part for the cremation of dead bodies
- (d) No fee shall be charged for the cremation of a dead body of any Chairman, Vice Chairman, Member or Employee who serves presently at the Sabha or any Chairman, Vice Chairman or Member who had served previously at the Sabha.
- (e) Even though a dead body has been delivered to the crematorium for cremation, the Chairman has the power to bury the dead body, if the dead body shall be unable to cremate before or during of cremation on electric failure or technical faults of the machineries of the crematorium
- 4. Anybody expecting to obtain a licence mentioned in By-law No. 2 (hereinafter referred to as "the applicant") shall forward an application substantially prepared in accordance with the Second Schedule to this part together with the documents mentioned below to the Chairman or the Authorized Officer:—
 - (a) (1) The National Identity Card of the applicant,
 - (2) The National Identity Card or Birth Certificate of the deceased (if available).
 - (3) The certificate issued by the Grama Niladhari of the Division where the deceased was living,

in order to facilitate the establishment of the relationship between the deceased and the applicant;

- (b) If an inquiry under the Criminal Procedure Code Act, No. 15 of 1979 had been made in respect of the death of the deceased, the certificate issued by the Magistrate or the Inquirer-into-Sudden Deaths under Paragraph 41(e) of the Registration of Births and Deaths Ordinance giving permission to cremate the dead body or the certificate issued under Paragraph 43(b) of the Registration of Birth and Deaths Ordinance, in the event of the dead body being of a still born person; and
- (c) the Death Certificate of the deceased.
- 5. In the event of a decision being arrived at to issue a licence on an application made for permission to cremate a dead

body, it shall be the duty of the Chairman or the Authorized Officer to register the death in the sequence such applications are received in a Register substantially prepared according to the Fifth Schedule to this part. This Register shall be maintained at the Office of the Dehiowita Pradeshiya Sabha accepting applications.

- 6. In the event of accepting any dead body for cremation in accordance with the application forwarded, the applicant shall be issued with the licence by the Chairman or the Authorized Officer after charging the fees levied according to First Scheduled. The time and the date on which the dead body due to be cremated according to the licence should be handed over to the Crematorium Keeper shall be clearly specified in the relevant licence.
- 7. In the event of a dead body being not accepted for cremation due to some reason the Chairman or the Authorized Officer shall take steps to immediately inform the applicant in writing about it, specifying the reasons for such nonacceptance.
- Dead bodies shall be accepted for cremation and cremations shall be done between the periods 7.00 a.m. to 7.00 p.m. on all days of the week.
- 9. The dead body shall be handed over to the Crematorium Keeper on or before the time specified in the licence issued. The Chairman of the Dehiowita Pradeshiya Sabha or the Authorized Officer shall not be subjected to responsibility in respect of any inconvenience or loss caused to the applicant or anybody else having rights over the deceased due to the failure to handover the dead body on time.
- The Crematorium Keeper shall maintain a Register substantially prepared in accordance with the Sixth Schedule to this part, in regard to each dead body cremated in any crematorium.
- 11. (a) The applicant or any authorized representative of him shall take possession of the ashes of the body before the elapse of seventy two hours after the cremation of any dead body.
 - (b) At the time of reserving the Crematorium to cremate the dead body, a proper container indicating the name and address of the deceased (with a tied cap) shall be handed over by the next of kin of the deceased to the Crematorium Keper to deposit the ashes of the deceased after cremation
 - (c) The ashes of the body shall not be handed over to any person other than the next of kin of the deceased.
 - (d) However, on a written request made by the applicant the Chairman or the Authorized Officer shall extend the period during which the ashes are kept with the Crematorium Keeper.

- (e) The period of extension for the ashes to be kept in the custody of the Crematorium Keeper under paragraph(b) shall not be more than two weeks from the date of the cremation.
- (f) The Chairman or the Authorized Officer or the Crematorium Keeper shall have the power to dispose of the ashes that had not been removed even after the expiry of such period allowed for the removal of ashes.
- (g) It shall be the duty of the Chairman or the Authorized Officer to make arrangements to bury the ashes not removed by any applicant or any authorized representative at the premises of the crematorium or in any cremetery.
- (h The ashes removed from the crematorium shall be inserted to the container handed over according to the provisions of Section 11(a) and the container shall be deposited safely in the section or room reserved for the aforesaid purpose by the Crematorium Keeper.
- 12. (a) Nobody other than the Crematorium Keeper or his Assistants shall enter into the covered section of the chamber of the Crematorium after the closure of the security door of the chamber on introducing the dead body into the chamber of any crematorium.
 - (b) Nobody shall enter into the premises of any crematorium without permission from the Chairman, Authorized Officer or the Crematorium Keeper.
 - (c) Notwithstanding anything stated in Paragraph (b)
 - any other person or persons who participate in the handing over of a dead body for cremation with the person who had obtained a licence to cremate it or with his authorized representative, and,
 - (ii) any other person or persons who arrive at the crematorium on the specified date or earlier to receive ashes, with the person who had obtained the licence or with his authorized representative,
 - shall be considered as persons who have been allowed to enter the premises of the crematorium.
 - (d) The Chairman shall have the final authority to decide any matter arisen in implementation of these by-laws
 - Any person who violates any section in these by laws shall be guilty of an offence and on being convicted by a court of proper juisdiction shall be liable to a fine not exceeding Rs. 750 0 and in case of containing the violation by any person even after being convicted by a court, such person shall be liable to an extra fine not exceeding Rs. 250 0 per each day of violation.

Maheepala Herath, Minister in-Charge of the subject of Local Government, Sabaragamuwa Province.

BY-LAWS RELATING TO REGULARIZE, SUPERVISE AND CONTROL OF PARKING VEHICLES AND TRAFFIC CONTROL ON ROADS WITHIN THE AREA OF AUTHORIY OF THE DEHIOWITA PRADESHIYA SABHA.

- The By-laws in this part are cited as the By-laws relating to regularize, supervise and control of parking vehicles and traffic control on the roads within the area of authority of the Dehiowita Pradeshiya Sabha.
- 2. (a) The Dehiowita Pradeshiya Sabha shall have the power to -
 - (i) ban the parking of vehicles;
 - (ii) limit the parking of vehicles;
 - (iii) allow parking on one side only;
 - (iv) ban or limit the loading or unloading of goods;
 - (v) ban loading and unloading of passengers;
 - (vi) name bus stops;
 - (vii) name one way streets and roads and to determine the direction of traffic,

on any section of any street or road in the area of authority of the Dehiowita Pradeshiya Sabha.

- (b) It shall be the duty of the Chairman of the Dehiowita Pradeshiya Sabha to take action to fix road signs on limitations at relevant places after placing any limitations made by the Dehiowita Pradeshiya Sabha under paragraph 02 (a). While these road signs on the limitations shall be in accordance with provisions published in the *Gazette Extra-ordinary* No. 448/18 dated 13th March 1987, having been made by the Minister under Section 237 of the Motor Traffic Act read with section 164 of the said Act, they are subject to amendments made from time to time.
- 3. Any driver of a vehicle being driven along any street or road located within or lying along the area of authority of the Dehiowita Pradeshiya Sabha shall obey the Provisions depicted in a road sign or signs fixed under the Provisions in paragraph (b) of by-law No.2.

- 4. Notwithstanding anything stated in the by-law No. 3 the limitations prescribed by any road sign fixed on the decision of the Dehiowita Pradeshiya Sabha under the provisions of by-law No. 2 shall not apply in respect of,
 - (a) a fire fighting vehicle or any other vehicle of the Dehiowita Pradeshiya Sabha used for the purpose of control any fire or any disaster occurring at any building or close to a building in any section of the street or road; it shall not be considered as a violation of the provisions in by-law No. 3.
- 5. (a) The Dehiowita Pradeshiya Sabha shall have the power to allocate. -
 - (i) any plot of land owned by the Sabha; or
 - (ii) any plot of land owned by any other Authority, according to an agreement entered into with such Authority for the purpose of parking motor vehicles, hereinafter referred to as "the vehicle park", within the area of authority of the Dehiowita Pradeshiya Sabha.
 - (b) The Dehiowita Pradeshiya Sabha shall decide from time to time the type of vehicles that shall be parked in any vehicle park and the maximum number of vehicles that shall be parked at a time.
 - (c) Every vehicle park indicated in Section 05 shall be published in the *Gazette* annually by the Pradeshiya Sabha.
- 6. At least two gates shall be made available in every vehicle park, one as a point of entry and the other as an exit. However, in the event of allocating a separate area in the park for the sole purpose of moving vehicles and allowing double lanes for vehicular traffic, with sufficient space at the gate it shall be in order to have only one gate for entry as well as exit.
- 7. Action shall be taken to display easily readable notices in all the three languages at the entry and the exit for the convenience of the vehicles arriving at the vehicle park. Moreover, arrows with white lines 20 centimetres wide shall be marked so as to enable the drivers to easily recognize the directions they shall follow while entering into the vehicle park and leaving it.
- 8. (i) The floor of every vehicle park shall be well prepared to park the vehicles (tar, concrete or any other material laid) and sufficient drains shall have been constructed for the free flow of water accumulated at the site.
 - (ii)It shall be the duty of the Chairman of the Dehiowita Pradeshiya Sabha to provide separate lavatory facilities for the males and females using the vehicle park
- 9. It shall be the duty of the Chairman of the Dehiowita Pradeshiya Sabha to make such separations in every possible instance.

- When accommodation is made to park vehicles at any vehicle park, sufficient traffic lanes shall be made available for the convenience of vehicles entering and leaving the premises.
- 11. When any vehicle is being driven or being parked within the vehicle park sufficient space shall be made available in it to park each vehicle so as not to cause any obstruction to those already parked within and a white line of 10 centimetres wide shall be marked to indicate the space allocated to each vehicle in the park.
- 12. An amount of money decided by the Dehiowita Pradeshiya Sabha from time to time shall be charged for parking vehicles in a vehicle park. Moreover it shall be the duty of the Chairman of the Dehiowita Pradeshiya Sabha to display at the entrance prominently in all the three languages the amount of money decided upon by the Council as charges for parking of any type of vehicle in any vehicle park.
- 13. (a) (i) Any employee of the Dehiowita Pradeshiya Sabha;
 - (ii) Any successful bidder selected by the Dehiowita Pradeshiya Sabha after calling for tenders or a person named by the particular bidder, hereinafter referred to as the "Vehicle Park Warden" shall be employed by the Dehiowita Pradeshiya Sabha.
 - to collect charges made on vehicles parked in the vehicle park.
 - (b) However, while the fees charged for parking vehicles in any vehicle park shall not exceed the fees decided by the Dehiowita Pradeshiya Sabha in the manner stated in the Third Schedule. the fees charged for parking each vehicle shall be noted down in a receipt substantially prepared according to the First Schedule in this part and issued to the driver.
- 14. It shall be the duty of the Chairman of the Dehiowita Pradeshiya Sabha to take action to see that every Vehicle Park Warden on duty is dressed in a suit to be decided by the Dehiowita Pradeshiya Sabha and which would allow easy identification of the Park Warden.
- 15. (a) It shall be the duty of the Vehicle Park Warden to issue an Admission Card indicating permission to enter and prepared substantially in accordance with the First Schedule in this part to the driver of the vehicle at the entrance to the Park when a vehicle of any type allowed to be parked under Paragraph (b) of By law, No. 5 enters the vehicle park.
 - (b) Before leaving the vehicle park, it shall be the duty of the driver of any vehicle parked in the vehicle park to -
 - return the card mentioned in paragraph (a) to the Vehicle Park Warden,

- (ii) pay to the Vehicle Park Warden parking fees decided upon by the Council in the manner set out in Bylaw, No. 12;
- (iii) obtain a suitable receipt mentioned in Paragraph (b) of By-law, No. 13.
- (c) An admission card prepared substantially in accordance with the Second Schedule in this part, in place of the receipt issued in accordance with the First Schedule, should be obtained for the permanent taxies parked in the vehicle park upon payment of a fee stipulated in accordance with the Third Schedule in this part and the said admission card should be stuck on the taxi so as to enable outside display.
- (d) It shall be the duty of the Vehicle Park Warden to issue an Admission Card prepared substantially in accordance with the Second Schedule in this part.
- 16 (a) Any person shall not park or drive into a vehicle park or allow to be driven into the park any vehicle or a vehicle which is not a motor vehicle unless it is a vehicle of the type decided by the Dehiowita Pradeshiya Sabha to be allowed into the Park for parking.
 - (b) When there is sufficient space at the entry gate for any vehicle arriving at the vehicle park to tow away any vehicle parked inside it when it is found impossible to start it in order to take it out of the park, the provisions in Paragraph (a) shall not apply for the other vehicle. However, such towing shall not be made in a manner causing any obstacle or harm to other vehicles parked in the vehicle park.
- 17. Any person shall not, -
 - (a) wash a vehicle or cause a vehicle to be washed;
 - (b) make any repairs other than an essential repair in order to start the vehicle or changing a tyre for the purpose of taking the vehicle out of the vehicle park;
 - (c) make any noise which is considered unnecessary or oppressive when any repair mentioned in Paragraph (b) are carried out;
 - (d) park vehicles so as to block the lanes of the vehicle park or the gates at the entry and the exit;
 - (e) blow the alarm instruments fixed in the vehicle except for the purpose of preventing an accident or ensuring the safety of the occupants in the vehicle;
 - (f) consume liquor or spit after chewing betel leaves or use indecent language or create commotion or engage in immoral activities, in any vehicle park.
- 18. While the responsibility in regard to the security of any vehicle parked in any vehicle park shall lie with the person who parks it in the vehicle park the Dehiowita Pradeshiya Sabha or the Chairman of the Dehiowita Pradeshiya Sabha

or the Vehicle Park Warden shall not be subjected to responsibility in regard to any loss or harm caused within the vehicle park.

- 19. It shall be the duty of the owner or the driver of any vehicle parked within any vehicle park to submit for inspection the admission card issued in respect of the vehicle when the Chairman of the Dehiowita Pradeshiya Sabha or any Authorized Officer or the Vehicle Park Warden or any Police Officer requests it for inspection.
- No vehicle shall on any occasion be driven in the opposite direction to that which is marked in the lane within any vehicle park in the manner set out in By-law, No. 7.
- No person shall harm or deface any construction made or instrument found in any vehicle park.
- 22. It shall be lawful for the Chairman of the Dehiowita Pradeshiya Sabha, or an Authorized Officer or the Vehicle Park Warden to take action to remove any vehicle parked in the vehicle park without a valid admission card.
- 23. In this part, unless the context otherwise requires -
 - "road" means any road, highway, lane, avenue, street, bylane, pair of steps, stepping log or pedestrian bridge owned by the Council and it shall also include any directional sign, demarcation stone, demarcation

post, lamp post, bridge, any type of culvert, water crossing, parapet wall, arch, bund, drain, sluice, supportive bund, hand rail, chain, fence, sign board, road sign or a pavement by the side of a road fixed or erected in relation to any road, highway, lane, street, avenue or pair of steps possessed by the Dehiowita Pradeshiya Sabha.

"vehicle" means any motor vehicle in conformity with the definition given in the Motor Traffic Act in respect of any motor vehicle.

- 24. Any person who violates any Section in these by laws shall be guilty of an offence and on being convicted by a court of proper jurisdiction shall be liable to a fine set out in sub section 122(2) of the Pradeshiya Sabha Act, No. 15 of 1987 and in case of continuing the violation by any person even after being convicted by a court or being handed over a notice in writing thereon by the Chairman or an Authorized Officer of the Dehiowita Pradeshiya Sabha considering the violation, such person shall be liable to an extra fine set out on such Violation in Sub Section 122(2) of the Pradeshiya Sabha Act, No. 15 of 1987.
- 25. In the event of any inconsistency between the Tamil and English texts of this By Law, the Sinhala text shall prevail.

DEHIOWITA PRADESHIYA SABHA

By Law on the Maintenance of Weekly Fair

- 01. This ByLaw is known as the by law of Administration, controlling, supervising of the fair in area under the power of Dehiowita Pradeshiya Sabha.
- 02. The factors mentioned below should be followed by the Pradeshiya Sabha of Dehiowita for the maintenance of the fair built by the Pradeshiya Sabha.
 - All the buildings in the fair should be constructed with bricks, cement stones or laterite and they should be permanent buildings. The floor of all the blocks should be concreted and they should be at least 1 meter in height.
 - 2. Roofs should be covered permanently with tin sheets and work should be completed.
 - 3. There should be a space of two cm (2cm) between the rows of buildings inside the fair which would enable the consumers to use as pavements and it should be fenced

- permanently with a building material and there should be well planned drainage system in which the rain water can be drained well in order to easy mobilization of the consumers.
- 4. Each and every shelf build inside the boundary of the weekly fair should be a slab of concrete on the wall built with cement stone or laterite. They must be leveled with cement and tiled. In any circumstance that the method mentioned above failed, it should be the slab should build with concrete and well plastered with cement and each block should be separated with a white line which should indicate the separation.
- 5. Gutters should be fixed to every roof and sufficient down pipes should be fixed to bring down the water collected in roofs systematically.
- 6. If water to be used in a block, there should be facilities to store water safely.

- Sufficient amount of toilets and lavatories should be built separately for men and women and for the disabled. And walls of each block should be tiled to the height of at least 1m from the level of the floor.
- The pavement between two blocks which would enable the movement of the consumers should be covered with a roof to save them from the sun and rain, and the water collected should be left to a drain in a systematic way.
- It is lawful to run a canteen or a coffee or tea shop approved by the Pradeshiya Sabha.
- It is the duty of the Sabha to supply electricity to shops to meet their demands.
- 11. It is the duty of the Sabha to avail facilities for fulfilling the religious needs in the boundary of the weekly fair.
- 12. A tap for the public should be fixed in the boundary of the weekly fair.
- 13. There should be a separate place for planting vegetables and fruit and it is strictly restricted using taps fixed in the toilets or taps fixed for the drinking water for the purpose of watering the plants.
- 14. A proper drainage system should be designed for the flow of the rain water pouring from the roof and coming on vegetable and fruit plot in the boundary of the fair.
- 15. It is the duty of the Pradeshiya Sabha to separate the shops in the weekly fair into blocks and have separate shops for beef, fish, dried fish, vegetable, fruit, grocery and for selling other items respectively according to the location of the blocks and to hand the sign boards.
- 16. The wastes generated in the environment,
 - (a) Biological rubbish;
 - (b) Glass;
 - (c) Paper or paper related materials;
 - (d) Polythene, plastic or materials related to polythene and plastic and rigifoam;
 - (e) Iron or other metals and metal mixed parts and;
 - (f) Dangerous wastes;

should be collected separately in tanks or vessels and they should be in the boundary of the weekly fair in order to collect the wastes separately. There should be tanks or vessels made of tin or tanks to biological wastes and they should be covered with lids to stop entering of mice, flies, birds and any other creatures. And it is very important to have a systematic disposal of garbage collected in the weekly fair boundary.

- 03. 1. Whole the garbage generated in the boundary of the fair or on or near the sales slab by salesmen working in shops and vendors approved by a ticket.
 - (a) Biological rubbish;
 - (b) Glass;
 - (c) Paper or paper related materials;
 - (d) Polythene, plastic or materials related to polythene and plastics and rigifoam;
 - (e) Iron or other metals and metal mixed parts and;
 - (f) Dangerous wastes;

should be sorted accordingly and left to separate tanks built by Pradeshiya Sabha or receptacles or to a system introduced by the Pradeshiya Sabha it is the duty of everyone mentioned above is to put the garbage into the proper place arranged by the Sabha.

- Other than the particular waste no individual should not put any other wastes in the tanks or containers allotted for particular variety of waste.
- Venue of any business in weekly fair means the boundary permanently marked by the Sabha.
 - 2. It is not permissible to keep any materials things or instruments used for selling or any other materials or thing other than in the venue mentioned in 4.1 accept the situation of bringing them to the fair and away from the fair.
 - 3. It is not permissible to do business other than in blocks allotted and approved boundary fair vendors. Pavement should be kept for the easy mobilization of passers-by.
- 05. It is not permissible to cook by any individual place other than the place mentioned by 2ix inside the boundary of the fair
- 06. In any weekly fair belong to Dehiowita Pradeshiya Sabha,
 - Inside the fair not allow to making troubles, using alcohol and drugs and using the bad words and bagging;
 - Staying inside the gates after closing it at the end of day to day activities;
 - Damaging the vegetation, sign board or other materials or make a loss or change the pattern when trying decorating or extending a building;
 - 4. Polluting the water supplied for use or waste or letting to waste or waste in any other ways or bathing or washing clothes or bath animals and wash vegetables and fruits and wash for any one except the place allotted for the purpose.

- Store goods which will block the way to the main switch and damage the main switch;
- 6. Get water supply illegally from main pipe hung for supplying water or any other pipeline;
- Except the place allotted for beef/ vegetable/ fish/show or sell.
- Taking in another place except motor vehicle bicycle or motor bike to another places in the out stopping at the car park
- 07. 1. A person who recently has suffered from a spreadable disease or who was as a by-stander of a so called patient should not engage in business activities in any manner and should not be an assistant of the business holder or should not be allowed to do any activities the weekly fair
 - If person who have worn only washed and cleaned dress are allowed to sell item and the salesman who wear indifferent ways are not allowed.
- 08. It is the duty of the Sabha that to clean the boundary of weekly fair before the day of fair and after the fair.
- 09. Persons who sell vegetable fruit, fish beef and dried fish should wash the slab at the end of their purpose.
- 10. Except the particular thing allotted by the Pradeshiya Sabha for each block other things should not be sold or exhibited inspire the sale by any person.
- 11. Flesh of cattle or any animal killed in a licenced slaughter house under the rules should not be exhibit or sold in any shops by any persons.
- 12. If slaughtering cattle has banned in the slaughter house in a particular day under Slaughtering Act 17, a magistrate has *Gazette* the rules keeping beef and exhibited for sale is prohibited in a shop.
- 13. Bringing or permitting to bring dogs or any other animals or birds by any body to the boundary of the fair should not be allowed it is advisable to realize that law and be avoided in a circumstance when a police officer brings a dog for any investigation in the boundary of the fair.
- 14. The business is over and leaving the shops sale staging is closed all the lights and fans should be put off electrical machines.
- 15. Candles or clay lamps should not be lighter for religious in any place purpose except the venue mention in 2XI.
- 16. It is the duty of the Chairman to make arrangements for washing the toilets at least thrice a day using anti biotic and the drains at least twice on the days of fair.

- 17. It is the duty of the Chairman to remove the garbage collected in the tanks built as per By-law 2(xvi) at least one a day and more than once if necessary.
- 18. Any person who has got licence under the By-law 23 to use a particular place for particular business it should not changed to a person or any other particular item of sale business should not be done and if such situations detected by authorized officers or chairman it is duty of them to expel him from the boundary of the fair on the particular day of cancel the licence.
- 19. Any person who has got licence to use a boutique or a place for business purposes should not create room for any others to do some other business view or show even in a portion his place.
- 20. Constructing any building in a manner of changing the plan of the fair by any body without approval to do so should be avoided unless pre approval is not given.
- 21. The days in which the fair should be opened should be decided the Pradeshiya Sabha. It is the duty of the Chairman to have a notice board showing days and the time of which the fair keep open and the board should be fixed at the entrance.
- 22. Any person running a business in the boundary of weekly fair should have gained licence according to the article I of this By-law. It is lawful to change of payment or the changes made earlier can be lawful.
- 23. None can use a place in the fair business purpose except the place approved for him by the Pradeshiya Sabha.
- 24. Any person engaged in business has to signed agreement according to article two to allot a space and he has to act accordingly to the rules and regulations.
- 25. Whatever it has mentioned in the By-law 25, it is lawful for a person who has undergone and signed an agreement with the Pradeshiya Sabha latest to use the fair in the Dehiowita Pradeshiya Sabha from the moment it is reinforced and the power is given by By-law 24 to use; manipulate and used can be considered as a trades any individual who is engaged in business and mention for more in the by-law should undergo an agreement within 3 months from the date of agreement according to the rules mentioned under By-law 24.
- 26. 1. An agreement signed under the terms of by-law Nos. 24 and 25 of Pradeshiya Sabha valid for only one year should be and before one month of the expiry date of previous agreement, a new agreement should be made with the Pradeshiya Sabha, and it is lawful allot a venue in that manner, the person who sign the agreement should have a power to use the year next by making validity every year
 - 2. However the person who undergo the agreement should pay for the next year for approval according (26 I) to use or manipulate business premises according to the prevailing permission fee.

- 27. Unless any expired agreement made valid for the following year under the rules of By-law No. 30 to use or manipulate the business premises will be no room for the owner to use the business place and he will lose the ownership after date of 30 days from the date of expiry of the agreement.
- 28. According to the agreement allot an area in the fair except the persons who made agreements nobody can engage in business activities and it is unlawful and if another person to running a business is detected the agreement will be cancelled and any lost or damage occurred to the person due to the return of the business place to the Pradeshiya Sabha it is his responsibility to bear the burden and not the responsibility of Pradeshiya Sabha or chairman or secretary or any authorized officers.
- 29. During the signing of the agreement it is lawful to pay whole the amount decided in the general meeting to be paid for the agreement.
- 30. 1 For certain business place in the weekly fair the payment for each day should be paid by day payers according to approval mentioned in article 2 and entitled to expel from the weekly fair boundary by the chairman, secretary or authorized officer at any circumstances.
 - A trader who comes for the first time to the fair can buy and approval ticked and do his business without making an agreement but the following he as to under go for an agreement lawfully.
 - 3. If a dispute occurs among the licence holders issued under law-30 1 or their workers or public in the boundary of the fair it can be subsided by the chairman or any authorized person appointed by the chairman to boundary of the fair.
 - 4. Peace should be maintained by the officer or officers in duty in the weekly fair boundary.
 - When consumers (buyers) or sellers who come to the weekly fair boundary were given an order in order to maintain peace by a police officer on duty or an authorized officer it is everyone's duty to obey it.
 - It is lawful to ban if an edible food item viewed for sale found to be bad for health after an experiment the chairman, PHI or an authorized health officer appointed by the chairman.
 - The items mention in paragraph 6 found to be bad for health by the PHI it is lawful to destroy them and no compensation would be given to the owners of the food.
 - Making any changes, temporally roofing, stabilizing an area from the shop given or close to that without any approval letter from the chairman is unlawful.
 - Except the goods belong to the Sabha such a table chair or so on should be kept near or inside the shop or made close by the shop is unlawful

- In the business premises, supplying electricity from the bulb or water from the tap for public use should not be approved or allowed.
- 32. Any authorized officer appointed by the secretary can issue on approval and change any person who wants to use or manipulate a business place inside weekly fair like wise.
 - Cash collected by an authorized officer should be deposited to the Sabha account before 3pm as the duty, if failed deposited the cash collected on any day it should deposited on the next to the Pradeshiya Sabha fund.
- 33. According to the By-law No 32 if the secretary is unable to appoint an authorized person to issue approval to use and manipulate the shops in fair and collect the charge he should be appointed by calling tender.
- 34. The person appointed by calling tender for a year to issue approval valid for the particular year and tender should be called the next year again and selected a person to collect money. If the money collector of the previous year applied for the next year too to select as a money collection is banned by By-laws.
- When choosing a money collector under rules of By-law
 the following duties should be done by him.
 - Refundable and non-refundable charges decided by the Sabha at the time calling tender should be deposited to the Pradeshiya Sabha
 - 3. To sign an agreement with the Pradeshiya Sabha regarding money collecting
 - 4. According to the agreement signed under the rules of paragraph (II) 35 folds of monthly wage should be deposited as security fund at the Sabha he should try to deposit more than one third of the amount or more than it
 - Approval to use the any weekly fair conducted by Pradeshiya Sabha should not be given to persons who fail to complete the rules mentioned paragraph 35. I
- 36. More than the amount decided by the Pradeshiya Sabha under by 23 of Pradeshiya Sabha should not be collected by any collector from any preson who use or manipulate the shops in Pradeshiya Sabha.
- 37. In the agreement signed by the Pradeshiya Sabha with any of the money collector according to the sub law (1) of By-law 35(II):
 - 1. Method of issuing approval to use business place.
 - 2. The way collecting fee(charge for the approval and the fee (charge).

- 3. Total amount of money payable to Pradeshiya Sabha by the money collected (fund raises) for the year of agreement.
- The amount should be paid in 12 installments and the amount of one installment.
- The date in which the amount payable to the Pradeshiya Sabha each month'
- 6. The collector agreement to pay 10% extra as a fine in term in which one fails to pay the fee on time.
- 7. Money collector should pay the security fund 3 folds of monthly wage to the Pradeshiya Sabha during the agreement.

It is the duty of Pradeshiya Sabha to draw up conditions for agreement.

- 38. 1. It is the duty of the secretary send notice of demand to pay the money to the money collector (Fund raiser) when he failed to pay the fee on date total amount of and the left and balance exceed more than two months.
 - 2. When the money collector fails to pay the balance with in seven day of the notice to Pradeshiya Sabha the agreement made with the Saba and it is the duty of the Sabha to send notice of the cancellation to the money collector on the same date.
 - 3. After the cancellation according to the rules 28 I of agreement the money collector should not issue any approval to any person to use and manipulate the shops and should engage in collecting money.
 - It is the duty of the secretary to appoint an authorized officer to collect money from the date of cancellation of agreement according to the rules in 38 II to collect money from the persons who use and manipulate the shops in the fair. If the secretary consider that the authorized officer (finds it difficulty) cannot continue collecting money according By-law 34 he has to inform his view to the chairman and chairman should forward to the Pradeshiya Sabha. When Pradeshiya Sabha is informed on this method Pradeshiya
- 39. The date and the time of the fair to be held should be view in written as a notice to be seen well close to the entrance in every weekly fair.
- 40. It is lawful to buy any item of food item put for sale only for cash by the chairman of the Sabha or any other authorized individuals and it is unlawful to get any item without money or by any means and it should avoided taking things without paying and trying to take things without paying and making troubles should be avoided.

- 41. The time period of supervision by the chairman or an authorized officer denoted by this By-law means any of the time during the day the shops kept open.
- 42. It is a false to contravence any of the rules entered in the Bylaw and if any individual found guilty by any of the courts the individual will be fined under the Act 122 (2) of No. 15 of 1987 and if he continues the same unlawful deed even after he has been fined and continues even after a written notice sent to him by the chairman, secretary or and authorized officer selected by the secretary the person found to be guilty should be fined according to the rules mentioned by Act 122(2) of No. 15 of the Pradeshiya Sabha Act of 1987 and an additional fine should be charged for each day he found to be an outlaw.
- 43. If in need of the meaning form the terms used in the By-laws.
 - 1. 'Weekly fair' denoted that a place built to engage in business and sell fruits vegetables and or other items produced at home and suggests any place built and managed by the Pradeshiya Sabha and any place buying or selling to whole sale basis is also included.
 - 2. A person who signs the agreement means a person who run a business in the boundary of fair after signing an agreement.
 - 'Business place' means any place divided by drawing white and on the floor for business purposes inside the fair building.

Conditions

- 3. I know that I am compelled to pay a sum of Rsfor the daily ticket for the block No.....unless this agreement is cancelled due to contravence or according to the wish of the person who signed the agreement.
- 4. Power is vested in the Pradeshiya Sabha to change the amount of refundable charge and the charge for the daily ticket. The party that signs the agreement agrees to pay the revisal from the very date.
- Pradeshiya Sabha would work to repel any business place that fail to pay for the ticket on the particular day of business.
- 6. It is lawful to cancel the agreement after the period of one month of notice to the Pradeshiya Sabha to cancel the agreement and any money paid to the Sabha would not refundable in such a situation.

There is no vested interest to the person who has signed the agreement to ask to refund the money paid for allocation of blocks during the time of cancellation of agreement.

7. Any damages should not be made by the person who signs the agreement his representative or his workers carelessly or purposefully to the properties such as electricity water supply gate doors and windows of weekly fair which belongs to the Pradeshiya Sabha. Further it is said that the Pradeshiya Sabha should not make any damage to the properties of the person who signs agreement with the Pradeshiya Sabha during the time of leaving with his properties after the cancellation of the agreement. Moreover when a person of agreement leaving

- with his properties the end of the year should not damage any of the property of Sabha in way carelessly or purposefully.
- 8. The person who signs the agreement should not sell or rent or lease the place with the approval of the sabha. Moreover, the person who sign the agreement cannot change the owner of the business or sell a Part or do join business.
- The person who signs agreement should admit the Mayor/ the Chairman or any Authorized officer enter the business place and he has to well supply with arrangements for them.
- 10. Any changes by fixing or other means should not be done to the building of the weekly fair by the person agree without the permission of the mayor/or chairman.
- 12. It should not be planned by the person who undergo the agreement to block the water drinage system or put garbage in a way to stop the function of them or put or throw any materials to block other vessels such as basins or drains.
- Garbage should not be thrown here and there except damping in the proper place.
- 14. Any advertisements or notices should not be pasted or fixed on the pillars or wall inside or outside of the business place.
- 15. Any items or instruments should not be kept on the roof of the business place by the person who signs the agreements.
- 16. Any type of material or instruments should not be stored or dumped exceeding the limited area of the business place goods and instruments unloaded from vehicles should be removed immediately.
- 17. Vehicle that transport extra goods should not be parked in the premises of weekly fair.
- 18. The premises of the weekly fair is open from 3 pm the previous day of the fair an till 9 am the next day of the fair and except this duration there is no power to stay in the business premises for the person who signs the agreement or his representative or his workers.
- 19. When the person who signs agreement, his representative or his worker found to be suffering from certain diseases that can be spread he is entitled (should) submit a medical certificate when request by an officer of the Pradeshiya Sabha when the person who signed the agreement any of his representatives or workers found to be suffering from such disease should not enter the business place during the period of disease.

- 20. In any circumstances any by law or conditions or rules mentioned here and brought hereafter by the Pradeshiya Sabha found to be broken or exceeded by the person who signs agreement or by his representative or by his workers the agreement will be cancelled with the ownership of leasee by the Pradeshiya Sabha
- 21. If any contradiction of position occurs between parties sign it should be informed to the secretary of ministry of provincial Government and none ofthe parties can make decisions unless a request is made and otherwise the Secretary's decision will be the final. But if an appeal was made by the party with in seven (7) days of the secretary's decision and officer to inquire the problem will be appointed by the secretary the retrival Act No. 11 of 1995 will be followed in this case. Even regarding the problem or law the decision made will the final and it should be accepted by the persons who under signed the agreement.
