2. Review of the Board of Management:

2.1 Objective

The objective and the purpose of the Fund, is to afford Provident Fund benefits to those Public Servants who are, not pensionable.

2.2 Functions

The main functions of the P. S. P. F. are,

- (a) to recover and credit the Fund by an amount equivalent to 8% of the monthly salaries of those who are non-pensionable and are serving in the various departments of the Island and in the foreign missions abroad;
- (b) to receive the contributions and to store, such contributions in a methodical manner;
- (c) to process and maintain individual accounts of such contributors to enable the contributors to be notified of the amount lying to their credit at the end of each financial year, and refund the benefits at the end of contributor's service;
- (d) to invest the excess money of the Fund in "Government securities" to enable the contributors to secure a higher interest and appropriate such interest, at the end of every financial year.

2.3 Performance Appraisal:

(a) Financial Results

The amount received as Compulsory contribution and Government Bonus during the year under review was Rs. 691,647,282 and Rs. 788,455,187 respectively, while the contributions received during the Year 2010 was Rs. 699,295,538 and Rs. 937,496,299 respectively. The total income from investment of the Fund after tax was Rs. 2,436,213,602 as compared with Rs. 2,601,861,541 last year. After providing for administrative expenses of the fund amounting to Rs. 9,905,543 a sum of Rs. 2,426,308,059 was available for appropriation as interest to the contributors. The percentage of interest thus available was 9.19% as compared with the percentage of interest of 11.03% during the pervious year. However, the percentage of interest rounded up to the nearest quarter being 9.15% amounting to Rs. 2,451,793,244 was appropriated and the balance amounting to Rs. 12,070,246 was transferred to the General Reserve.

Report of the Auditor General on the Financial Statements of the Public Service Provident Fund for the year ended 31st December, 2011

THE audit of financial statements of the Public Service Provident Fund for the year ended 31st December, 2011 comprising the balance sheet as at 31st December, 2011 and the income statement, and cash flow statement for the year then ended and a summary of significant accounting policies and other explanatory information was carried out under my direction in pursuance of provisions in Article 154 (1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 24 (1) of the Public Service Provident Fund Ordinance (Cap 621). My comments and observation on the above financial statements appear in this report.

1:2 Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Generally Accepted Accounting Principles and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements, whether due to fraud or error.

1:3 Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Sri Lanka Auditing Standards. Those Standards require I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements.

An audit involves procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgements, including the assessment of risks of material misstatements of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Fund's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Fund's internal control. An audit also includes evaluating the appropriateness of accounting policies used and reasonableness of accounting estimates made by management, as well as evaluating the overall presentaion of financial statements.

I believe that audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified opinion.

1.4 Basis for Qualified Opinion

My opinon is qualified based on the matters described in paragraph 2.2 of this report.

2. Financial Statements

2.1 Qualified Opinion

In my opinion except for the effects of the matters described in paragraph 2.2 of this report, the financial statements give a true and fair view of the financial position of the Public Service Provident Fund as at 31st December, 2011 and its financial performance and cash flows for the year then ended in accordance with Generally Accepted Accounting Principles.

2:2 Comments on Financial Statements

2:2:1 Accounting Deficiencies

- (a) According to the provisions in Section 7 (1) of the Public Service Provident Fund Ordinance, a sum equivalent to 1.5 times of the Compulsory Contribution should be credited to the Fund by the Government as the Government Bonus. Even though the sum of Rs. 17,571,473,225 equivalent to the 1.5 times of the compulsory contribution balance amounting to Rs. 11,714,315,483 as at 31st December, 2011 should be available with Fund as the Government bonus that balance amounted to Rs. 17,888,009,781. As such the Government Bonus Account had been overstated by a sum of Rs. 316,536,556.
- (b) The sum of Rs. 39,780,214 shown in the books of the Fund as at the beginning of the year under review as prepayments to the Consolidated Fund, had been shown in the balance sheet as current assets without being adjusted to the payments made to the Consolidated Fund in the year under review. As such Government bonus had been understated by that amount while the appropriation of profits to the Government Bonus Account in the year under review had been understated by a sum of Rs. 303,324

2:2:2 Suspense Accounts

The balance of the Suspense Account shown as the Adjustment Account in the balance sheet as at the end of the year under review amounted to Rs. 18,326,537. This balance brought forward over a long period had not been settled even by 30th April, 2012.

2:2:3 Non-compliance with Laws, Rules and Regulations

The Following non-compliances were observed.

References to Laws, Rules and Regulations

Non-compliances

(a) Public Service Provident Fund Ordinance (Cap 621)

(i) Section 2 (2)

Individual accounts in respect of each contributor had not been maintained

(ii) Section 25

Even though the Director General of Pensions should at the end of each financial year, inform the balances of members' accounts as at 31st December, it had not been so done.

Reference to Laws, Rules and Regulations

Non-compliance

(b) Paragraph 04.3(f) of the Public Finance Circular No. PF/423 of 22nd December, 2006 A certificate that the balance lying to the credit of the Fund as at the end of the year under review had been reconciled with the Treasury Books had not been furnished with the Financial Statements.

3. Financial Review:

3.1 Financial Results

According to the Financial Statements presented, the financial results for the year under review before appropriation to the contributors amounted to a surplus of Rs. 2,426,308,059 as compared with the corresponding surplus of Rs. 2,593,589,969 for the preceding year and a deterioration of a Rs. 167,281,910 was indicated. The decrease of the interest income by a sum of Rs. 165,647,939 or 6.4 per cent due to the decrease of the rate of interest in the year under review as compared with preceding year had been the main reason for the decrease is the surplus.

4. Operating Review:

4.1 Performance

The following observations are made:-

(a) The expected targets of the activities of the Fund according to the Action Plan for the year 2011 and the actual achievements are given below.

According to the above data, the expected targets had not been achieved in 02 instances and the expected targets had been exceeded in 02 instances. It was observed that the target for the payment of benefits to the contribution had been set unrealisticality.

(b) According to the Management Analysis of the Fund appearing in the financial statements furnished to audit for the year under review the maintenance of the accounts in a manner to enable the balances as at the end of the year to be furnished to the contributors had been shown as one of the 04 main activities directed towards the objectives of the Fund. Nevertheless, the individual Accounts had not been maintained in the updated manner to enable the individual account balances as at end of the year to be informed to the contributors.

4:2 Interest Percentage Entitlement to Members

The interest percentage given to the contributions during the year under review and preceding 10 years had fluctuated between 11.85 percent and 7.1 percent. The interest percentage paid to the contributors in the year under review as compared was the preceding year had decreased by 1.81 percent.

4:3 Interest Income Lost by the Fund

As the Government bonus receivables from the Secretary to the Treasury had not been received by the Fund, the interest that could have been earned by investing that money had been deprived to the Fund. The interest so deprived to the Fund in the year under review and the preceding the 05 years is as follows.

According to the above observation, the investments interest income deprived to the Fund during the immediate past 06 years amounted to Rs. 1,298 million approximately.

4:4 Utilization of Cadre

The number of members of the Fund by the year under review as compared with the year 2003 had improved by 37.73 percent. Nevertheless there was not appreciable change in the cadre available for carrying out the functions of the Fund and as such the number of members attended to by each officer had increased. The position relating to the year under review and preceding 08 years is given below.

The increase of the ratio of Members to staff had been the reason for the regular delay in carrying out the functions of the Fund.

4:5 Payment of Benefits to Members

Out of the applications, made by the members of the Fund for the benefits in the year under review, payments on 1,772 applications had not been made by 31st December, 2011 and that represented 15.3 percent of the total number. The position of the year under review and 05 preceding years is given below.

4:6 Management Inefficiencies

According to Circular No. 1/97/of 31st July, 1997 and No. 14/2006 of 30th October, 2006 of the Director General of Pensions, an advice on the money credited to the Fund in each month, should be furnished to the Secretary of the Fund by the institutions concerned before 15th day of the month following. Nevertheless, a few institutions only had furnished the advices. The progress of the procedure of the Fund to get down the advices had not reached the expected level.

5. Systems and Controls

Deficiencies in system and controls observed during course of audit were brought to the notice of the Director General of Pensions from time to time. Special attention is needed in respect of the following arrears of control:-

- (a) Accounting;
- (b) Member's Contributions;
- (c) Follow up action on Audit Observations.

Observations of the Management Board of Public Service Provident Fund regarding the report of the Auditor General concerning the accounts of Public Service Provident Fund for the year ending 31.12.2011.

2.2 Comments on Financial Statements

2:2:1 Accounting Deficiencies

- (a) This surplus remained for a long period and generally an amount equal to 15 times of the compulsory contribution should be credited to the government bonus money. Reason for this surplus had been the delay of applying for the awards by members after the termination of membership. However, since these awards are made only to the date on which the membership terminated, the balance money usually remained in the account. Since the interests received by re-investing these money is also credited to the government bonus caused to the increase of this surplus. Further the money remained in the account of membership terminated persons is also invested until they receive the awards. The interest received by these investments is also credited to the member's accounts which caused to the surplus.
- (b) The difference can be corrected by adjusting with the Treasury books and these adjustments have been done by the monthly account summary of month of February, 2012. The transfer sheets are forwarded herewith.

2:2:2 Receivable and payable accounts

(a) Even though the Departments and Ministries that maintained erroneous debits for over 5 years are regularly notified in written and by telephone to settle the balance, those institutions have not taken any positive action to settle the same. Therefore it has been difficult to settle these balances. However the action has been taken to correct most erroneous debits of year 2010 and 2011 within the year concerned.

No unsettled erroneous debits for year 2008, 2009, 2010 are available and it was already informed the authorities by letters and telephone to settle the erroneous debits remained for over 4 years. It is regret to inform that these institutions have been abstained from providing past information.

2:2:3 Non-compliance with Laws, Rules and Regulations

(A) Public Service Provident Fund Ordinance (Ordinance 621)

(i) (2) Section (2) 2

It has been difficult to make immediate corrections to these errors due to unavailability of proper maintenance of single accounts from the beginning of the fund. However the steps have been taken to maintain single accounts under the e-pensions project. Therefore it is believed that these matters would be settled under the e-pensions project since the financial provisions have not allocated to any other programme.

(ii) Section 25

We are hopeful that this issue will be solved as the facility to inform balances to the members is available under the e-pension project which already completed the pilot program.

3. II (3) (b)

Agree. Noted to follow this during the forthcoming financial year.

(B) Para. 04.03 (e) of Public Finance Circular PF/423 dated 22nd December, 2006 relevant letter is attached herewith.

The Treasury has not issued a separated letter noticing to inform the balances but when inquired the Treasury we have not received any reply in that regard. The quarterly submitted reconciliation report has been submitted on 05.04.2012 and it is forwarded herewith since it contained with the details of last balance.

4. Operational review

4.1 Interest percentage of the members

As a result of decline of interest rates (Year 2011), the appropriated interest percentage also have been dropped-down.

4.2 The lost interest revenue of the Fund

Letters have been sent to the Secretary to the Treasury informing the decrease in appropriated interest percentage due to irregularity of receiving imprest for Government bonus and to settle the account balance of the Deputy Secretary to the Treasury and a discussion in this regard also have been held with the patronage of Director General of Treasury Operations. This was informed also to the Secretary to the Finance Ministry by letter dated 16.03.2009 but the money not received yet. However this situation can still prevailed due to not receipt of money to settle the account balance of Deputy Secretary to the Treasury.

4.3 Staff resource

Comparing to previous years we were able to reduce the delays by 62% as a result of recruitment of additional 08 officers and utility of existing resources with maximum efficiency.

4.4 Benefit payments for members

A considerable number of increases in the applications to draw benefits could observe during Year 2008, 2009, 2010, 2011 though there was no increase in the number of staff comparing the workload ultimately caused to delay in the process. To overcome this

difficulty and expedite the payments, we introduced a special project by attaching 8 officers temporarily. Accordingly we were able to reduce the 39.9% unpaid applications of year 2009 up to 15.3%.

4.5 Performance

(a) Though we expected 8000 registrations in the fund, the membership enrolment could be done on the basis of receipt of applications only. Therefore it is difficult to achieve the expected targets as the membership registrations done on the basis of applications received.

The success of collecting contributions has been 74% only and the irregularity of receiving government bonus has been caused to this. The additional fund investment has been 101.4% and it is a reach to the expected targets. The benefit payments to the contributors have been dramatically increased as 262.8% due to payment of benefits to the reserve police officers and other P. S. P. F. benefitted officers since they were received permanent posts on government policy decisions. The expected target of issuing awards has been increased as a result of the method used to expedite the award payments.

(b) We believe that the already initiated e-pension project would make solutions for these issues.

4.6 Management weaknesses

Even though the all departments and ministries were educated to submit credit notices by the circular 14/2006 dated 30.10.2006 in addition to the circular 1/97, the institutions concerned have maintained a procedure of sending a list with cheques or different manner without sending credit notices. As a result of these irresponsive conducts of the institutions, the fund could not meet with the expected targets of its productive implements. Having identified these issues the Public Service Provident Fund has introduced an instruction manual along with Circular 04/2010 dated 25.05.2010 and it is expected the fund would be achieved the progress predicted. As the success of all these actions depends on the reactions of other instituions it has been difficult to achieve the expected goals at some times.

5. Systems and Control Recorded to act accordingly.
