All Government Departments, Corporations, Boards, etc. are hereby advised that Notifications fixing closing dates and times of applications in respect of Post-Vacancies, Examinations, Tender Notices and dates and times of Auction Sales, etc. should be prepared by giving adequate time both from the date of despatch of notices to Govt. Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after three months from the date of publication.

All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication i.e. notices for publication in the weekly *Gazette* of 03rd January, 2014 should reach Government Press on or before 12.00 noon on 20th December, 2013.

IT is hereby notified that by virtue of powers vested in me by Sub Section (2) of Section 2 of Entertainment Ordinance (Chapter 267) which should be read with Para (a) of Sub-section (1) of Section (2) of Provincial Council Act (Supplementary Provisions) No. 12 of 1989, I, Gustingna Wadu Shan Wijayalal De Silva, Minister of Local Government of Southern Provincial Council hereby approve the proposal mentioned in the following schedule and seconded by the Sabha under Sabha decision 7-1 taken at the general meeting held on 06th December, 2012.

PROPOSAL

Every person who carry out following entertainment event which related to the purposes of Entertainment Ordinance (Chapter 267) within the area of Beliatta Pradeshiya Sabha should pay entertainment tax as described below:-

- (a) In a cinema show an amount similar to Seven percent (7%) of total amount charged from all entrants for that cinema show.
- (b) In another event of entertainment, an amount similar to Ten percent (10%) of total amount charged from all entrants for that event of entertainment.

By virtue of powers vested in Local Government institutions by Section 2 of the said Entertainment Tax Ordinance, Pradeshiya Sabha of Beliatta Proposes that entertainment tax should be recovered and it should be paid on the day prior to the day of such purpose of entertainment.

IT is hereby notified that the Southern Province Provincial Council has at its meeting held on 23.07.2013, unanimously approved the draft by-laws made by the Minister-in-charge of the subject of Local Government of the Southern Province Provincial Council, under the powers vested in him in terms of Section 2, Sub-section (I) of the Local Goverment Authorities (Standard By-laws) Act No. 06 of 1952 (Chapter 261) read with Section 2, Sub-section (I) (a) of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989 and notified in Part IV(b) of Gazette No. 1811 dated 17.05.2013 of the Democratic Socialist Republic of Sri Lanka, to wit-

By-laws relating to the interpretation of all standard by-laws of Urban Councils within the Southern Province; by-laws on general provisions applicable to all standard by-laws; by-laws on penalties regarding any violation of any provision or directive contained in any standard by-law; by-laws relating to the procedure of the council meetings; by-laws on the sale of fish; by-laws on the sale of meat; by-laws relating to factories making soft drinks; by-laws relating to hair dressing saloons, barbers' saloons and beauty parlours; by-laws on bakeries; by-laws on dairy farms; by-laws

on swimming pools, by-laws on factories making ice; by-laws on eateries, reataurants and tea or coffee shops; by-laws on hotels; by-laws on lodging houses; by-laws on laundries; by-laws on factories; by-laws relating to funeral undertakers' services; by-laws relating to the sale of food items by itinerant traders; by-laws relating to pedestrian crossings; by-laws on regulation, supervision and control of industrial premises associated with building materials or premises used for their stock keeping; by-laws on parking of motor vehicles and traffic control; by-laws on prevention of damages to roads or obstruction of road usage; by-laws on the regulation, control and levying of fees for crematoriums; by-laws on the maintenance of public fairs; by-laws relating to play grounds; by-laws relating to community centres; by-laws on advertising posters; by-laws on the registration of pawnbrokers and pawn brokers and by-laws relating to the submission of periodic returns and other reports.
