By-Laws

WELIGEPOLA PRADESHIYA SABHA BY - LAWS

IT is here by notified that by viture of power vested in terms of sub section 1 of section 2 of the Provincil Councial (concequntial provisions) Act, No.12 of 1989, I Maheepala Herath ,Ministry of Locial Government ,approve the by law on Limitation of weight and running speed of vehicle and formalization of running vehicles within the jurisdiction of the Weligepola Pradeshiya Sabha adopted by the Weligepola Pradeshiya Sabha on 31.10.2012 in terms of sub section 126 which should be read along with sub section 01 and section 122 of Pradesiya Sabha Act No.15 of 1987 and that this by law will be enforced since the date of its publication of this notice in the *Gazette*.

At the Chief Minister's Office, Sabaragamuwa Provincial Council.

By - Law of Limitation of Weight and Speed of vehicles

- 01. This By Law is named as the law of limitation of weight and speed of vehicles.
- 02. The objective of this by law is to formalize transportation of heavy vehicles and making limitations of driving speed and imposing limitations of weight minimizing the damage to the roads in the Weligepola Pradesiya Sabha and not belonging to any other authorities and located within the jurisdiction of the Pradesiya Sabha
- 03. This by law is in operation since the date of its publication in the *Gazette*.
 - 04. (a) Here in after running a tipper a lorry a tractor or a road constructing machine with a weight exceeding 2 tons should not be done on the roads meant in the secound by law without bearing a licence obtained after paying charges mentioned in the first schedule issued by the chairman of the pradesiya sabha and pulling or towing logs and other material on such a road should not be done by means of animals or tractor.
 - (b) The power of amending the charges mentioned in the first schedule of this by law if necessary or from time to time, lies in the Weligepola Pradesiya Sabha.
 - (c) Running of any vehicle without air fressyre tyres should not be done unless loaded in another vehicle on any road belonging to the Pradeshiya Sabha should not the done.
- 05. The maximum running speed of a vehicle on a road belonging to Pradesiya Sabha should not exeed 25 kilo meters per hour.

- 06. In an instance where no provisions have been made by any sub law by the Pradeshiya Sabha the vehicles should not be the stationed in the places mentioned in the 2nd schedule of this on the days and times also mentioned in the same schedule.
- 07. (a) If any individual transports any building material, agricultural product timber or machinery equipment through a road which depicts from the second by law of this by law a written request should be forwarded to the chairman of the sabha at least prior to three days.
 - (b) On receipt of such a request according to by law under 7.1 a report should be called by the chairman through a technical officer or any other officer authorized by the chairman and a deposit of money as a security should be obtained sufficient for the amount of damage to be made.
 - (c) After levying charges for a deposit of security and due charges the permission should not be granted without coming at an agreement.
 - (d) In case of a request made to release the security at least 10% of the department fees and subsequently its loss in case of any damage should be levied after assessment.
 - (e) If the damage exceeds the deposit of security it is lawful to order the relavant individual to pay that extra money too.And on an occasion where such payment is evaded when it is orderd to pay the Pradesiya Sabha has the authority to levy such charges by suing at a court of judicial power.
 - (f) In an instance where it is decided by the chairman that following procedures of by law of 7.5 above are unjustifiable the chairman is empowered to donate some relief, subject to approval of the general meeting.
- 8. The contractors who have come to agreemant with the Pradesiya Sabha relavant to developmentstasks can get exempted from the charges mentioned in the first schedule here by making written request forwarded to the chairman.
- 09. It is lawful for the chairman of secretary or any other person authorized by the chairman of the Pradesiya Sabha to examine all permits issued under this by law.
- 10. Every contravention of by law is an offence and when any individual is found guilty for an offence at a court of judicial power he/she is liable for a fine orderd under section 122(2) of the Pradeshiya Sabha Act, No. 15 of 1987 and if he/she continued to do that contravention even after handing him/her over a written notice by the chairman or secretary or any other officer outhorized by the chairman paying attention to it he/she in liable for a fine for days the crime has been committed as indicated in section 122(2) of the Pradeshia Sabha Act, No 15 of 1987.

- 11. In case of any complexity of a definition of any law of this by law the sinhala copy of this should alwas the empowered.
- 12. For the purpose of this by law Weligepola Pradesiya Sabha is meant by Pradeshiya Sabha Chairman of the Weligepola Pradeshiya Saba is meant by the Chairman, Secretary, of the Weligepola Pradeshiya Sabha is meant by the secretary ,any other officer of the Sabha a Gramaniladhari,or and a police officer is meant any other officer.

SCHEDULE 01

01. Transportation of sand soil or other minerals

- (a) The non refundable deposit of money is Rs.1,000 for transportation by heavy vehicle of the weight of 1 cubes to two cubs per one turn. Permit charge for one turn is Rs.1 00.
- (b) Non refundable deposit of money for transportation by heavy vehicle weighing 2 cubs to 4 cubes for one turn is Rs.1,000 Permit charge for one turn in Rs. 200.
- (c) Non refundable deposit of money for transportation by heavy vehicle more than 4 cubes is Rs. 1,000/, Permit charge for every exeeding cube in Rs. 10
- 02. Transportation of firewood, bamboos, and timber logs.
 - (a) Non refundable deposit of money for attractor for one turn is Rs. 1000 Permit charge for one turn is Rs. 200
 - (b) Non refundable deposit of money to a lorry, tiper or truck is Rs. 1,000 per one turn. Permit charge is Rs. 300.
 - (c) Non refundable deposit of money for construting or any other vehicle (Non chain loader) is Rs. 1,000 Permit charge for a day is Rs. 1,000.

03. Transportation of Agricultral Material

- (a) Non refundable deposit of money for daily transpotation by lorry/tipper or truck of one ton or a portion of it per one turn or transportation of over 05 days a month is Rs. 1,000 Permit charge per one turn is Rs. 50 or if it exeeds 10 days a month Rs. 500
- (b) Non refundable deposit of money for daily transportation by lorry ,tipper with the weight of 02 tons or transportation of over 05 days a month is Rs. 1,000 permit charge is Rs. 75 or far a tansportation of over 10 days a month is Rs. 750

WELIGEPOLA PRADESHIYA SABHA

By - laws

IN terms of the powers vested by me under secton 123 of Pradeshiya Sabha Act, as the Minister in charge of the subject of Local Government, I hereby declare that I have approved the following by-law imposed by the Weligepola Pradeshiya Sabha of the administrative Jurisdiction of Sabaragamuwa Provincial Council by virtue of the powers vested in it under Section 122 and 126 of Pradeshiya Sabha Act No. 15 of 1987.

Maheepala Herath, Minister in charge of the subject of Local Government, Sabaragamuwa Province.

By-Laws on Regulation of Establishing Places to Park Vehicles within the limits of Weligepola Pradeshiya Sabha and Charging Fees from Vehicles

- 1. These By-laws shall be known as the By-laws on regulation of establishing places to park vehicles within the limits of Weligepola Pradeshiya Sabha, charging fees for parking and controlling of vehicle parking.
- 2. A notice should be exhibited in a public place by the Chairman of the Weligepola Pradeshiya Sabha hereinafter referred to as the Chairman, regarding the place of parking, prohibited or limited parking or places reserved for parking in a street or part of a street. Parking should not be done other than a place allowed by the council.
- 3. No person shall park a motor car, motor lorry, Bus, Motor Cycle, Three-wheeler or any other vehicle other than in a general park.

- 4. No person shall park a Motor car, Motor lorry, Bus, Motor Cycle, Three-wheeler or any other vehicle in a general park unless the owner or driver of the vehicle possess a valid pass issued by the Sabha .
- 5. Every pass is issued daily on hourly basis or monthly basis on request to the Weligepola Pradesiya Sabha. Every such pass should be taken by paying the daily or monthly fee mentioned in the schedule 2 and 3 according to the necessity.
- 6. One very pass issued under by law No. 04 regarding a motor car, a lorry, a bus, a motor bike, a three wheeler, or any other motor vehicle, the recognition number of motor vehicle should be clearly mentioned and valid only for the period mentioned on the pass.
- 7. According to the by law No. 04, at any time and any occasion when the driver or vehicle owner is asked to produce the pass by a police man, vehicle controller, or a person who has been authorized and appointed by the sabha for that purpose, should produce the relevant pass for the inspection which has been issued for a car, a lorry, a bus, a motor bike, a three wheeler, or any other motor vehicle that has been parked within a public parking place.
- 8. In a situation ,when a public vehicle park has limited to a particular type of class of vehicles the other type of vehicles which are not in the above mentioned vehicle class are not allowed to be parked at that public parking place.
- 9. It is prohibited parking a car, a lorry, a bus, a motor bike, a three wheeler, or any other motor vehicle in a public parking place making troubles to other vehicles which enter to and exit from the park.
- 10. It is prohibited washing a car, a lorry, a bus, a motor bike, a three wheeler, or any other motor vehicle while they are parked in a public parking place.
 - 11. No one is allowed to:
 - (a) Repair a car, a lorry, a bus, a motor bike, a three wheeler, or any other motor vehicle which is in a public parking place if it is not a compulsory for the purpose of taking out from the park.
 - (b) According to the given permission in the chapter 10(a), it is advised that not to make any unreasonable harmful noises when doing that type to repair.
- 12. Improper behaviors and doing harmful things within the public parking place are strictly prohibited for any person.
- 13. Incorporated or unincorporated bodies are allowed to obtain monthly pass from the sabha for their cars, lorries, buses, motor bikes, three wheelers, or any other motor vehicles by paying relevant charges for the sabha office. (Vehicles of Government Ministries and Departments are exempted from these particulars).
- 14. The due charges should be paid to the sabha by and incorporated or non incorporated board of persons for their motor cars, motor vehicle, boxes lorries, buses, motor bikes, three wheelers

- or any other motor vehicles belonging to those incorporated or non incorporated board of persons. (vehicles of Government, Ministries, and Departments are exempted from these regulations)
 - 15. (a) This by law should be effective from the date on which it is published the *Gazette*.
 - (b) This by laws will be operative and effective from 6.00 am to 6.00 pm on each day.
- 16. If any specific persons or specific class or peoples have been given a specific order or written order by the sabha, they will be exempted from parking charges for their motor cars, motor vehicle, boxes lorries, buses, motor bikes, three wheelers or any other motor vehicles.
- 17. Breaking all or any term of this by law will be an offence and has to pay a fine not more than Rs.750 to the court and if the same person continuous the same guilt/fault should have to pay an extra fine not more than Rs.250 daily on which the fault is done, after a written notice which is with the chairman's reference.
- 18. In this by laws, Weligepola Pradeshiya Sabha refers as "sabha", and chairman of Weligepola Pradeshiya Sabha / special commissioner/authorized officer refers as "Chairman"

"Lorry" implies a motor vehicle or a vehicle which has been built with a special purpose of delivering goods, but vehicles which are used within a farm do not fall in to this category.

"Motor car" implies a motor vehicle, but not a motor bike, ambulance, hearse, or a vehicle with a separate trailer which carries chinless/week persons with their luggage including not more than 8 persons with driver.

"Motor vehicle box" means a vehicle. It is neither a ambulance nor hearse. This has been manufactured with a separate trailer for the purpose of transport not less than 8 passengers including driver and their luggage.

"Bike" is a motor vehicle which has been produce with more than three wheels. Bike's weight and the weight and the weight of the car which has been attached by the side weight altogether not more than 5 motor's weight.

Motor Vehicle means:

(a) Any vehicle mechanically forward and backward operated, tractor with a trailer or vehicles that are used for road development activities and approved/permitted by the registrar motor vehicle plantation roller machines are not included in this category.

or

(b) Any vehicle mechanically forward and backward operated and approved / permitted by the registrar motor vehicle using in the agriculture sector for farm uses or leveling the ground for building constructions, removing mud & sand in the depth of rivers and canals, pulling and loading soil or using similar activities as above. Plantation roller machines that are used on the roads are not included in this category.

- "Bus" is a motor vehicle box. This has been registered as a Bus and used for transporting passengers.
- "Stopping" means holding or discontinuing a motor vehicle in a particular place for a particular reason / matter, but not for the purpose of loading passengers or luggage.
- "Police officer" means a person who is engaging the police service and wearing a Police Uniform.

and

- "Vehicle Controller" means a man or woman has been appointed and authorized by the Chairman of the sabha in order to control the vehicles which are parked in the public parking places designed by Pradeshiya Sabha.
- 19. In this by law, it is notified that at any circumstances where there is miss matching / asymmetries in the English or Tamil transcripts, the Sinhala transcript will be immediately applicable and concerned.
- 20. A committee can be appointed by the pradeshiya sahbha in order to control three where societies.

Officially the Chairman and the Secretary of this society will be the chairman and the secretary of the sabha respectively. The other officials and members of this society comprise of 3 members of the sabha, officer in charge police in the area of authority or his representative an officer in charge of vehicles, and the officer of the sabha who is responsible for this subject.
