Report of the Auditor General on the Financial Statements of the University of Colombo School of Computing for the year ended 31st December, 2010 in terms of Section 108 (2) of the Universities Act, No. 16 of 1978 and Section 13 (7) (a) of the Finance Act, No. 38 of 1971

The audit of financial statements of the University of Colombo School of Computing for the Year ended 31st December, 2010 was carried out under my direction in pursuance of provisions in Article 154 (1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 23 of the University of Colombo School of Computing Ordinance, No. 1 of 2002 enacted in terms of Section

18 of the Universities Act, No. 16 of 1978, Sections 108 (1) and 111 of the Universities Act and Sub-sections (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971. This report is issued in terms of Section 108 (2) of the Universities Act and Section 13 (7) (a) of the Finance Act, No. 38 of 1971. My comments and observations appear in this report.

1.2 *Responsibility of the Management for the Financial Statements :*

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Accounting Standards. This responsibility includes: designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

1.3 *Scope of Audit and Basis of Opinion :*

My responsibility is to express an opinion on these financial statements based on my audit. Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff, other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards to obtain reasonable assurance as to whether the financial statements are free from material misstatements. The audit includes the examination on a test basis of evidence supporting the amounts and disclosures in financial statements and assessments of accounting Policies used and significant estimates made by the management in the preparation of financial statements as well as evaluating their overall presentation. I have obtained sufficient information and explanations which to the best of my knowledge and belief were necessary for the purpose of my audit. I therefore believe that my audit provides a reasonable basis for my opinion. Sub-sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

2. Financial Statements

2.1 *Opinion*

So far as appears from my examination and to the best of information and according to the explanations given to me, I am of opinion that the University of Colombo School of Computing had maintained proper accounting records for the year ended 31st December, 2010 and except for the effects on the financial statements of matters referred to in paragraph 2:2 of this report, the financial statements have been prepared in accordance with Sri Lanka Accounting standards and give a true and fair view of the state of affairs of the University of Colombo School of Computing as at 31st December, 2010 and the financial results of its operation and cash flows for the year then ended.

2.2 *Comments on Financial Statements :*

2.2.1 *Presentation of Financial Statements :*

An observation report including the matters revealed at the audit test check carried out on the financial statements presented was forwarded to the Director of the Institution. The relevant corrections and explanations had been submitted to audit.

2.2.2 *Overstatement in the Accounts :*

Although educational allowances should not be taken into consideration in the computation of gratuity to the educational staff recruited to the service after 01st April, 2005 in accordance with the University Grants Commission Circular No. UGC/HR/3/9/8 dated 21st April, 2005, a sum of Rs. 25,729 had been excessively allocated due to the educational allowances paid to seven members of the staff during the year under review had been taken into consideration in the computation of gratuity.

2.2.3 *Accounts Receivable and Payable :*

The following observations are made.

- (a) Loans amounting to Rs. 270,586 remaining recoverable for more than five years from the persons not in the service at present due to various reasons, could not be recovered up to date.

- (b) The value of receivables by the Institution from 07 academic and non academic staff who had breached the agreements for not reporting to the service on the basis of proceeding abroad or other reasons in terms of Section 33 of Chapter 10 of the Establishments Code for University Grants Commission and other Higher Educational Institutions, amounted to Rs. 15,909,040.

2.2.4 Lack of Evidence for Audit

- (a) Boards of Survey in respect of fixed assets at the cost of Rs. 451,108,034 and fixed assets at the written down value of Rs. 106,018,108 had not been carried out during the year under review and report not presented. As a result, those assets could not be satisfactorily verified in audit.
- (b) A sum of Rs. 527,845 had been transferred to the PAN Localization Project from the funds of the Learning Technology Research Lab (LTRL) Project. The approval thereon obtained from the Funding Agency had not been submitted for audit.

2.2.5 Non-compliance with Laws, Rules, Regulations and Management Decisions

The following instances of non-compliances were observed.

(a) Financial Regulations 835 (2) (e)	Although the period of the rental agreements for buildings obtained on rent should not exceed three years, two buildings had been obtained on rent by the Institution for a period of Five years and the value of the relevant rental agreements amounted to Rs. 9,300,000.
(b) Paragraph 27.3 of the Establishments Code of the Universities	Study leave had been granted to two lecturers who had not completed the minimum probation period of one year to proceed abroad for post graduate studies from the year 2004 to the year under review and a sum of Rs. 6,626,294 had been spent for the above educational activities.
(c) Finance and Planning Circular No. 431 dated 24th April, 2008	Although it was reported that all the officers proceeding abroad on official travel at the expense of any Funds should purchase their air tickets from the Sri Lankan Air Lines Company or Mihin Lanka (Private) Company, the Institution had paid a sum of Rs. 93,000 to purchase air tickets from a private institution.
(d) Public Enterprises Circular No. PED 25th dated 29th July, 2004	Although prior approval of the Ministry of Finance should be obtained for investment of surplus funds, a sum of Rs. 207,782,066 had been invested on fixed deposits in several state banks up to 30th June, 2010 without such approval.
(e) Letter No. UGC/TUA/2/PGS dated 08th June, 2009 of the University Grants Commission	Although according to the order made by the University Grants Commission in terms of instruction of Section 15 (ii) of Part II of the Universities Act, fees for visiting lecturers who are delivering lectures for post graduate courses should be limited to maximum of Rs. 2,500 per hour of lecture, a sum of Rs. 324,875 had been overpaid thereon during the year under review due to the payment made at the rate of Rs. 3,000 per hour based on the approval of the Board of Management.
(f) Paragraph 7.4.1 of the Circular No. PED 12 dated 02nd June, 2003	Although a representative of the Treasury should participate at the meeting of the Audit and Management Committee, a representative of the Treasury had not been participated for the meeting of the Audit and Management Committee.

2.2.6 *Transactions of Contentious Nature*

A sum of Rs. 82,171 had been paid during the year, 2010 as salaries and incentive allowances for proficiency in second and third languages in accordance with Circular issued by the Universities Grants Commission contrary to the Public Enterprises Circular No. 95 of 14th June, 1994. Although the Director General of Public Enterprises and the Director General of Budget had informed to the University Grants Commission that the payment of these allowances are contrary to the Government rules and regulations, such payments are being made continuously.

3. Financial and Operating Review

3.1 Financial Review

3.1.1 *Financial Results :*

According to the Financial Statements presented, the working of the Institution for the year ended 31st December, 2010 had resulted in a deficit of Rs. 76,739,145 before taking into account the Government Grant as compared with the corresponding deficit of Rs. 82,084,310 for the preceding year. The deficit for the year under review had reduced to Rs. 11,357,570 due to the Government Grant of Rs. 65,381,575 received for recurrent expenditure. The deficit for the preceding year had reduced to a sum of Rs. 13,474,310 due to the Government Grant of Rs. 68,610,000 received for recurrent expenditure of that year.

3.2 *Operating Review :*

3.2.1 *Performance :*

- (a) Two hundred and thirty new students had been recruited for 04 internal courses belong to 02 main fields conducted by the Institution during the year under review whereas degrees had been awarded for 229 students.
- (b) External courses on Communication Technology had been conducted by the Institution in three main stages such as Diploma, Higher Diploma and Degree. 6,366 students had registered for three academic years and 361 Diplomas, 199 Higher National Diplomas and 140 Degrees had been awarded during the year under review.
- (c) Three Postgraduate Diploma Courses had been conducted by the Institution and the educational facilities for 443 students had been provided under these courses.
- (d) Seventeen lecturers of the permanent staff of the Institution had delivered 3,660 hours and 4,015 hours of lectures during the year under review in respect of academic years 2009/2010 and 2010/2011 respectively. Number of lecture hours delivered by 17 visiting lecturers was 360.

3.2.2 *Budgetary Control :*

Significant variances were observed between the budgeted value and the actual expenditure in respect of capital expenditure thus, the budget had not been made use of as an effective instrument of management control.

3.2.3 *Management Inefficiencies :*

Although according to Paragraph 5.4.1 (b) (iv) of the Procurement Guidelines, authorities and duties of the Engineer or the Consultant should be clearly mentioned in the contract agreement if the services of an Engineer or a Consultant for supervision and administration activities of the contract were expected, contrary to the above instruction a sum of Rs. 893,030 had been paid as consultancy fees by the Institution for obtaining consultancy services from a private institution in respect of supervision and administration activities of a contract for renovation of a building at a cost of Rs. 14,462,016.

3.2.4 *Uneconomic Transactions :*

Even though it was able to carry out the activities of internal audit by the Internal Audit Unit of the University of Colombo without incurring additional expenditure, the internal audit activities had been assigned to a private audit institution violating the Finance Act, Establishment Codes of the Universities and the Financial Regulations. Amount paid thereon during the year under review was Rs. 248,623.

4. Systems and Controls

Deficiencies in systems and controls observed during the course of audit were informed to the Director of the Institution from time to time. Special attention is needed in respect of Management of assets.

Interest income of Rs. 106.85m earned from the year 2004 had been included in the said investment.

- (e) The same MSc degree in Computer Science is being conducted by other universities and private institutions in the country. Demand for the degree is always depends on the quality of the course work and the lecturers. The lecturers for the programme is recruited internally as well as externally.

Accepting of appointments by the lecturers depends on the rate offered for an hour. Since the degree programme is being conducted at the weekends by the all places lecturers are preferred to joined the places where they are offered a higher rates.

In deciding per hour rate all the activities such as preparation of notes, Printing of notes, and all other Primary activities have been considered and included. But all other places are paying separately for various other activities.

In addition to that, out of total income earned in this programme, 60% is being used for conducting the degree programme and the balance 40% is being used for the benefit of undergraduate education, development activities of the institution, and research activities of the senior academic staff. Also its worthwhile to mention that this is a grate chance for the Govt. to minimize the cost of undergraduate education.

If it is necessary to comply with the circular instructions it would cause to drop the demand for the degree leading to conduct it successfully and could be a lost for the institution as well as the Govt.

- (f) Presently Treasury Representative is being participated to the Audit Committee meetings regularly.

As per the circular instructions given by the University Grant Commission allowance for the proficiency in Second and Third Language has been paid.

3. Financial and Operating Review

3.1 Financial Review

3.1.1 Financial Result

Financial result mentioned in the report is correct as per our Financial Reports.

3.2 Operating Review

3.2.1 Performance

- (a) Recruitment of 230 students to the Undergraduate programme and offering of degrees to 229 students is correct.
- (b) Registration of 6,366 students to the External Degree programme and offering 361,199 and 140 of Diploma, Higher Diploma and Degrees respectively is correct.
- (c) Providing of educational facilities for 443 students for 3 Postgraduate courses is correct.
- (d) Delivering of lectures by 17 permanent staff and Visiting lecturers is correct.

3.2.2 Budgetary Control

Capital Expenditure during the year was higher than the budgeted since the UCSC carried out substantial renovation programme to all of UCSC building to commemorate the 25th Anniversary. However capital expenditure during the year has been managed well.

3.2.3 Management Inefficiencies

In order to carry out renovation programme to commemorate the 25th Anniversary the UCSC buildings renovation programme were carried out with the approval of the Board of Management of UCSC to be spent from generated funds.

A consultancy service was obtained with the approval of Board of Management on very feverable terms.

Since the consultant had been providing services to the institution from years ago, the knowledge of the consultant on structure of the buildings was very useful for this renovation.

It is worthy to mentioned that the said renovation job had been completed successfully even less than the estimated cost.

3.2.3 Uneconomic Transactions

Since resources available to the Internal Audit branch of University of Colombo they say that it is impossible for them to provide internal audit services to the UCSC. When we explore the actual situation we got to know that they did not cover entire activities of the institutions attach to the University of Colombo in their internal audit plan.

Having deeply considered the above fact we decided to employ a professional audit firm in order to carry out UCSC internal audit activities with the approval of Board of Management to be paid them from our generated funds.

An internal audit plan has been developed by the internal auditors for the UCSC having taken into consideration of University of Colombo internal audit plan and Audit committee chaired by a chartered Accountant (Board Member) reviewed the plan and recommended it for the Board of Management for approval.

Since the internal audit is being carried out on a quarterly basis and UCSC audit committee reviews the internal audit report on a quarterly basis, our finance, administration and other sections are being run smoothly and with high internal control systems.

We have once again invited the internal audit to provide the service and they have accepted to cover only a minor part of the UCSC requirement.

Hence I wish to mention that this is not an uneconomic transaction.

4. Systems and Controls

Special attention will be drawn to safe guard assets of the institution.
