I, Mohan Lal Grero do hereby give notice under Standing Order Number 48(1) of the standing order of the Parliament of the Democratic Socialist Republic of Sri Lanka, that I propose to introduce to Parliament a Bill entitled, "An Act to incorporate the Federation of Information Technology Industry Sri Lanka (FITIS)".
