All communications relating to Trade marks should be addressed to the Registrar of Patents and Trade Marks, Registry of Patents and Trade Marks, 3rd Floor, "Samagam Medura", No. 444, D. R. Wijewardene Mawatha, Colombo 10.

Hours of Inspection

The office shall be open to the public for inspection of the Register on every working day from 9 a. m. to 2.30 p. m. Applications for inspection of the Register will, However be accepted up to 2 p. m. on working days.

Trade Marks Limited to Colours

Where it is stated in the advertisements of an application that the mark upon its registration to be limited to certain colours, are market in the usual heraldic manner.

Association

Where it is stated that an advertised mark is to be associated under section 112 of the Code of intellectual Property Act. No. 52 of 1979 with another mark, it is indicated by its official number.

OPPOSITION

NOTICE is hereby given that any person who has grounds of objection to the registration of the following Trade Service or Collective Marks may, within three months from the date of this Gazette, lodge Notice of Opposition on Form M2 (together with a duplicate copy thereof). The fee for such Notice of opposition is Rs. 750, payable in Cash or by Cheque, Money Order, Postal Order or Bank Draft.
