AN ACT TO INCORPORATE THE SRILANKA LUMBINI DEVELOPMENT TRUST.

I, V. K. Indika, do hereby give notice under the Standing Order No. 48 of the Standing Orders of Parliament of the Democratic Socialist Republic of Sri Lanka, that I propose to introduce in Parliament a Bill entitled an Act to Incorporate the Sri Lanka Lumbini Development Trust".

The aim of the Bill is to incorporate the said Sri Lanka Lumbini Development Trust which has the following General Objects :-

- (a) To establish an institute of Therawada Buddhism, following the tradition of the areas like Kapialwasthu, Devdaha and Ramagram, based on the Sal grove in Lumbini Nepal, the Birth place of Siddartha, to develop the Buddhist culture in Nepal and adjacent countries and to train the Bikkus and to direct them to propagate Buddhism ;

- (b) Creating Therawada Buddhist revival in Nepal by the developing and conserving Sri Lankaramaya established in the city of Lumbini by the Government of Sri Lanka ;
- (c) Maintaining the "Sri Lanka Rest House" built in the City of Lumbini by the Government of Sri Lanka with proper management, generating income through that in order to maintain Theravada Buddhist Religious Centers and develop Theravada monasteries, etc.
