INDEPENDENT AUDITORS' REPORT TO THE MEMBERS OF SRI LANKA INSTITUTE OF TAXATION

**1. Report on the Financial Statements :**

We have audited the accompanying Financial Statements of Sri Lanka Institute of Taxation, which comprise the Statement of financial Position as at 31st March, 2013 the statements of comprehensive Income and Cash Flows for the year then ended, and a summary of Significant Accounting Policies and other explanatory information as set out on pages (01) to (13).

**2. Council's Responsibility for the Financial Statements :**

Council is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Accounting Standards applicable for SME's. This responsibility includes: designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that the free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies and making accounting estimates that are reasonable in the circumstances.

3. In common with many organizations of similar size and organization, the Institute's system of control is dependent upon the close involvement of the Council Members. Therefore, where independent confirmation on the completeness of accounting was not available, we have accepted assurances from the Council Members that all the Institute's transactions have been reflected in the books of accounts.

**4. Scope of Audit and Basis of Opinion :**
