### GAMPAHA MUNICIPAL COUNCIL

#### Recruitment to the Post of Fireman in Western Provincial Public Service – 2013

APPLICATIONS are hereby invited from permanent residents of the Western Province with under mentioned qualifications for the post of fireman to the fire service in Gampaha Municipal Council in the Western Provincial Council.

01. *Salary Scale.* – Rs. 14,280 - 145 x 7 - 180x10 - 240 x 17 - Rs. 21,175 - (Rs.-1-2006A).

02. *Age Limit.* – Applicants should be not less than 19 years and not more than 25 years of age. In first time the age limit of the applicants who have completed fireman course conducted by the National Apprentice Authority is extended up to 35.

03. *Educational and Other Qualification :*

- (a) Applicant should have a minimum of six passes at the G. C. E. (O/L) Examination in not more than two attempts including Sinhala/Tamil, Mathematics and Science subject and among them should have passed in five subjects in one sitting.
- (b) Applicants should have an excellent character with good health, and also :
  - (i) Should be minimum of 5 feet and 4 inches of height,
  - (ii) Should be minimum of 125 Lb (55.5Kg.) of weight,
  - (iii) Applicants should be unmarried,
  - (iv) Should be a permanent resident within the Western Province minimum of 3 years.

04. *Recruitment System.* – A written exam and placement test will be conducted in terms of Public Administration Circular No. 15/90 according to the results of examination those selected will be call for an interview to certify the qualification later they will be absorbed into the service. The recruitment task will be carried out by Gampaha Municipal Commissioner.

*Recruitment Examination :-*

- (a) Applicant should appear for a one hour question paper to examine general knowledge level,
- (b) A qualifying test will be conducted in due course to examine the physical qualifications.

05. *Conditions applicable to the service –*

- (i) This post is permanent and pensionable.
- (ii) Applicants will be treated according to the provisions of the Establishment Code, Financial Regulations of the Western Provincial Council and other condition issued time to time by the Western Provincial Public Service Commission and also the orders of the said Local Authority. The service of this post is limited only to the Western Province.

06. *Service Conditions.* – Selected applicants should follow a one year training course. Appointing authority has the power to exclude the trainees without any compensation who do not satisfactory work condition and behavior or expected professional standard.

Rs. 3,000 will be paid as an allowance during the training period.

Those who complete the training satisfactorily will appointed placing in the salary scale of fireman in Provincial Public Service.

Those completing the training should forward to bond signature values of Rs. 10,000 at the beginning of the training stating that they will serve in the Western Provincial Public Service for period of five years.

All trainees should appear for medical examination before commencing their training.

Those who receiving appointment as fireman it is compulsory to reside within the local authority area.

07. *Efficiency Bar Examination.* – Application having passed in the writing examination conducted by an institution named by the Gampaha Municipal Council Commissioner will be promoted by the appointing authority after the Efficiency Bar Examination.

Fire engineering science - Two hour question paper.
