# Report of the Auditor General on the Financial Statements of the University of Jaffna for the Year ended 31st December, 2011 in terms of Section 108 (2) of the Universities Act, No. 16 of 1978.

The audit of Financial Statements of the University of Jaffna for the year ended 31st December, 2011 comprising the balance sheet as at 31st December 2011 and the income statement, statement of changes in equity and cash flow statement for the year then ended and a summary of significant accounting policies and other eplanatory information, was carried out under my direction in pursuance of provisions in Article 154 (1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Sections 108 (1) and 111 of the Universities Act, No. 16 of 1978 and Sub sections (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971. My comments and observations, which I consider should be published with the annual report of the University of Jaffna in terms of Section 108 (2) of the Universities Act, appear in this report. A detailed report in terms of Section 13 (7) (A) of the Finance Act was issued to the Vice Chancellor of the University on 15th August, 2012.

# 1:2 Management Responsibility for the Financial Statements :

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements, whether due to fraud or error.

# 1:3 Auditor's Responsibility:

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Sri Lanka Auditing Standards. Those Standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatements of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the University's preparaton and fair presentation of the financial statements in order to desing audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the University's internal control. An audit also includes evaluating the appropriateness of accounting policies used and reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements. Sub-sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified audit opinion.

### 1.4 Basis for qualified Opinion

My opinion in qualified based on the matters described in paragraph 2.2 of this report.

### 2. Financial Statements :

2:1 Qualified Opinion :

In my opinion, except for the effects of the matters described in paragraph 2.2 of this report, the financial statements give a true and fair view of the financial position of the University of Jaffna as at 31st December, 2011 and its financial performance and cash flows for the year then ended in accordance with Sri Lanka Accounting Standards.

- 2:2 Comments on Financial Statements :
  - 2:2:1 Sri Lanka Accounting Standards :
    - (i) The book value of the fixed assets, which had become Zero value and continued to be used had not been revalued and shown in the accounts in terms of the Sri Lanka Accounting Standard No. 18.
    - (ii) The Non-current assets schedule furnished along with the financial statements for the year under review had not been contained the following details in terms of SLAS 18.
    - (a) The Gross carrying amount and the accumulated depreciation at the beginning and end of the year.
    - (b) A reconciliation of the carrying amount at the beginning and end of the period showing the Additions, Acquisitions, Disposals, Depreciation and Other movements.
    - (iii) Payment of Gratuity amounting to Rs. 14,105,090 had been made and directly charged to the Income statement instead of debiting it to the provision for Gratuity Account in terms of SLAS 16.
  - 2:2:2 Accounting Deficiencies :

Following accounting deficiencies were observed in audit :

- (a) Value of books and periodicals amounting to Rs. 2,191,072, and 87 items of Journals and periodicals to the value of Rs. 1,359,072 shown in the financial statements had not been received from the suppliers in respect of the years 2005, 2006, 2007, 2008 and 2009. However, the depreciation of those books and periodicals amounting to Rs. 438,214 had been charged against the income.
- (b) Building works for Rs. 1,708,750 had been completed and handed over by the Building Department. However, it had not been capitalized due to the non-submission of work completion certificate by the Department of Buildings.

- (c) Excess of expenditure over income amounting Rs. 1,093,395,992 had been erroneously debited to the General Reserve Account instead of charging to the Accumulated Fund. As a result debit balance had been shown in the General Reserve Account as at 31st December, 2011.
- (d) A three-wheeler purchased from silver jubilee fund for Rs. 243, 100 had not been brought to accounts since 2006.
- (e) Three City Rider Buses donated by the Indian Government to the University during 2010 had not been brought to the accounts even during the year under review.
- (f) Rent income receivable from the University staff relating to the Guest house, Colombo for the years 2008, 2009, 2010 and 2011 amounting to Rs. 6,140, Rs. 2,428, Rs. 35,900 and Rs. 24,700 respectively had not been brought to accounts.
- (g) A sum of Rs. 364,569 had been shown as suspense account balance as at 31st December, 2011 and out of this a sum of Rs. 103,410 had been remained for over five years without being taken action to clear these balances.
- (*h*) Several corrections were made in the stores ledger and import advance account (Maintenance) to the value of Rs. 63,197 without passing Journal entries.
- (*i*) Books and periodicals Advance Control account balance as at 31st December, 2011 aggregating Rs. 24,134,681 and the corresponding balance amounting to Rs. 23,364,882 disclosed in the financial statements had not been reconciled and the reasons for difference of Rs. 769,799 had not been explained to audit.
- 2:2:3 Accounts Receivable and Payable

Following observations are made :

- (*a*) Trade receivables included the outstanding balances amounting to Rs. 504,237 for more than five years and provision for doubtful debt had not been made in the accounts.
- (b) Trade payables included the outstanding balance amounting to Rs. 2,562,402 for more than five years.
- (c) Unpaid salary amounting to Rs. 1,353,830 to the Staff of the University remaining as payables for the period ranging from 01-05 years without being taken action in accordance with FR 272 (2), and 290.
- (d) A sum of Rs. 37,455 over paid to an academic staff on account of books allowance in 1997 had not been recovered up to the year 2011.
- (e) Advances made to the various parties such as Departments of buildings and Rehabilitation and Emergency Ceylon Electricity Board and University of Moratuwa for the purpose of Supplies, imports, Books and periodicals, staff salary, sundry advances, aggregating Rs. 298,536,398 had not been recovered. Out of this balance a sum of Rs. 6,362,536 had not been recovered for more than 10 years.
- (f) Distress Loan balance of Rs. 53,055 receivable from an officer and Motor cycle loan balance of Rs. 10,802 receivable from another officer and computer loan of Rs. 18,000 receivable from another officer had been outstanding for the period ranging from 08 years to 10 years.
- (g) Out of the total advances for the Import of consumables, equipments and books and periodicals paid in 2011, 93% of advances had been paid last date of the financial year of 2011 without having proper assessments. As a result, the public funds paid for the specific purposes for the year under review had been allowed to idle throughout the year due to considerable period of delay in supply of the items ordered.
- (h) As per the supplies advance register-Consumable, a sum of Rs. 187,534 had been shown as fully settled. But as per financial statements unsettled supplies advance shown as Rs. 810,480. Further the details of settlements had not been made available to audit.

2:2:4 Lack of Evidence for Audit :

Following observations are made.

(*a*) Assets, inventory items, payables, receivable, fuel and lubricants expenses, repairs and maintenance expenses of the Vehicles and machineries, work in progress, rent payments and telecommunication charges aggregating Rs. 1,323,032,618

could not be satisfactorily vouched in audit due to non availability of annual verification reports, stock verification reports, confirmations, age analysis, detailed schedules, vehicle log books, daily running charts for certain vehicles, valuation reports and telephone registers.

- (b) Transactions such as items donated, rental income, stocks, losses and staff loans could not be satisfactorily vouched in audit due to non rendition of following evidences,
  - Detailed reports on donations received from various foreign countries/embassies, valuation reports of the rented out premises and Register of rental income.
  - Minutes of the University Council meetings
  - Minutes of the Finance Committee meetings
  - Minutes of the Library Committee meetings
  - Annual Report of the University of Jaffna
  - Annual Verification Reports
  - Accident/Loss reports. Example book losses
  - Age Analysis of Receivables and Payables. Example Staff loans

# 3. Financial and Operating Review

- 3.1 Financial Review :
- 3.1.1 Financial Results :

According to the financial statements presented, the working of the University for the year under review had resulted in a deficit of Rs. 833,942,534 before taking into the accounts for the Government grant for recurrent expenditure as compared with the corresponding deficit of Rs. 611,306,520 for the preceding year. After taking the Government grant of Rs. 773,652,193 received for recurrent expenditure, the deficit for the year under review had been reduced to Rs. 60,290,341 and after taking the Government grant of Rs. 536,400,000 received for recurrent expenditure for the preceding year, the deficit of that year had been reduced to Rs. 74,906,520, thus indicating a further deterioration of Rs. 222,636,014 in the operating financial results of the University.

# 3.1.2 Uneconomic Transactions :

Following observations are made.

- (*a*) Telephone Intercom facilities had been installed at the University in January, 2011 in order to reduce the official telephone charges by reducing the use of existing direct telephone lines. However, the Telecommunication charges for the year under review had rapidly increased by Rs. 2,496,589 or 25 percent when compared with the charges for the year 2010.
- (b) Although the University had three buses including sixteen vehicles were in its vehicle fleet a sum of Rs. 2,506,648 had been paid for vehicle hiring Charges which exceeded the estimate by 75% and fuel and lubricants expenses also had increased by 51% over the estimated figure for the year under review.
- (c) The University Registrar and Deputy Registrar are occupying in the University guest house since April, 2009 without paying rent. In this connection, electricity charges aggregating Rs. 26,253 had been paid during the year under review from the University funds.
- (d) Although it was stated in the reply for the audit query that steps have been taken to improve the guest house facilities, a sum of Rs. 379,113 had been paid for the lodging charges during the year under review for private hotels.
- 3.1.3 Property Plant and Equipment (PPE):

The value of property plant and equipment aggregating Rs. 1,933,590,051 shown in the financial statements had been based on book value. However, physical verification of these assets had not been carried out during the year under review.

- 3.1.4 Financial Management :
  - (a) Cash Management

Although a sum of Rs. 225,919,873 had been shown as a bank balance at People's Bank University of Jaffna branch as at 31st December, 2011, action had not been taken to utilize the money for the intended purpose or to invest the money with the prior approval.

(b) Investments

Sums of Rs. 216,531,122 and Rs. 7,501,740 had been shown as Long Term and Short term Investments respectively in the financial statements for the year under review and the income from investments amounting to Rs. 113,040 only had been accounted which is 0.05% on total investments. Thus indicating that the University funds had not been utilized efficiently and effectively to earn maximum income.

3.1.5 Assets Management :

Following observations are made.

(i) The following vehicles had remained idle. However, no meaningful action had been taken to utilize these vehicles for the intended purpose of the University. This was pointed out in my previous years audit report too.

- (ii) Supplies and maintenance items aggregating Rs. 3,953,319 had remained unused for a period ranging from 01 to 13 years in the stores of the University. In this regard no action had been taken to utilize them.
- (iii) A time recording machine purchased for Rs. 182,400 had been remained unused since 2001.
- (iv) 156 Nos. of steel beds purchased for Rs. 1,482,000 had been remained unused for over five years.
- (v) 161 Nos. of computers and accessories, multimedia project equipments and furnitures had been identified as idle and under utilized assets in the office of the Dean, Faculty of Management Studies and Commerce, Department of Human Resources, Department of Accountancy, and Department of Physics.
- 3.1.6 Items in Contentious Nature :

Following observations are made :-

- (i) Even though the buildings, resource persons and all the other facilities were available at the University, the lectures for the Faculty of Law had been conducted in a rented out building in Colombo and a sum of Rs. 100,000 per men sum had been paid as rental.
- (ii) Attendance registers for the academic staff had not been maintained for a long period. Therefore, staff leave, and accuracy of the salary payments made to the staff for the year under review could not be satisfactorily vouched in audit for the year under review.
- (iii) Even though it had been accepted to install 11 Nos. of Finger Print Scanners which was purchased during March and May 2011 at a cost of Rs. 714,560 had not been utilized for the intended purposes in terms of Establishment Circular No. 02/2010 of 15th February, 2010 issued by the University Grants Commission.
- 3.1.7 Identified Losses :

Loss of 23,493 numbers of books had been observed in audit it was explained to audit that the loss had occurred due to disturbances prevailed, However, no action had been taken to report this loss over last 15 years in terms of F. R. 101.

3.1.8 Contract Administration :

Following observations are made :-

(i) Construction of Buildings for the Ramanathen Academy of Fine Arts-

The project of the construction of buildings for the Ramanathen academy of Fine arts started in 1999. The construction work of painting and sculpture studios for Ramanathen Academy of Fine arts Stage III-Level- A should have been completed by August, 2011. However 40% of the above work only had been completed up to 31st December, 2011 and a sum of Rs. 94.4 million had been released to the Department of Buildings up to 31st December, 2011. Although the works for Level - A had been handed over to the University of Jaffna on 21st February 2012, the work completion certificate was not made available and the works for the Levels - B and C had not been commenced even up to 31st October, 2012.

(ii) Improving Water Supply to the Hostel Complex - Balance Work to the 25,000 gallons elevated Water Tank.

The above project was commenced in 1989 at the total estimated cost of Rs. 2.3Mn and the works had been stopped in June, 1990 due to war situation. The revised estimate for the balance work was accespted by the University in 2009. Even though the Chief Engineer Northern Division, Department of Buildings had confirmed by the letter dated 24th August, 2011 that the balance work could be completed as per the revised estimate submitted for Rs. 18Mn, the works had not been commenced up to 31st October, 2012.

- (iii) Even though the construction of building complex for the faculty of Graduate Studies had been expected to be completed in 2011 and paid a sum of Rs. 12.1 million in 2011, the physical progress was only 8% whereas the financial progress was 28%. Due to undue delay in completing the above project works, the cost of the constructions would be increased tremendously and also the objective of those construction works had not been achieved by the University.
- 3.1.9 Un-authorized Transactions :

Following observations are made-

- (i) Official vehicles of the University had been allowed to use by the officers of the University to travel between their residence/ guest house and University without proper authority.
- (ii) Refundable deposits aggregating Rs. 501,975 made for Hall, Science, Geography and Laboratory for the years 2004 to 2006 had been transferred to prior year (Receipts) account with the approval of the Vice Chancellor on 29th July, 2011. A system to get the consent from the depositors (Students) had not been followed up and still they had not been informed in connection with this transfer. Approval of the University Governing Council had not been obtained to transfer of refundable deposits to the prior year account. In this regard no action had been taken to refund these deposits at the time of the students leaving from the University.

# 3.1.10 Irregular Payments :

Following observations are made-

- (i) According to the work schedule and the cost estimate submitted by the Director, Project Consultancy Unit of the University of Moratuwa; the Jaffna University Council had approved the total cost estimate of Rs. 2,450,000 (excluding VAT) on 24th September, 2011 for the consultancy services to prepare the master plan for the University of Jaffna. Sums of Rs. 490,000 and Rs. 260,000 had been released as mobilization advance on 23rd December, 2011 and 05th July, 2012 repectively with the approval of the Vice chancellor. However a memorandum of Understanding (MOU) had not been signed by the respective parties and works had not been completed up to 31st October, 2012.
- (ii) Total cost estimate of Rs. 36,011,600 had been approved by the University Council to construct a building for the Faculty of Graduate studies. University of Jaffna, and an agreement had been signed on 24th April, 2012 with Central Engineering Consultancy Bureau (CECB). In this regard following observations are made.
  - (*a*) A sum of Rs. 8,066,603 or 20% of the total cost estimate (including VAT) had been paid as mobilization advance to the CECB on 22nd September, 2011 without an agreement as requested by UGC Engineer through e-mail document.
  - (b) The CECB had been appointed for consultancy services and contractor of the works as well. In this connection conflict of interest had not been considered as parties involved in consultancy and carrying out contract work are same.
  - (c) Works had not been completed up to 31st October, 2011 according to the work plan.

# 3:2 Operating Review

3.2.1 Examinations Held and Release of Results :

Dates to hold the examinations for various courses conducted under each faculty of the University and target dates to release results of these examinations had not been determined. It was observed that there were considerable delays in releasing the results of examinations conducted by the faculties of Agricultures, Arts, Management studies and Commerce and Science and external examination unit of the University during the years 2010 and 2011. According to the University Grants Commission circular No. 636 of 14th July, 1995 results should be released within three months after the examination. But, results had been delayed for the periods ranging from 4 to 14 months, there by the students had been deprived to get their employment opportunities in time.

3.2.2 Cost per Student :

Total number of students registered for the courses of the University were 5,425 as at the end of the year under review. Total recurrent expenditure incurred during the year under review amounted to Rs. 555,663,167. The average recurrent cost per student for the year was Rs. 102,426.

# 3.2.3 Human Resources Management :

The University had not taken action to recruit suitable persons for the existing vacant cadre; instead staff had been recruited on temporary basis excessively. Details are as follows:

In this connection although the interviews for recruitments had been conducted to fill the vacancies in several time, recruitments were not made up to 31st October, 2012. Reasons for delay in recruitment had not been furnished by the University.

## 3.2.4 Recruitments and Appointments :

Academic Staff of the University had been proposed by Board of study based on approval obtained from the University Council to conduct the BBM (On Line) Degree programme. In this regard the lecturers were appointed and paid for Subject Matter Experts and Subject Matter reviewers. Following observations are made in this regard.

- (a) Proper scheme of recruitment, method of recruitment, selection criteria, basis for the selection and appointment, determination for the payment formula for the Subject matter experts and reviewers for the Subjects of 1st, 2nd and 3rd years of the Programme had not been followed. In this regard a sum of Rs. 1,100,000 had been paid for subject matter experts and Rs. 410,000 for subject matter reviewers. These payments were considered as irregular payments due to the under mentioned reasons.
  - (i) One Academic Staff from the Faculty of Managment Studies and Commerce had been appointed as Subject matter expert and Subject matter reviewer for more than one subject.
  - (ii) A Lecturer had been appointed as both Subject Matter Expert and Subject Matter reviewer for the Subject of Principles of Economics (BBM 1201) and paid Rs. 20,000 for the Subject matter reviewing.
  - (iii) Even though the Lecturers and professionals were available in the relevant field from the Department of Economics, Law and Computer Science of the University, the appointments were made from the academic staff of the Faculty of management studies and commerce for Subject Matter Expert and Subject matter reviewer to the Department of Economics, Law and Computer Science.
- 3.2.5 Procurement of Goods and Services-

Following observations are made-

- (i) A procurement plan had not been prepared and submitted to audit in terms of Procurement Manual 2006 and the National Budget Circular No. 128 of 24th March, 2006.
- (ii) A sum of Rs. 95,000 had been agreed to pay as monthly rental without obtaining the valuation report for the rented out property from Chief Valuer of the Valuation Department.
- 3.2.6 Non-Achievement of Corporate Social Responsibility (CSR) :

Waste water disposal system for female hostel complex of the University-

Consultancy charges amounting to Rs. 750,375 had been paid during the year 2008 as an advance to National Water Supply and Drainage Board for waste water disposal system for female hostel complex of the University.

Memorandum of Understanding between the University of Jaffna and National Water Supply and Drainage Board was signed on 19th June, 2008, for the total estimated cost (excluding VAT) of Rs. 9,004,500. Subsequently the estimate had been revised to Rs. 18,881,695 or 109.7% by the National Water Supply and Drainage Board.

According to the Vice Chancellor's letter No. A/CWP/01 dated 08th November, 2010 the revised estimate had not yet been approved by the University Council. Due to the delay in commencement of this Project for the last three years people liveing in the surrounding area of the University had been affected by the polluted water.

- 4. Accountability and Good Governance
- 4.1 Corporate Plan :

A corporate plan for the period 2011-2015 had been prepared and updated annually in terms of the Public Enterprises Circular No. PED/12 of 02nd June, 2003.

4.2 Annual Action Plan :

Action Plan for the period 2011-2015 had been prepared instead of preparing for the year 2011. However the progress of the targets indicated in the action plan had not been reviewed periodically.

# 4.3 Internal Audit :

Following areas had not been covered by the internal audit programme prepared by the University.

- (a) Vavuniya campus of the University.
- (b) Capital work projects and contract administration.
- (c) Procurements.
- (d) Loans and Advances.
- 4.4 Follow up Action on Audit Queries :

Following observations are made.

- (i) 67 audit queries issued for the years 2010 and 2011 had been replied with a considerable period of delay ranging from 01st month to 11 months.
- (ii) An Audit Query Register had not been maintained in terms of F. R. 452.
- (iii) Details of unanswered audit queries are given below.

4.5 Rendition of Information to Audit :

A separate income and expenditure account for extension course such as English, Computer, etc conducted at Vavuniya Campus during the year under review had not been prepared.

4.6 Publication of Annual Report :

Annual reports for the years 2008 to 2010 had not been tabled in Parliament even up to 30th June, 2012 in terms of Section 6.5.3 of the Public Enterprices Circular No. PED/12 of 02nd June, 2003.

4.7 Budgetary Control:

Significant variations were observed between the budget and actual thus indicating that the budget had not been made use of as an effective instrument of management control.

5. Systems and Controls

Observations made in systems and controls during the course of audit were brought to the notice of the Vice Chancellor of the University by my detailed report issued in terms of Section 13 (7) (a) of the Finance Act. Special attention is needed in respect of the following areas of control.

- (a) Assets Management ;
- (b) Library administration;
- (c) Stores Administration ;
- (d) Contract Administration ;
- (e) Delays in Projects ;
- (f) Receivables and Payables;
- (g) Procurements;
- (h) Human Resources Management ;
- (i) Budget.

# OBSERVATION OF THE UNIVERSITY OF JAFFNA ON REPORT OF THE AUDITOR GENERAL ON THE ACCOUNTS OF THE UNIVERSITY OF JAFFNA FOR THE YEAR ENDED 31ST DECEMBER, 2011.

# 2.2.1

- (i) Action will be taken to revalue in the course of the year 2013.
- (ii) (a & b) All the details are available in the working files. However action will be taken to comply with SLAS 18 in future.
- (iii) Action will be taken to comply with SLAS 16 in future. An annual provision will be made and the actula payment of gratuity will be deducted from the provision as per SLAS 16.

2.2.2

- (a) Amount of Rs. 540,887 represents payment in advance for the supply of Periodicals and journals. Action is being taken to communicate with the supplier and carried forward the amount represents periodicals and journals not supplied for the future. This advance will be cleared and the periodicals and journals will be capitalized when supplies received in full.
- (b) The Department of Building has still not submitted the works completion certificate for some project as they did not settle the final bills to the contractors. Building Department has been continuously reminded to submit the works completion Certificate.
- (c) Normally excess of expenditure is transferred to the General Reserve Account.
- (d & e) Already it has been brought to the account of the year 2012.
  - (f) Action is being taken to bring into the account of the year 2012.
  - (g) This amount represents the material lost during the transportation by ship from Colombo to Jaffna and approval will be taken from the appropriate authority to settle in the year 2013.
  - (*h*) Journal Entry has been passed for the amount of Rs. 1,750 in the year 2012. Order book had been corrected in the year 2012 and the amount involved is Rs. 61,447.
  - (*i*) The difference of amount is due to on analysis it was found that the aggregate of the sub ledger account differs with the amount in the Trial Balance. It has been ascertained that wrong entries in main ledger and now it has been corrected.

2.2.3

- (a & b) The parties have been identified and we are in communication with them to clear this receivables and payables. The list is annexed (Annexure 01)
  - (c) This represents unpaid salaries of various types. Analysis is made to identify those which are not actually payable such as salary in lieu of notice to be credited to revenue. Salaries which should be actually payable will be identified and parties will be communicated before finalizing whether to pay or to credit back to revenue.

- (d) With concern of the authorities action has been taken to transfer to revenue.
- (e) The following projects are in progress and classified as follows (annexure 2). Current year projects coming under current year. Previous projects are funded from previous funds. Every effort is made to obtain completion certificates from Department of Building with regard to completed projects.
- (f) Provident fund of officers still on due. When releasing provident fund we will deduct these amounts. We are in consultation with UGC to deduct these from the funds lying in their Provident Fund accounts.
- (g) This had been utilized for necessities and release of funds by treasury at the latter part of the year. Out of 321,500,000 of capital in the year 2011, 181,500,000 (i. e. 56% of capital grants) have been received in the latter part of the year. Details are as follows.

2.2.5 We have noted and we will comply in future :

3.1.2

- (a) Due to prevailing normalcy in the area, the academic and administrative activities of the University have expanded and increased providing latest communication facilities which cause for this increase in the usage. Due to the development activities, widening of road network caused frequent disconnection of power supply during the whole office hours leads to the compulsory usage of direct lines.
- (b) University has received three vehicles (two van & one pick up) under the Finance leasing method and these vehicles are used for the long distance journey and officers are invited for the several meetings frequently to Colombo and it is essential to use hired vehicles as the existing vehicles are needed for the local travelling.
- (c) It is to be pointed out that electricity charges for the nine months aggregating to Rs. 26,253.26 has an average monthly sum of Rs. 2,917.029 and the average charge for this should have been much lower than this if the first three months are not taken into account During April in 2011 Building Engineers and workers who work under SIDA project for the IT network project stayed there and finalized all the work. University has signed the agreement with SIDA in which it was agreed to provide accommodation and electricity and other amenities free for those who were engaged by way of SIDA agreement to facilitate completion of the said project. They used electrical equipment during the stay and it was the reason for the higher electricity charges during that period. Further, CEB has reported connection wire malfunctions during the period in the line supplying electricity to the said building and losses have been reported to be occurred to faulty earthling in the surroundings. This fact could be verified from the CEB as it has rectified it later after informing the University. Only the basic electrical maintenance charges are to be expected from the Guest House and no special/extraneous expenses were related to it. The Registrar by virtue of his post is entitled for quarters and was accommodated in the above said premises with the approval of the Vice Chancellor.
- (d) We experience difficulties in finding accommodation for guests who come for visiting lecturers/selection board *etc*. The Guest House with good facilities is a long felt need. The facilities such as AC, toilets *etc*. in the Guest House are not adequate and satisfactory for the many guests who come on our request to attend important meetings and official functions. They specially insisted on the above facilities and therefore lodging had to be obtained outside.
- 3.1.3 We are in the process of outsourcing these activities.

3.1.4

- (*a*) The excess money in the current account has been invested in fixed deposit with the permission of the Council. The excess funds exposed due to under ependiture of capital projects approved and also suddenly release of funds for new projects. Every effort is made to encash and utilizes this money including running self financing courses.
- (b) Whatever interest earned from investment out of the endowment fund or similar donation would be utilized for the intended purpose of the donor.
- 3.1.5(i) & (ii) With the commencement of the Faculty of Agriculture at Kilinochchi, the Land master is being used. Other vehicles are used by the University. The items in the stores are being classified into serviceable and obsolete items. Action is being taken in the year 2013 for all obsolete items.
  - (iii) Already finger scanner machines were installed and in use according to the latest Circular. Time recording machine will be taken as condemned and unserviceable items.
  - (iv) Some beds have been already issued to the newly rented houses. The balance will be transferred to the hostel of Agriculture and Engineering which are needful to accommodate the newcomers.
  - (v) With the commencement of the E-lab of the Faculty of Commerce and Management Studies, computers are being used. All these are coming under the Faculty of Commerce and Management Studies.

3.1.6

- (i) It was decided by the University Senate to conduct the 4th year study programme for the LLB students in Colombo in consideration of the following to ensure the quality.
  - 1. The fourth year programme consist of Six Course Units and Research Project having 30 Credit Value.

- 2. Only one permanent Lecturer will be available in the Department of Law in the next academic year to undertake the teaching programme.
- 3. Mr. V. T. Thamilmaran SL I, Mrs. S. Segarajasingam SL I, Mr. Sivapatham SL I, and Mr. A. Sarveswaran SL I, of the Faculty of Law, University of Colombo are prepared to take Lectures for the 4th year students in Colombo Center of the Department of Law, University of Jaffna. They cited that present workload and the incovenience in travelling to and from Jaffna as primary reason for them to prefer teaching the 4th year students from Colombo.
- ii. Academic Staff in the Univerity system do not generally sign in the Attendance Register. However, this matter was brought to the notice of the Council and the Council will take action on this in due Course.
- iii. Finger Scanner Machines have been fixed at the all Dean's Office, Teaching Hospitals, Library, Registrar's Office, Security Department, Ramanathan Academy of Fine Arts and Unit of Siddha Medicine to confirm the arrival and Departure. Administrative Officers, Trainees and other staff on assignment basis are using the machines.
- 3.1.7 During the displacement these losses have occured and no proper procedures like reporting to police were followed. Now action will be taken according to the FR 101 after the valuation report has been obtained.

# 3.1.8

- i. The works for the level B and C is in progress and the Department of Buildings was requested to expedite the completion of building soon.
- ii. Since the Department of Buildings (Central) has submitted revised estimate for 19.9 million, the University Procurement Committee has requested the Department of Buildings to submit some relevant documents to recommend the revised estimate.
- iii. The stage I of the contract which was awarded to CECB for Rs. 33.9 million has already been completed.

# 3.1.9

- i. Transport is provided to Officers of the University to travel between their residence and univerity as per PA circular 22/99 adopted by UGC establishment circular Letter 07/2000.
- ii. Approval of the University Governing body was already obtained to credit to revenue. In future students will be required to declare the amounts lying to their credit are not claimed those will be transferred to the University revenue within 03 months after completion of studies.

# 3.1.10

i. The Master Plans for Faculties of Agriculture and Engineering at Kilinochchi and the Vavuniya Campus has been already submitted to UGC. The Master Plan already prepared for University main complex (Jaffna) and will be finalized very soon. Step will be taken to sign the MOU within the next two months.

ii.

- (*a*) Since the CECB had accepted the letter of award issued by the University and this award was approved by the Cabinet of Ministers the advance payment was made to CECB pending signing the formal agreement.
- (b) The method of Procurement of works called "Design and Build" is one of the Procurement method approved by the Cabinet of Ministers.
- (c) Works had not been completed by 31st October, 2011 but that work was nearing completion at that time.
- 3.2.1 Now it has been improved. Action is being taken to report to the Senate about the examiners who are not responding in time based on the Circulars. Further these reminders will be filed in their personal files.
- 3.2.3 Information is noted.

3.2.4

(*a*) The BBM Online programme is a part of the Degree programme offered by the Faculty of Management Studies and Commerce. We never recruit lecturers (SME and Reviewers) over an advertisement. The lecturers who have been recruited in the normal

advertisement for our faculty will help to run this programme with additional work which involves additional payment. All SME's and experts are members of the Faculty. The observation of the audit has no relevance in this matter.

The Board of study for BBM Online degree programme decided the payment formula based on the other Universities like University of Peradeniya for the BBM Online degree programme. The Finance Committee and the Council give the final approval for the budget submitted by the Board of study of the BBM online degree programme with the said provisions.

- i. It is not mandatory that one lecturer should be appointed to one subject; all depends on the quality and relevancy of the lecturer considering qualification and experience.
- ii. There is no subject as Principles of Economics in our Curriculum for first year second semester. Mr. S. Ramesh appointed as SME and Mr. B. Pragalathan appointed as reviewer for the subject BBM 1201 Economics for Enterprises in the first year second semester.
- iii. It is expected that a standard on par with our internal degree programmes should be maintained. The lecturers involve in the internal degree programmes will maintain the same standard for the BBM Online degree programme.

3.2.5

- i. University has followed proper system and necessary format according to the Procurement Manual. Action will be taken to follow the Procurement Manual properly in future. Due to the non-availability of Ministry nominee to the Procurement Committee during non-office hours, we are compelled to have the meetings during office hours. Further payments have not been claimed by the members.
- ii. Valuation report was not obtained at that time. The lease has been terminated on 28.02.2013. The lapse is noted and it will not be repeated.

# 3.2.6

- i. The above project is nearing completion and will be handed over to us within next two months.
- 4.1 & 4.2 A Corporate Plan for Year 2012-2016 has been already submitted. Corporate Plan for Year 2013-2017 is being prepared, in terms of the Public Enterprise Circular No. PED/12 of 02nd June, 2003. It will be reviewed periodically. Action Plan for 2013 is being prepared now.
  - 4.3 The subject of (*a*), (*b*), (*c*), (*d*) have been included in the Internal Audit Programme and plan for the year 2013. The subjects such as capital work projects and contract administration, procurements, loans and advances had been included in the Internal Audit Programme and Plan 2011 and had been done the audit works.

In the past years, the Internal Audit Unit was unable to observe the activities of Vavuniya Campus of University of Jaffna due to following reasons.

\* Shortage of staff.

\*No appointment for the head of Internal Audit Division for a long time. Only the division was run by two Senior Staff Assistants.

\*Difficulties in travelling due to prevailing situation at that time such as War and Exodus.

- 4.4 Most of the audit queries have been replied except two. Every effort is made to finalize a reply for those two queries, failing an interim reply will be given.
- 4.5 Separate accounts are being maintained for income and expenditure in the ledgers for extension programmes and shown in the trial balance also separately and furnished to audit.
- 4.6 The Annual Reports 2011 had been submitted to the Ministry of Higher Education excluding Auditor General's report on the Final Accounts 2011.
- 4.7 The University has adhered to the UGC guidelines. Variations have been informed to the Faculties to take action to minimize.
- 5.0 Proper systems and controls are there in design. Heads of Divisions have been reminded of the requirement to strictly follow the control systems by monitoring the performance of staff. These details are dealt in the induction programme for the probationary lecturers.
