All Government Departments, corporations, Boards, etc. are hereby advised that Notifications fixing closing dates and times of applications in respect of Post-Vacancies, Examinations, Tender Notices and dates and times of Auction Sales, etc. should be prepared by giving adequate time both from the date of despatch of notices to Govt. Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 04th July, 2014 should reach Government Press on or before 12.00 noon on 20th June 2014.

AN ACT TO INCORPORATE THE SATHMETHSILHAULA SOCIETY

I, Janaka Wakkumbura do hereby give notice under Standing Order No. 48(1) of the Parliament of the Democratic Socialist Republic of Sri Lanka that, I propose to introduce in Parliament a Bill entitled "An Act to incorporate the Sathmethsilhauula Society".

The aim of the Bill is to incorporate the said Sathmethsilhauula Society which has the following general objects :-

1. To encourage and provide support for obtaining and practising *adhisila, adhisamadhi and adhipanna* as Buddhist monks and Dasasilmathas to those who have been found suitable for ordination ;

2. To encourage and provide support for upasakas and upasikas to develop *sila, samadhi and panna* ;

3. To facilitate the Buddhist practitioners affiliated to the monasteries maintained by the Corporation to follow the instructions in the particular meditation techniques taught and practised in accordance with the teachings of the Lord Buddha in those monasteries etc.

with a view to emphasizing and achieving the *nibbana gamini patipada*.
