NOTES TO THE FINANCIAL STATEMENT - 31ST DECEMBER, 2012

1. Basis of Preparation

(a) Statement of Compliance

The Financial Statements have been prepared in accordance with Sri Lanka Accounting Standards for Small and Medium- Sized entities (SLFRs for SMEs). These are the Institute's first financial statements prepared in accordance with SFRs for SMEs and First time adoption of Sri Lanka Accounting Standards for Small and Medium Sized has been applied.

Functional and Presentation Currency

The Financial Statments are presented in Sri Lanka Rupees which is the functional currency of the Funds.

(b) Basis of Measurement

The Financial Statements have been prepared on the historical cost basis.

(c) Events After Reporting period

All material events occurring after the Balance Sheet date have been considered and where necessary, adjustments have been made in the Financial Statement.

(d) Use of Estimates and Judgments

The preparation of the Financial Statements in conformity with SLFRS requires management to make judgments, estimates and assumptions that effect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

(e) Transition to the SLFRS for SMEs

Basis of Transition

The Financial Statement of the funds, for the year ended 31st December, 2012 are the first annual financial statments prepared to comply with SLFRS for SMEs.

The date of transition is the 01st January, 2011. The opening balances of the financial statements are adjusted to comply with the new standards. In preparing these financial statements the company has applied all mandatory exceptions and exemptions from other SLFRSs for SMEs

(f) Foreign Currencies

All Foreign exchange transactions are initially recorded at the functional currency rate rulling at the date of transaction. All monetary assets and liabilities denominated in foreign currency at the year end are translated at the rate ruling on the Balance Sheet date. Non-Monetary items which are measured in terms of historical cost or fair value denominated in foreign currency is translated using the exchange rate at the date of the initial transaction.

Non Monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated to reporting currency using the exchange rate that was prevailing on the date the fair value was determined. The resulting gains or losses on translations are dealt with in the income statement.

(g) Going Concern

The Directors have made an assessment of the Funds ability to continue as a going concern in the foreseeable future, and they do not intend either to liquidate or cease operation.

2. **Assets and Bases of their Valuation :**

Significant Accounting Policies

The accounting policies set out below have been consistently applied to all periods presented in the Financial Statements and in preparing the opening SLFRS statement of financial position at 01st January, 2011 for the purposes of the transition to SLFRS unless otherwise indicated.

2.1 *Property, Plant and Equipments*

a. *Cost :*

Costs incurred in acquiring improving or extending property, plant and equipment have been treated as Capital Expenditure. Property, plant and equipment are recorded at cost less excluding the cost of day to day servicing, less accumulated depreciation and accumulated impairment in value.

b. *Depreciation :*

Depreciation has been calculated in order to write off the cost of property, plant and equipment on the reducing balance method basis over the expected useful lives of the concerned assets, using the following rates :

Full provision for depreciation has been made in the month of purchase and no depreciation has been charged in the Month of Disposal.

c. *Leased Assets*

Where property, plant and equipment have been financed by leasing arrangements, which transfers substantial benefits and risks of ownership, are classified as financial leases the assets are treated as if they have been purchased outright and are included in Property, Plant and Equipment have been depreciated according to the rates specified above.

Rights to assets held under finance leases are recognized as assets of the fund at the fair value of the leased property (or, if lower, the present value of minimum lease payments) at the inception of the lease. The corresponding liability to the lessor is included in the statement of financial position as a finance lease obligation. Lease payments are apportioned between finance charges and reduction of the lease obligation so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are deducted in measuring profit or loss. Assets held under finance lease are included in property, plant and equipment, and depreciated and assessed for impairment losses in the same way as rentals payable under operating lease are charged to profit or loss on a straight-line basis over the terms of the relevant lease.

2.2 Financial Instruments

2.2.1 Non-derivative Financial Assets

The Fund recognises financial assets or financial liabilities in its statement of financial position when the funds becomes a party to the contractual provision of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of a financial asset or liability (other than financial assets and financial liabilities at fair value through profit or loss) are added or deducted from the fair value of the financial asset or liability, as appropriate, on initial recognition. Transaction costs that are directly attributable to the acquisition of financial assets and financial liabilities at fair value through profit or loss are recognised immediately in the income statement.

Financial assets and liabilities are offset and the net amount is presented when, and only when the Fund has a legal right to offset the amount and intends either to settle on a net basis or to realise the asset and settle the liability simultaneously.

The Fund has following non-derivative financial assets: held to maturity financial assets, loans and available for sale financial assets.

2.2.1.1 Held to Maturity Financial Assets

A non-derivative financial asset with fixed or determinable payments with fixed maturity where Fund intends to hold to maturity is classified under this category.

Held to maturity financial assets are recognised initially at fair value plus any directly attributable transaction costs. Subsequent to initial recognition held-to-maturity financial assets are measured at amortised cost using the effective interest method, less any impairment losses.

Held to maturity financial assets comprise to T Bills and T Bonds.

2.2.1.2 Loans and Receivables

Loans and receivables are financial assets with fixed or determinable payments that are not quoted in an active market. Such assets are recognised initially at fair value plus any directly attributable transaction costs.

Subsequent to initial recognition loans and receivables are measured at amortised cost using the effective interest method, less any impairment losses.

Loans and receivables comprise of staff loans and trade and other receivables.

2.2.1.3 Available-for-Sale Financial Assets

Available for sale financial assets are non-derivative financial assets that are recognised as available or sale or not classified in any previous categories. Available for sale financial assets are recognised initially at fair value plus any directly attributable transaction costs.

Subsequent to initial recognition, they are measured at fair value and changes therein, other than impairment losses, are recognised in other comprehensive income and presented in the available for sale reserve in equity. When an investment is derecognised, the cumulative gain or loss in other comprehensive income is transferred to profit or loss.

Available for sales financial assets comprise of equity investments.

2.2.1.4 Derecognition of Financial Assets

The Fund derecognises a financial assets when the rights to receive cash flows from the assets have expired or when it transfers the financial asset in a transaction in which substantially at the risks and rewards of ownership of the financial assets are transferred or in which fund neither transfers nor substantially all risk and rewards of ownership and it does not retain control of the financial assets.

Transactions in which the fund neither retains nor transfers substantially all the risks and rewards of ownership of a financial assets and it retains control over the assets, the Fund continues to recognise the assets to the extent of its continuing involvement, determined by the extent to which it is exposed to changes in the value of the transferred asset.

On recognition of a financial asset, the difference between the carrying amount of the assets (or the carrying amount allocated to the portion of the assets transferred), and the sum of (i) the consideration received (including any new assets obtained less any new liability assumed) and (ii) any cumulative gain or loss that had been recognised in order comprehensive income is recognised in profit or loss.

The Fund derecognises a financial liability when its contractual obligations are discharged or cancelled or expire.

2.2.2. *Non-Derivative Financial Liabilities*

The Fund initially recognises debt securities issued and subordinated liabilities on the date that they are originated. All other liabilities are recognised initially on the trade date at which the Company becomes a party to the contractual provisions of the instrument.

The Fund classifies non-derivative financial liabilities into other financial liabilities category. Such financial liabilities are recognised initially at fair value plus any directly attributable transaction costs. Subsequent to the initial recognition, these financial liabilities are measured at amortised cost using the effective interest method.

Other financial liabilities comprise interest bearing borrowings, banks, overdraft and trade and other payables.

Bank overdraft that are repayable on demand and form an integral part of the Fund's cash management are included as a component of cash and cash equivalents for the statement of cash flows.

2.2.2.1 *De-recognition of Financial Liability*

The Fund derecognises a financial liability when its contractual obligations are discharged, cancelled or expired. Financial assets and liabilities are offset and the net amount presented in the statement of financial position when and only when, the Fund has a legal right to offset the amounts and either to settle on a net basis or to realise the asset or settle the liability simultaneously.

2.2.3 *Amortised Cost Measurement*

The amortised cost of a financial asset or liability is the amount at which the financial asset or liability is measured at initial recognition, minus principal repayments and any impairment and plus/minus the cumulative amortisation using the effective interest method of any difference between the initial amount recognised and the maturity amount, minus any reduction for impairment.

2.2.4. *Fair Value Measurement*

Fair Value is the amount for which an asset could be exchanged, or a liability settled, between knowledgeable, willing parties in an arm's length transaction on the measurement date.

The fair value of financial instruments that are traded in an active market at each reporting date is determined by reference to quoted market prices or dealer price quotations, without any deduction for transaction costs.

For financial instruments not traded in an active market, the fair value is determined using appropriate valuation techniques. Such techniques may include using recent arm's length market transactions: reference to the current fair value of another instrument that is substantially the same, a discounted cash flow analysis or other valuation models.

2.2.5. *Impairment*

The carrying amounts of the Fund's non financial assets, other than inventories and deferred tax assets are reviewed at each reporting date to determine whether there is any indication of impairment. If any such indication exists, the assets recoverable amounts are estimated.

The recoverable amount of an asset or cash generating unit is the greater of its value in use and its fair value less costs to sell. In assessing value in use, the estimated future cash flows are discounted to their present value using a per tax discount rate that reflects current market assessment of the time value of money and risks specific to the asset or cash generating unit. In determining fair value less costs to sell on appropriate valuation made is used.

An impairment loss is recognised if the carrying amount of an asset or cash-generating unit exceeds its estimated recoverable amount impairment losses are recognised in profit and loss. An impairment loss is reserved if there has been a change in the estimates used to determine the recoverable amount. An impairment loss is reversed only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

2.2.5.1 *Impairment of Non-derivative Financial Assets*

Financial assets other than those measured at fair value are assessed for indicators of impairment at the end of each reporting period. Financial assets are considered to be impaired when there is objective evidence that as a result of one or more event that occurred after the initial recognition of the financial assets, the estimated future cash from the asset have been affected.

The Fund assesses at each reporting date whether there is any objective evidence that a financial assets or a group financial assets is impaired. A financial assets or a group of financial assets is deemed to be impaired if, and only if, there is objective evidence of impairment as a result of one or more events that has occurred after the initial recognition of the asset and that loss event have an impact on the estimated future cash flows of the financial asset or the group of financial assets that can be reliably estimated.

a. *Impairment Losses on Financial Assets carried at Amortised Cost*

Impairment losses on assets carried at amortised cost are measured as the difference between the carrying amount of the financial asset and the present value of estimated future cash flows discounted at the asset's original effective interest rate.

Impairment losses are recognised in profit or loss and reflected in an allowance account against loans and advances. When a subsequent event causes the amount of impairment loss to decrease, the decrease in impairment loss is reversed through profit or loss.

b. *Impairment Losses on Available-for-Sale Financial Assets*

Impairment Losses on Available-for-Sale investment securities are recognised by transferring the cumulative loss that has been recognised in other comprehensive income to profit or loss as a reclassification adjustment. The cumulative loss that is reclassified from other comprehensive income to Profit or loss is the difference between the acquisition cost, net of any principal repayment and amortisation, and the current fair value, less any impairment loss previously recognised in profit or loss. Changes in impairment provisions attributable to time value are reflected as a component of interest income.

If, in a subsequent period, the fair value of an impairment available-for-sale debt security increases and the increase can be objectively related to an event occurring after the impairment loss was recognised in profit or loss, the impairment loss is reversed, with the amount of reversal recognised in profit or loss. However, any subsequent recovery in the fair value of an impaired available-for-Sale equity security is recognised in other comprehensive income.

2.3. *Inventories*

No physical verification was carried out at end of the Financial Year and Inventories are valued by management.

2.4. *Cash and Cash Equivalents*

Cash and cash equivalents comprise cash in hand, demand deposits and short-term highly liquid investments, readily convertible to known amounts of cash and subject to insignificant risk of changes in value.

For the purpose of cash flow statement, cash and cash equivalents consist of cash in hand and deposits in banks net of outstanding bank overdrafts.

2.5. *Liabilities and Provisions*

A provision is recognised if, as a result of a pest event, the Fund has a present legal or constructive obligation that can be measured reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessment of the time value of money and the risks specific to the liability. The unwinding of the discount is recognised as finance cost.

Capital Commitments and Contingencies

Capital Commitments and Contingent liabilities of the Fund are disclosed in the respective notes to the Financial Statements.

2.6. *Employees Benefit*

2.6.1. *Defined Benefit Plan*

The Fund has both defined benefit and defined contribution plans. A defined contribution plan is a pension plan

under which the group pays fixed contributions to a separate entity. A defined benefit plans define an amount of pension benefit that an employee will receive on retirement, based on the years of service and compensation.

The liability is not externally funded.

All actuarial gain and losses arising from defined benefit plans are recognised immediately in profit and loss.

2.6.2. *Defined Contribution Plans - Employees' Provident Fund and Employees' Trust Fund*

A defined contribution plan is a post-employment benefit plan under which an entity pays fixed contributions into a separate entity and will have no legal or constructive obligation to pay further amounts. Employees are eligible for contributions to Employee's Provident Fund and Employees' Trust Fund in line with the respective status and Regulations. The Fund contributes 12% and 3% of gross emoluments of employees to the Employees' Provident Fund, and the Employees' Trust Fund, respectively and is recognised as an expense in profit and loss in the periods during which services are rendered by employees.

2.6.3. *Short-Term Benefits*

Short-term employee benefit obligations are measured on an undiscounted basis and are expensed as the related service is provided. A liability is recognised for the amount expected to be paid under short-term cash bonus if the Fund has a present legal or constructive obligation to pay this amount as a result of past services provided by the employee and the obligation can be measured reliably.

2.7. *Provisions*

Provision for legal claims are recognized when the Fund has a present legal or constructive obligation as a result of past events, it is probable that a transfer of economic benefit will be required to settle the obligation and the amount can be estimated reliably.

The provision are measured at the present value of the future amount required to settle the obligation using a per tax reflecting the current assessment of the time value of money and specific risks relevant for the obligation. The increase in provision due to time passage is recognized as an interest expense.

3. Income Statement

3.1. *Revenue Recognition*

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Fund and the revenue and associated costs incurred or to be incurred can be reliably measured. Revenue is measured at the fair value of the consideration received or receivable, trade discounts and turnover taxes. The following specific criteria are used for the purpose of recognition of revenue.

a. *Rendering of Services*

Revenue from rendering of services is recognised in the accounting period in which the services rendered or prepared.

b. *Interest*

Interest income is recognised in profit and loss as it accrues and is calculated by using the effective interest rate method.

3.2. *Expenditure Recognition*

Expenses are recognised in profit and loss on the basis of a direct association between the cost incurred and the earning of specific items of income. All expenditure incurred in the running of the business and in maintaining the Property, Plant & Equipment in a state of efficiency has been charged to income in arriving at the profit for the year.

Net Finance Cost

Finance income comprises interest income on funds invested, and which is recognised as it accrued in profit or loss, using the effective interest method.

Finance cost comprises interest payable on borrowings. Borrowing cost that are not directly attributable to the acquisition, construction or production of a qualifying assets are recognised in profit or loss using the effective interest method.

Foreign currency gains and losses are reported on a net basis as either finance income or finance cost depending on whether foreign currency movements are in net gain or net loss position.

3.3. *Taxation**Sales Tax*

Revenues, expenses and assets are recognised net of the amount of sales tax except where the sales tax incurred on a purchase of assets or service is not recoverable from the taxation authorities in which case the sales tax is recognised as a part of the cost of the asset or part of the expense items as applicable and receivable and payable that are stated with the amount of sales tax included. The amount of sales tax recoverable and payable in respect of taxation authorities is included as a part of receivables and payables in the Balance Sheet.

3.4 *Borrowing Costs*

Borrowing costs are recognised as an expense in the period in which they are incurred..

4. *First Time Adoption of SLFRS/LKAS*

The Financial Statement, for the year ended 31st December 2012, are the first Financial Statements prepared in accordance with SLFRSs/LKAS. Previously for period up to, the company prepared its Financial Statements in accordance with Sri Lanka accounting standard which were effective up to 31st December, 2011.

5. *Explanation for Transition to SLFRS/LKASs*

In preparing SLFRS/LKASs Statement of Financial Position for previously reported financial period, required adjustment have been made in accordance with the respective SLFRS/LKASs. The effect of the transition from SLASs to SLFRS/LKASs has been presented in the reconciliation statements and accompanying notes to the material reconciliation items.

6. *Determination of Fair Values*

A number of the Funds's accounting policies and disclosures require the determination of fair values, for both financial and non-financial assets and liabilities. Fair values have been determined for measurement and/or disclosure purposes, based on the following methods. When applicable, further information about the assumptions made in determining fair values is disclosed in the Notes specific to that asset or liability.
