ESALA PERAHERA OF BOLTHUMBE SAMAN DEVALAYA - 2014

- (1) The "Kap Situweema" Ceremony of Esala Perahera 2014 was held auspiciously on 21st July 2014.
 - * The "Uda Maluwa Perahera" will be held from 27th August to 6th September.
 - * The "Maha Perahera' will be held from Spetember 07th to 13th.
 - * The water-cutting ceremony will be held at the "Walahun Ella Mukalana" water spring on 14th September and the Perahera will be over.
- (2) The lands of Mr. M. K. Louis Siknkno and Mr. M. K. Podimahaththaya to the North quarter, Mr. Sirinimal and Mr. M. K. Wijedasa to the East quarter, Mr. Ranbandara's "Galpadiwaththa' land to the South quarter and Mr. B. M. Wijehamy and Mr. Nobert Chinthamani to the West quarter are allocated for the accommodation of the pilgrims and see the perahera.
- (3) Preparing food items in and around and shrine terrace, Bodhi tree terrace and devala premises is prohibited.
- (4) All the trades and prohibited in the upper flor, "Dandu hela", dagoba terrace and "Ratha ge" terrace.
- (5) Trades will be allowed in the following areas in a way that the perahera will not be obstructed.

- * From the main stone staircase to the staircase of the throne palace to the right side of the down street.
- * From the "Ratha ge" terrace wall to the dagoba portion to the dancing room in the East.
- * The area prescribed by me and well the areas to the bottom of the East and South and to the East boundary of the devalaya.
- (6) Trades are totally prohibited in the camp area; in areas except mentioned by the above 4th and 5th statements.
- (7) Parking private vehicles at the main road is totally prohibited. All the traffic including bicycles and carts cannot be taken into the camp area devoid of a licence issued by the officer in charge of the camp.
- (8) Notices will be published for making aware of the procedures of leasing of lands for trade in the camp area.
- (9) The temporary constructions in the leased lands must be under the instructions of the health department. As the festival is over, the traders themselves have to take off the temporary buildings and refusals including polythene should be disposed under the Public Health Inspector's instructions.
- (10) Only the vehicles having the licence for the Esala Perahera Festival are allowed to enter the festival premises. Accordingly, the following routes are not allowed for vehicles to take in.

- * Devala premises access road by Colombo Badulla road *via* Divisional Secretariat junction.
- * Devala premises access road *via* Thotapalla and Pokunegama.
- * Devala premises access road *via* Pirithwaththa, Galwaththa and Devala area.
- (11) Premitted vehicles that reach the devala premises can be parked at the school playgroung.
- (12) It is completely prohibited to photograph and video the "Diggeya" and upper floor of the devalaya without permission.

THE ESALA PERAHERA FESTIVAL OF UGGAL ALUTHNUWRA KATARAGAMA DEVALAYA - 2014

- (1) The Esala Perahera Festival of Uggal Aluthnuwara Kataragama Devalaya will be commenced on 4th October and terminated with the water-cutting ceremony on 9th October.
- (2) Uda Weediya, East quarter, Pirithwaththa, Galwaththa and Malukarawaththa which belong to the West quarter of Devalaya and Udahagedarawaththa which belong to the North quarter are reserved for dancers and pilgrims.
- (3) Preparing food is prohibited in areas of shrine terrace, Bodhi tree terrace, dagoba terrace, down floor, art institute cart, medawaththa and surrounding.
- (4) Notices will be published for making aware of the procedure of leasing of lands for trade in the festival premises.

- * Displaying and selling illegal goods in and outside the stalls are completely prohibited.
- * Stall keepers must put all the waste materials into litter bins in order to prevent dengue menace.
- (5) It is prohibited to sell flowers, incense things, candles and offerings at Upper floor, middle street, middle street access road and surrounding.
- (6) Permission should be obtained by the Basnayaka Nilame for the law pertaining to recreational activities. Taxes which have to be paid for the Pradeshiya Sabha must be afforded by the entertainer. If loudspeakers are used, permission must be received from the courts and with the advent of the procession, all the activities must be temporally paused and if needed, they can be continued after the end of the perahera.

- (11) Bursting of crackers and fire are prohibited.
- (12) Nobody can sell tickets, falgs or collect money for any purpose without getting the approval by an authorized officer of the Divisional Secretary.
