03. *Terms of Employment*
  - (i) This post is permanent and Pensionable and subject to 03 years of probation period.
  - (ii) The appointment shall be subject to the General conditions applicable to the appointments to the posts in Central Provincial Public Service and to the terms and conditions of the scheme of recruitment and Promotion of Central Provincial Analysts (Kandy Municipal Council) and any amendments hereinafter made thereto and provisions indicated in Establishments Code and Financial Regulations.

05. *General conditions*
  - (i) Shall be a citizen of Sri Lanka.
  - (ii) Shall possess a continues permanent residence for a period of not less than 03 years within Central Province by the closing date of application.
  - (iii) Shall be not less than 18 years and not more than 45 years of age on the closing date of applications (The maximum age limit shall not be applicable for the candidates who are already in Public or Provincial Public Service.).
06. *Educational and Professional Qualifications*
  - (i) A First Class or Second Class Honors Degree for Chemistry from a recognized University  
or
  - (ii) A member of the Royal Institute of Chemistry in Great Britain and Ireland  
or
  - (iii) Higher academic or professional qualifications in Chemistry

  - (b) The signature of the applicant should be attested by a Principal of a Government School, Justice of Peace, Commissioner of Oaths, an Attorney-at-Law, a Notary Public, Commissioned Officer of the Army, Navy or Air Force, *Gazetted* Officer of the Police, or an officer who holds a permanent post in Government or Provincial Public Service with an annual salary of Rs. 240,360/= or more.
  - (c) Applicants who are already in public service or in the Provincial Public Service should forward the applications through the Head of Department. If failed to do, their applications will be rejected.
  - (d) Applications not conform to specimen and incomplete will be rejected without any notice. No complain will be taken into consideration in relation to loosing an application in posting or being late.
