Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after three months from the date of publication.

All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* notices for publication in the weekly *Gazette* of 24th March, 2016 should reach Government Press on or before 12.00 noon on 11th March, 2016.

Notice under clause 2(2) of the Entertainment Tax Ordinance No. 12 of 1946

I, Chamara Sampath Dasanayake - the Honourable Chief Minister and the Minister Incharge of the Local Government subject of the Provincial Council of the Uva Province hereby announce that, as per the powers vested in me according to the provisions mentioned in the clause 2(2) of the Entertainment Tax Ordinance No. 12 of 1946 which should be read with the clause 2 of the Act No. 2 of the Provincial Councils (Sequential Provisions) Act No. 12 of 1989; I had approved the resolution mentioned in the Schedule 1, resolved on 01.12.2014 by the Municipal Council of Badulla, according to the Provisions of the clause No. 2 (1) of the Entertainment Tax Ordinance No. 12 of 1946 amended by (the amendment) Act of the Entertainment Tax No. 27 of 1984.

SCHEDULE I

The Resolution

A Tax will be levied and charged according to the amounts mentioned below for the payments for entering the said entertainment shows (meant as shown in the ordinance) conducted within the area of authority of the Municipal Council of Badulla under the sub clause (1) of the 2nd clause of the Entertainment Tax Ordinance Act (Authority 267), from the date this decision is published in the *Gazette*; in place of the payments of the tax imposed and charged, according to the decision published in the *Gazette* No. 14771 of 20th October 1967 and No. 105 of 29th March, 1979 for entering entertainment shows, conducted within the area of the administrative limits of the Municipal Council of Badulla.

It is also proposed to charge an entertainment tax of 7.5% of the entrance fee paid to watch a film within the area of authority of the Municipal Council of Badulla and an entertainment tax of 25% of the fare charged as entrance fee charged for other entertainment activities announced in the entertainment tax ordinance No. 12 of 1946 amended by (the amendment) entertainment tax act No. 27 of 1984.
