NOTIFICATION MADE UNDER STATE LAND REGUALTION No. 21 (2)

IT is hereby notified that for the purpose of Manufacture Detergent Powder Huper & Co (PVT) LTD has requested on lease a state land containing in extent about Hectare 0.4048 and 0.0023 Hectare out of extent marked lot No. 01 as depicted in the Tracing No. P. P. P. 4668 and situated in the village of Waikkala with belongs to the Grama Niladhari Division No. 480 A, Bolana coming within the area of authority of Wennappuwa Divisional Secretariat in the District of Puttalam.

02. Given below are the boundaries of the land requested.

On the North by : Owitiyawa owned by W. Michel Fernando and others and Bogahaowita owned by State ;
On the East by : Lot No. 1 in P. P. P. 4034;
On the South by : Lot No.2 in P.P.P. 3812 and Road (Pradheshiya Sabha) ;
On the West by : Lot No. 1 in P. P. P. 4034 .

The land requested can be given on lease for the necessary purpose. Therefore the Government has intended to lease out the land subject to other government approved conditions.

(a) *Terms of the lease* .- Thirty Years (30) (30.11.2016 onwards);

The annual rent of the lease .- 4% of the commercial value of the land as per valuation of the chief valuer for the year 2016. This amount of the lease must be quinquennially revised in such a manner that the amount as a result of the revision will be not morethan 50% of the amount that just preceded.

Premium .- Three times of the annual rent of the lease;

- (b) The lessee must within one year of the commencement of the lease, develop the said land in such a manner as to captivate the mind of the Divisional Secretary;
- (c) The lessee must not use this land for any purposes other than for the purpose of Manufacture Detergent Powder;
- (d) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretay/Scoping committee/ Board of Investment of Sri Lanka and by other institutions;
- (e) The buildings constructed must be maintained in a proper state of repair;
- (f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained action will be taken to terminate the lease;
- (g) No - sub leasing can be done until the expiry of a minimum period of 05 years from 03.11.2016 ;
- (h) Payment of the lease must be regularly made and if defaulted in payment, he agreement will ipso facto lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date which this notice is published in the *Gazette* to the effect that this land must not be given on lease the land will be leased out as requested.
