NOTIFICATION UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that Mr. P. Dimuthu Udaya Kumara has requested the state land in extent of 02 R. depicted in the tracing of F. V. P. 113 and situated in the village of Medawachchiya of No. 68, Medawachchiya West Grama Niladhari Division which belongs to Medawachchiya Divisional Secretary's division in the District of Anuradhapura of North Central Province, on lease for commercial purposes.

02. The boundaries of the land requested are given below :

On the North by: Land of Aysha baby ;
On the East by : Reservation of tank ;
On the South by: Land of Agarthan ;
On the West by : Land of Dimuthu Udayakumara.

03. The requested land can be granted lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions and the following conditions : -

(a) Term of the Lease.- Thirty (30) Years, (From 15.06.1995 onwards);

The Annual Amount of the Lease.– 4% of the commercial value of the land in the year 1995 as per the valuation of the Chief Valuer. This amount of the lease must be revised in every five years in such a manner that the amount as a result of the revision will not be less than 50 % of the amount that just preceded.

Premium .- Three times of the amount which is 4% of developed value of the land ;

- (b) The lessees must, within a perood of one year From the date of commencement of the lease, develop the said land, to the satisfaction of the Divisional Secretary;
- (c) The lessees must not use the said land for any purpose what so ever other than a Commercial Purpose ;
- (d) This lessee shall also be subject to the other special conditions imposed by the Divisional Secretary and other institutions;
- (e) Constructed buildings must be maintained in a proper state of repair.
- (f) If the lessee fails to substantiate the purpose for which the land was obtained within the specified period of time steps will be taken to cancel the agreement of lease;
- (g) No permission will be granted until expiry of minimum 05 years from the date of 16.02.2017 for any other subleasing or vesting other than vesting within the family or subleasing or vesting to substantiate the purpose of which the land was obtained;
- (*h*) Payment of the lease rental must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of herein *Gazette* publication to the effect that this land must not be given on lease, the land will be leased out as requested.
