Proposal

By virtue of the powers vested in Local Government Authorties by section Sub Section 1 of Section 2 of Entertainment Tax Ordinance Sooriyawewa Pradeshiya Sabha hereby proposes that in any entertainment purpose carried out within the area of Sooriyawewa Pradeshiya Sabha for the purposes of Entertainment Tax Ordinance (Chapter 267) an entertainment tax should be paid to Sooriyawewa Pradeshiya Sabha in following events.

- (*a*) In an event of a cinema show, a similar amount of Seven percent (7%) of the total amount which is collected from those who are admitted for that show; and
- (b) In any other entertainment event a similar amount of Twenty percent (20%) of the total amount which is collected from those who are admitted for that show.
