### NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the Agricultural purpose of Mr. Liyanage Asoka Pathmanaha Lelwala has requested on lease a State land containing in extent about 9.3344 Hectares out of extent marked Lot No.- as depicted in the Tracing No. - situated in the village of Mahagodagama with belongs to the Grama Niladhari Division of Mahagodagama coming within the area of authority of Buttala Divisional Secretariat in the District of Monaragala.

02. Given below are the boundaries of the land requested :

*On the North by:* Reservation for forest and Road ;

*On the East by :* Reservation for Forest ;

*On the South by:* Reservation for Forest ;

*On the West by :* Reservation for Forest.

03. The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions:-

(a) *Terms of the Lease.*- Thirty Years (30) , (from 15.12.2016 Onwards );

*The Annual Rent of the Lease.*- 4% of the undeveloped value of the land as per valuation of the Chief Valuer for the year 2016. This amount of the lease must be quinquennially revised in such a manner that amount as a result of the revision will be not less than 50% of the amount that just preceded.

*Premium .-* Treble of the annual of the lease ;

- (b) This lessee must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary ;
- (c) The lessee must not use this land for any purposes other than for the purpose of Agricultural activities;
- (d) This lessee must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary/Scoping Committee/Board of Investment of Sri Lanka and by other institutions;
- (e) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease ;
- (f) No sub - leasing can be done until the expiry of a minimum period of 05 years from 15.12.2016 ;
- (g) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date which this notice is published in the *Gazette* to the effect that this land must not be given on lease, the land will be leased out as requested.
