BY-LAWS RELATING TO PLAYGROUNDS

Warakapola Pradeshiya Sabha

- 1. The by-laws in this part are cited as the by laws relating to regularizing, control and supervision of public playgrounds within the area of authority of the Warakapola Pradeshiya Sabha.
- 2. Anybody who expects to obtain a licence to make use of any playground owned by the Warakapola Pradeshiya Sabha shall forward an application substantially prapared in accordance with the specimen given in the first schedule of the by-laws in this part.
- 3. Unless the following conditions have been fulfilled in issuing to licence to make use of any palygraound owned by the Warakapola Pradeshiya Sabha to anybody forwarding an application as stated in by-law No.2, the Chairman of the Warakapola Pradeshiya Sabha shall not issue a permit.
 - (*a*) All applications for issue of a permit to make use of the playgrounds shall be considered in the sequence in which they were received by the Warakapola Pradeshiya Sabha. However, high priority shall be given to any applications in respect of any matter relevant to any sport or sports from among the applications received for the use of playground.
 - (*b*) Unless a permit has been obtained after payment of fees set out in the Second Schedule for reservation of the playgrounds, nobody shall be entitled to make use of the paly ground.
 - (c) These fees shall be subject to revise by the Warakapola Pradeshiya Sabha from time to time and in addition to the fee, taxes imposed by the government from time to time shall be added and charged.
- 4. Forwarding of an application to reserve a playground for use shall be done at least three days before the expected day of such use.
- 5. In the event of any applicant needing the cancellation of the reservation of any playground after it had been reserved under the provisions of the by-laws in this part, the Chairman of the Warakapola Pradeshiya Sabha shall allow such cancellation, subject to the following conditions:
 - (a) When the application for cancellation of the reservation is forwarded,
 - (1) Three months prior to the date on which the playground was reserved, five percent of fees paid;
 - (2) Two months prior to the date on which the playgound was reserved, ten percent of the fees paid;
 - (3) One month prior to the date on which the playgound was reserved, fifteen percent of the fees paid;
 - (4) Fifteen days prior to the date on which the playgound was reserved, twenty five percnt of the fees paid;
 - (5) Seven days prior to the date on which the playgound was reserved, fifty percnt of the fees paid;
 - (6) Three days ptior to the date on which the playgound was reserved, seventy five percent of the fees paid.

shall be subject to with holding in the funds of the Warakapola Pradeshiya Sabha.

- (*b*) When the application for cancellation of the reservation is forwarded in a period of time less than three days to the date on which the playgound was reserved the fees paid shall not be refunded.
- (c) When any reservation has been cancelled the applicant shall have the right to get the money deposited for such reservation refunded fully.
- (d) A playgound reserved by any person shall not be used for any other purpose than that for which it was reserved.
- (e) A permit issued in respect of reserving a playground shall not be transferred on any gound to any other person.
 - 6. In the event of the necessity to get the date of reservation of any playground changed in the applicant shall forward a written request in this regard to the Chairman of the Pradeshiya Sabha. The amendment of the date reservation made according to such request shall be subject to provisions in by-laws No.3 and 4.
 - 7. On any occasion when any playground has not been reserved for any purpose according to the provisions of the by-laws in this part, it shall be the duty of the Chairman to allow such playground to be used for sports activities or training in sports.
 - 8. The Chairman of the Pradeshiya Sabha shall have the power to allow for making use of the playground without fees to any recognized political party, any kind of ceremony of public Institutes and a national ceremony under the conditions of a resolution adopted by a general meeting of the Pradeshiya Sabha.
 - 9. Fees shall be charged as set out in the third schedule on behalf of the extra period of time that the playground has been utilized.
- 10. While nobody shall damage or let anybody else damage a palyground owned by the Warakapola Pradeshiya Sabha, action shall not be taken to lead animals such as cattle into the playgound. Furthermore, action shall not be taken to enter any vehicle into any playground without obtaining permission from the Chairman.
- 11. In the event of any playground reserved under the provisions of the by-laws in this part being required for any essential matter of the Warakapola Pradeshiya Sabha, on the day of such reservation itself, the Chairman shall have the power to cancel such reservation. However, if such cancellation is effected the applicant shall be informed in writing about the cancellation three days prior to the date of such reservation of the playground and the fees paid by him and the deposit money shall be refunded fully. Furthermore, such cancellation shall not be effected less than three days prior to the date of reservation.
- 12. Violation or noncompliance of any section of these by -laws shall be an offence and any person who violates any section in these by laws shall be guilty of an offence and on being convicted by a court of proper jurisdiction shall be liable to a fine set out in the Section 122(2) of the Pradeshiya Sabha Act, No.15 of 1987 and in case of continuing the violation by any person even after being convicted by a court and being notified in writing by the Chairman or Secretary of the Pradeshiya Sabha or any other Officer authorized by the Chairman considering the violation, such person shall be liable to an extra fine set out in the Section 122(2) of the Pradeshiya Sabha Act, No.15 of 1987 for each day of violation.
- 13. In the event of any inconsistency between texts of by-laws in this part, the Sinhala text shall prevail.
- 14. For the purposes of these by-laws,

the term "Pradeshiya Sabha" means Warakapola Pradeshiya Sabha, the term "Chairman" means the Chairman of the Warakapola Pradeshiya Sabha, the term "Secretary" means the Secretary of the Warakapola Pradeshiya Sabha,

the term "Authorized Officers" means any Officer of the Warakapola Pradeshiya Sabha, authorized by the Chairman of the Warakapola Pradeshiya Sabha.

15. In this part, unless the context otherwise requires -"playground" means any playground allocated by the Pradeshiya Sabha for the purpose of sports and it shall include the wall or fence erected around the playground or any building constructed within the Playground or any section of such construction or any fittings or instruments.

"Sports" shall have the same interpretation contained in the Sports Law, No. 25 of 1973.
