Central Provincial Public Service Commission shall conduct a competitive examination and the candidates obtaining highest marks will be subjected to an interview for selection of suitable candidates. No marks will be assigned at the interview. Recruitment will be made under the merit of marks obtained in the examination by the candidates. A minimum of 40% marks should be obtained for each question paper.
06. *Conditions of recruitment :*
- 6.1. This post is permanent and pensionable.
 - 6.2. Appointment is subject to the provisions in the public P.A. circular 01/2014 issued on Implementation of Official Language Policy.
 - 6.3. Should serve minimum of 05 years within Central Province once you call upon appointment, not eligible to get transfer and should have serve Minimum of 03 years in the institution of your first appointment.

01. Intelligence Test – (Time 01 hour, Total marks - 100)
This paper consists of objective questions to assess the candidate's, power of logical reasoning and analysis and ability to draw sound inferences.
 02. Technological question paper (Time 03 hours, Total marks - 100)
Consists of multiple Choice Questions and Structural Questions applicable to the post
 - a) For the post of Technological Service (Civil) Grade III/ Training Grade to Central Provincial Public Service.

This paper is designed for candidates applied for civil posts consists of questions to test the level of technological knowledge, a civil officer should possess in the field of Building Construction & maintenance, Road construction & Maintenance, and Water Supply & Drainage.

- (b) For the post of Technological Service (Mechanical) Grade III to Central Provincial Public Service
This paper is designed for candidates applied for Mechanical posts consists of questions to test the level of technological knowledge, a Mechanical officer should possess.
- (c) For the post of Technological Service (Electrical) Grade III to Central Provincial Public Service
This paper is designed for candidates applied for Electrical posts consists of questions to test the level of technological knowledge, an Electrical officer should possess.
- (d) For the post of Technological Service (Draughtsman) Grade III to Central Provincial Public Service
This paper is designed for candidates applied for Draughtsman posts consists of questions to test the level of technological knowledge, a Draughtsman should possess.
