### NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified National Suwa Shanthi Foundation has requested on lease a State land containing in extent about Hectare 0.809 out of extent marked Lot No. 420 as depicted in the Tracing No. F. V. P. 1981 and situated in the Village of Wilava with belongs to the Grama Niladhari Division of No. 197, Wilava coming within the area of authority of Mahawa Divisional Secretariat in the District of Kurunegala.

02. Given below are the boundaries of the land requested :

*On the North by:* Lot Nos. 417 and 419 ;

*On the East by :* Lot Nos. 419 and 421 ;

03. The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions : -

(a) *Terms of the Lease.*- Thirty (30) Years, (09.04.2015 On wards).

*The Annual Rent of the Lease.*- 2% of the undeveloped value of the land as per valuation of the Chief Valuer for the year of 2015.

(b) The lessee must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary ;

- (c) The lessee must not use this land for any purposes other than for the purpose of Society ;
- (d) Divisional Secretary/Scoping committee/Board of Investment of Sri Lanka and by other Institutions;
- (e) The buildings constructed must be maintained in a proper state of repair ;
- (f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease ;
- (g) No sub - leasing can be done until the expiry of a minimum period of 05 years from 09.04.2015;
- (h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date herein below to the effect that this land must not be given on lease, the land will be leased out as requested.
