## SRI LANKA RAILWAYS

### **Request for expressions of Interest for Investigation, preliminary design & preparation of BOQ, Cost estimate and bidding document for construction of Railway double Line from Polgahawela to Kurunegala**

THE Sri Lanka Railways intends to prepare the bidding document for construction of double line from Polgahawela to Kurunegala which will be approximately 22 kilometres in length. The proposed double line is travelling along with existing Polgahawela - Kurunegala Railway line. There are one crossing station and three substation in between Polgahawela and Kurunegala main stations. 08 Nos. bridges and 79 Nos. culverts are to be constructed parallel to existing bridges and culverts. There are 19 Nos. Level crossing protection systems are to be provided for all level Crossings. The Consultant should provide the Investigation & preliminary design details, BOQ, cost estimate and the bidding document to the Sri Lanka Railways.

Double tracking from Polgahawela to Kurunegala will help to enhance traffic handling capacity of Northern & Eastern lines. Effective Railway lines would encourage road users to actively use railway; which is expected to see an overall reduction in fuel usage, less emission of toxic gases polluting the environment, saving of time from traffic jams, noise pollution etc.

The ministry Consultancy Procurement Committee, Ministry of Transport & Civil Aviation intends to invite Expressions of Interest (EOIs) from eligible consultants (firms) that are willing to undertake this assignment.
