### NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the purpose of Commercial, Thaprobhan Pavilion Hotel has requested on lease a State land containing in extent about 0.0073 Ha. out of extent marked Lot No. 02 and tracing done to depicted a in the Plan No. GA/HBR/2017/488 situated in the Village of Unawaduna which belongs to the Grama Niladhari Division of No. 137 B, Yaththekimulla coming within the area of authority of Habarathuva Divisional Secretariat in the District of Galle.

02. Given below are the boundaries of the land requested :

*On the North by* : Godagena Opening Waste land (State);

*On the East by* : Lot No. 01 in this depict ;

*On the South by*: Lot Nos. 01 & 03 in this depict ;

*On the West by* : Lot No. 03 in this depict.

The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions :-

(a) *Term of the Lease.*- Thirty (30) Years , ( From 16.10.2018 Years Onwards ).

*The Annual Rent of the Lease.*- 2% of the prevailing market value of the land on occasions when the assessed value of the land as per the valuation of the Chief Valuer for that year is lower than rupees five million (Rs. 5,000,000) assessed value for the year 2018 4% of the prevailing market value of the land on occasion when the assessed value of as per the valuation of the Chief Valuer for that year is higher than rupees five million (Rs. 5,000,000) assessed value for the Year 2018, this amount of the lease must be quinquennially revised in such a manner that 20% should be added to the final annual rental of the preceding 5 years;

(b) The lessees shall not utilize this land for any other activities except for the operation of Thaprobhan Pavilion Hotel ;

(c) Prior to the disposal of the long term lease hold, the consent from the Director General of the Wild Life Conservation Department shall be obtained, If any development activity is to be taken place in this land, the Prior permission shall be obtained from

the Department of Coast Conservation and Coastal Resource Management under the Coast Conservation and Coastal Resource Management Act, No. 57 of 1981;

(d) An Environment Protection License shall be obtained from the Central Environment Authority and relevant hotel in this land shall be maintained subject to the condition thereof;

(e) The lessees must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary ;

(f) The lessee must not use this land for any purpose other than the purpose of Commercial ;

(g) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary/Scoping Committee/Board of Investment of Sri Lanka and by other institutions;

(h) The buildings constructed must be maintained in a proper state of repair;

(i) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease ;

(j) No sub-leasing can be done until the expiry of a minimum period of 05 years from 16.10.2018 ;

(k) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date herein below to the effect that this land must not be given on lease, the land will be leased out as requested.
