#### NOTIFICATION UNDER STATE LAND REGULATION No. 21 (2)

It is hereby noticed that for the construction of buildings for a Girls' Remand Home and industrial training center for poor girls and officer's quarters, the Salvation Army has requested on second period of long lease, state land containing in extent about 02 acres and 06 perches (A.02 R.00 P.06) marked as Lot 01, as depicted in Plan No. PPYA 264 (L.2789) in the village of Kaitadi in the Kaitadi Grama Niladhari Division in the Tenmaradchi Divisional Secretariat Division in the District of Jaffna.

The boundaries of the land requested are given below.

*On the North by* : Lot No. 465 – PP 39; *On the East by* : Lot No. 25 PPS 2008;

On the South by : Kandy Road; On the West by : Lot No. 465 PP 39.

- 03. The requested land can be granted lease for the necessary purpose. Therefore, the government has intended to lease out the land subject to other government approved conditions and the following conditions.
- (a) Term of Second lease: Thirty (30) years (from 2002.06.01 onwards)

Annual amount of the lease: 0.5% of the currently prevailing undeveloped value of the land as per valuation of the chief valuer for the year 2002.

Premium: -

(b) The lessees must, within a period of one year the date of commencement of the lease, develop the said land to the satisfaction of the Divisional Secretary.

- (c) The lessees must not use the said land for any purpose what so ever other than a purpose of constructing a girls remand home industrial training center and officer's quarters.
- (d) This lease shall also be subject to other special conditions imposed by the Divisional Secretary/ Scopin Committee/BOI of Sri Lanka and other institutes.
- (e) The buildings Constructed and Constructed must be maintained in a proper state of repair.
- (f) If the lessee fails to substantiate the purpose for which the land was obtained within the specified period of time, steps will be taken to cancel the agreement of lease.
- (g) Payment of the lease rental must be regularly made and if defaulted in payment, the agreement will ipso facto lapse.

If acceptable reasons are not submitted to me in writing within 06 weeks of herein Gazette publication to the effect that this land must not be given on lease, the land shall be leased out as requested.
