NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the purpose of Jamiul Hilal Jumma Masjith Trustee Board has requested on lease a state land containing in extent about 0.408 Hec. out of extent marked lot No. 277 as depicted in the plan No. F.C.P. 114 and situated in the Village of Al-Hilalpurra which belongs to the Grama Niladhari Division of No. 133 - Al - Hilalpurra coming within the area of authority of Lankapura Divisional Secretariat in the District of Polonnaruwa.

02. Given below are the boundaries of the land requested:

On the North by : lot No. 156,
On the East by : lot No. 278,
On the South by : lot No. 210,
On the West by : lot No. 161.

03. The land requested can be given on lease for the necessary purpose. Therefore, the government has intended to lease out the land subject to other government approved conditions and the following conditions.

- (a) *Terms of the lease* : Thirty (30) years (from 28.03.2018 onwards)
- (b) The annual amount of the lease : 1/2% of the undeveloped value of the land as per valuation of the Chief Valuer for the year 2018.
- (c) The land should be used only for religious activities.
- (d) The lessee must, within the one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary.

- (e) The lessee must not use this land for any purposes other than for the purpose of Religious activities.
- (f) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary, and by other Institutions.
- (g) The buildings constructed must be maintained in a proper state for repair.
- (h) Once the land is given on lease and in the event of failure on the part of lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease.
- (i) No sub-leasing can be done until the expiry of a minimum period of 05 years from 28.03.2018.
- (j) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto lapse*.

If acceptable reasons are not submitted to me in writing within six weeks of the date herein below to the effect that this land must not be given on lease, the land will be leased out as requested.
