All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 19th October 2018 should reach Government Press on or before 12.00 noon on 5th October 2018.

AN ACT TO AMEND THE SRI LANKA INSTITUTE OF TAXATION (INCORPORATION) ACT No. 21 OF 2000

I, S. M. Marikkar do hereby give notice, under Standing Order No. 53(1) of the Standing Orders of the Parliament of the Democratic Socialist Republic of Sri Lanka, that I propose to introduce in Parliament a Bill entitled "An Act to Amend the Sri Lanka Institute of Taxation (Incorporation) Act No. 21 of 2000.

The aim of the Bill to change its name to "The Chartered Institute of Taxation of Sri Lanka" with the following general objects :-

1. To provide for a professional organization for persons providing advice on the law and practice of taxation.
2. To Prescribe and conduct or approve courses of study for the membership or for persons seeking to qualify for membership and for grant of the required professional qualifications.
