### Resolution

By virtue of powers vested in me under Sub Section 3 of Section 9 of Pradeshiya Sabha Act, No. 15 of 1987 to be read with Sub section (1) of Section 2 of Entertainment Ordinance (Chapter 267), I, J. M. ## Examinations, Results of Examinations, &c.

### RECRUITMENT OF GRADUATES FOR EXISTING VACANCIES IN SCHOOLS THAT ARE UNDER THE WESTERN PROVINCIAL MINISTRY OF EDUCATION-2019

THE notification published on the *Gazette* No. 2,114 dated 08<sup>th</sup>March 2019 is revised as follows :

#### 01. Eligibility :

The section, Candidates who have fulfilled the below mentioned qualifications by 08.04.2019 should direct applications so as to be received by on or before that date” is revised as “Candidates who have fulfilled the below mentioned qualifications should direct applications so as to be reached by 18.04.2019 or before that date”.

#### 1.1 Qualifications

The Section, Should have obtained a degree from a university recognized by the University Grants Commission in subject areas of following fields which are specifically recognized with relevance to the teaching appointments as per VII below is revised as “Should have obtained a degree from a university recognized by the University Grants commission in subject areas of following fields which are specifically recognized with relevance to the teaching appointments as per VI below”.

- 2:1 The Section , Graduates who have fulfilled the required qualifications by 08.04.2019 can apply for the vacancies existing in provincial schools” is revised as “Graduates who have fulfilled the required qualifications by 18.04.2019 can apply for the vacancies existing in provincial schools”.
- 2:2 The Section , Recruitment will be made as per Section 7.2.4 of the Western Provincial New Teacher Service Minute which is effective from 01.01.2011 is revised as “Recruitment will be made as per Section 7.2.4 of the Western Provincial Teacher Service Minute which is effective from 01.07.2008” .
- 2:3 The Section, A competitive examination and a practical test will be conducted and recruitment for the vacancies will be done according to the order of marks obtained. (Duration of recruitment on examination results is relevant only for existing vacancies as at 31.12.2020) is revised as follows.

Syllabus of the written examination :

#### **Subject number 01 – Aptitude test**

This paper is designed for the purpose of measuring the skills of the candidate for the teacher profession and logical intelligence. This consists of 50 multiple choice and short answer questions. Short answers should be provided for all those questions.

#### **Subject number 01 – General knowledge**

This paper consists of multiple choice and short answer questions to test the general knowledge of the candidate of the general knowledge with relevance to the teaching field and/or the general knowledge on local educational trends and general knowledge of educational modification.

A competitive examination and a practical test will be conducted and recruitment for the vacancies will be done according to the priority order of marks obtained. (Duration of recruitment on examination results is relevant only for existing vacancies as at 31.12.2020)

1. As the practical test, a presentation should be done under a topic identified by the applicant.

Method of the practical test:

For the practical test – Not less than 5 minutes.

01. *Method of Practical Test :*

- i. A time not less than 5 minutes will be given for practical test.
- ii. Maximum marks that can be obtained for practical test is 25.
- iii. At least 2 marks should be obtained for each criteria to pass the practical test.

03. *Purpose of Criteria*

- i. Purpose and entry  
Assessment of the ability to successfully explain the purpose and to enter to the lesson.
- ii. Personality and voice control  
Assessment of the ability to control voice as a teacher.
- iii. Clearness of communication  
Assessment of the ability to communicate effectively in the learning-teaching process.
- iv. Time management  
Assessment of the ability to reach a purpose with in the given time.
- v. Use of presentation techniques  
Assessment of the ability to use techniques to reach the purpose.

03. *Method of applying*
