NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the Commercial purpose of Agriculture, North and East Economic Development Center has requested on lease a State Land containing in extent about Acre 20 (8.09373 Ha.) out of extent marked Lot No. A and situated in the village of Thennamarawadi with belongs to the Thennamarawadi Division of coming within the area of authority of Kuchchaveli Divisional Secretariat in the District of Trincomalee.

02. Given below are the boundaries of the land requested :
On the North by : Thennamarawadi State Scrab Jungal;
On the East by : Path ;
On the South by: Thennamarawadi State Scrab Jungal;
On the West by : Thennamarawadi State Scrab Jungal.

The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions.

(a) *Term of the Lease.*— Thirty Year (30) (15.02.2019 Onwards);

The Annual Rent of the Lease.— In the instances where the assessed value of the land in the year is less than five million rupees (Rs. 5,000,000) 2% of the Unimproved value of the land in the said year, as per the valuation of the chief valuer. In the instances where the assessed value of the land in the effective year of the lease in the more than five million rupees (Rs. 5,000,000), 4% of the Unimproved value of the land in the said year, as a per valuation of the chef valuer. The amount of the lease must be revised in the every five years and the revision shall add 20% to the amount that just preceded.

Premium :- Not levied

(b) The lessee must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary.

(c) This lessee must not use this land for any purpose other than for the purpose of Agricultural Activities;

(d) The lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary/Scoping committee/Board of Investment of Sri Lanka and by other Institutions;

(e) The buildings constructed must be maintained in a proper state of repair ;

(f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease ;

(g) No sub - leasing or can be done until the expiry of a minimum period of 05 years, For 05.07.2017 ;

(h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date which this Notice is published in the *Gazette* to the effect that this land must not be given on lease, the land will be leased out as requested.
