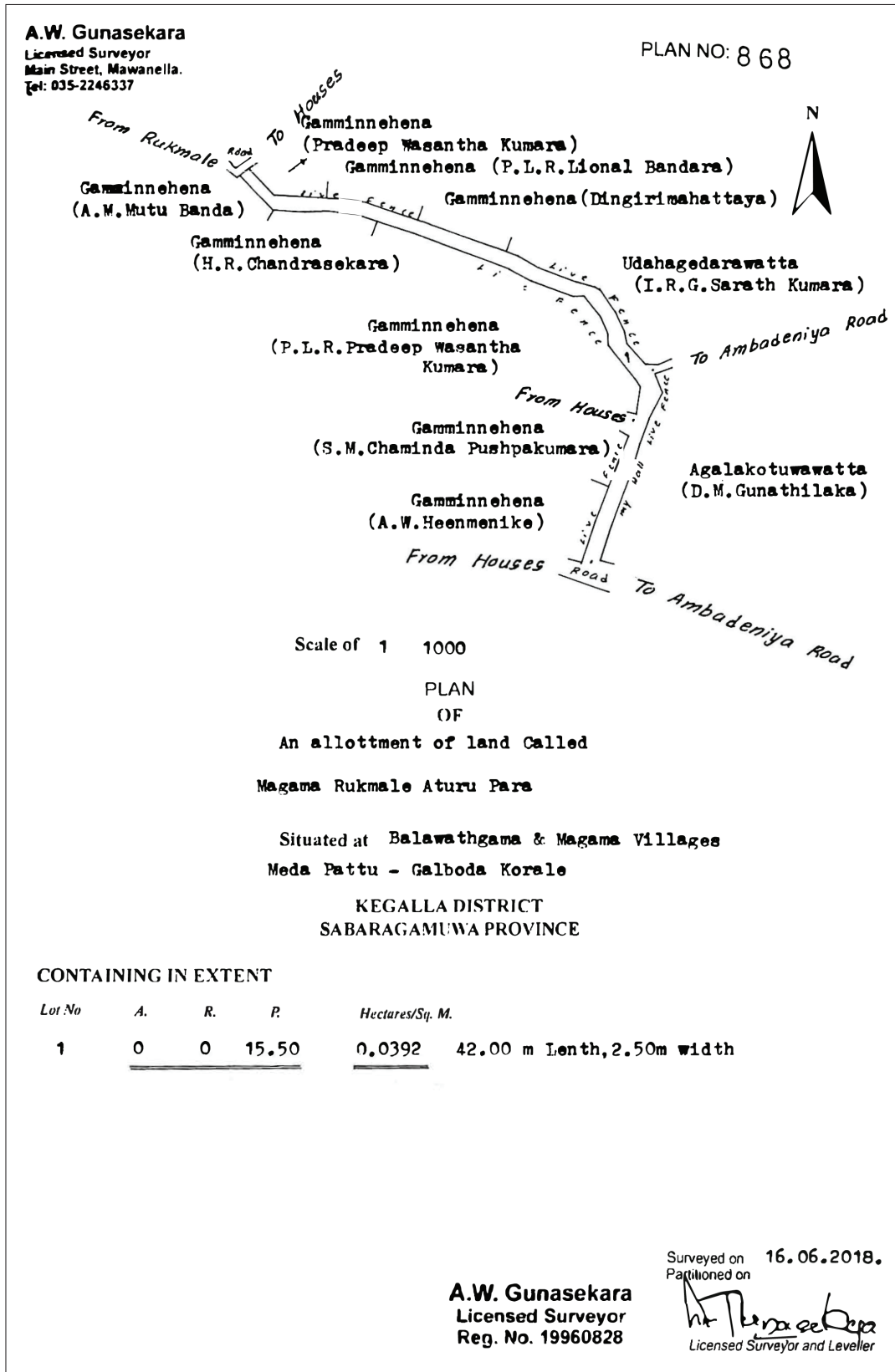

Digging a pit on the concret road - Rs. 2,000.00. Across the concret road - per foot at the rate of Rs. 50.00. Digging a pit on tarred road - Rs. 1,500.00. Across tarred road - Rs. 5,000.00. Digging soiled road - Rs. 500.00. Across soiled road - Rs. 1,500.00 is hereby proposed to be charged.

The above should be amended as :

- Rs. 500.00 will be charged on supplies without water meters.
- Rs. 500.00 will be charged as a service charged on road damages for laying pipe lines.

#### Laying pipe lines under mentioned roads :

I do hereby propose to charge for digging a pit on the concret roads Rs. 2,000.00. Rs. 3,000.00 will be charged for damaging across 8 feet width concrete road, Rs. 5,000.00 for 10 feet width roads, Rs. 8,000.00 for 12 feet width roads and Rs. 50.00 will be charged for every feet exceeding it and Rs. 1,500.00 for digging a pit on tarred road, Rs. 5,000.00 digging across tarred roads, Rs. 500.00 for digging a pit on soiled road and Rs. 1,500.00 will be charged for damaging across soiled roads.
