RECRUITMENT TO THE POSTS OF TECHNOLOGICAL SERVICE TO CENTRAL PROVINCIAL PUBLIC SERVICE - 2019

APPLICATIONS are called from both male and female candidates who are residing within Central Province and possess required qualifications specified in this notification to fill the vacancies in Grade III of Agriculture Instructor, Grade III of Livestock Development Instructor, and Grade III of Colonization Officer of Technological Service of Central Provincial Public Service.

01. General conditions :

- 1.1 Shall be a citizen of Sri Lanka;
- 1.2 Shall possess a continues permanent residence for a period of not less than 03 years within Central Province immediately preceding closing date (04.10.2019) of applications. (applicant having married a person holding more than 03 years of permanent residence within Central Province will be considered for the recruitment);
- 1.3 Shall be not less than 18 years and not more than 30 years of age on the closing date (04.10.2019) of applications (the maximum age limit is inapplicable to those already in Central Provincial Public Service);
- 1.4 Shall be of excellent character;
- 1.5 Should possess the adequate physical and mental fitness required to serve in any area of Central Province and discharge duties of the post .

Salary will be paid by placing as per provisions indicated in Schedule II of the Public Administration Circular No. 03 /2106.

04. **Terms of Engagement :**

Terms of Engagement determined by the relevant scheme of recruitment approved by the Central Provincial Public Service Commission.

05. **Mode of recruitment :**

Vacancies shall be filled on district population ratio as per P.A. Circular 15/90. Central Provincial Public Service Commission shall conduct a competitive examination and the candidates obtaining highest marks will be subjected to an interview for selection of suitable candidates. Candidates obtained less than 40% marks for each subject are not eligible for recruitment. No marks will be assigned at the interview. Recruitment will be made under the merit of marks obtained in the examination by the candidates. A minimum of 40% marks should be obtained for each question paper.

06. **Conditions of recruitment :**

- 6.1. This post is permanent and pensionable. You shall be subjected to a policy decision taken by the government in future in respect of the pension scheme entitled to you.
- 6.2. Appointment is subject to the provisions in the public P.A. circular 01/2014 issued on Implementation of Official Language Policy
- 6.3. Should serve minimum of 05 years within Central Province once you call upon appointment, not eligible to get transfer and should have serve Minimum of 03 years in the institution of your first appointment.

07. **Examination procedure :**

- (a) Examination will be held Sinhala, Tamil and English medium. It is not allowed to change the medium of language applied by the candidate subsequently.
- (b) Candidates should answer all question papers at the examination in one and the same language.
- (c) Candidates shall be bound by the rules and regulations imposed by the Central Provincial Public Service Commission on conducting the examination and issuing examination result.

09. Penalty for furnishing false information:

If a candidate is found to be ineligible, his candidature is liable to be cancelled at any stage prior to, during, or after the examination. If any of the particulars furnished by a candidate is found to be false within his/her knowledge or if he/she has willfully suppressed any material fact, he/she will be liable to dismissal from the Public Service.

10. Examination Fees:

A non-refundable examination fee of Rs. 600 should be credited to the Central Provincial Chief Secretary's Revenue Head 20-03-02-13. This fee could be paid to any Divisional Secretary office in Central Province and the receipt (Blue Colour) issued should be firmly affixed to the application. The application without a receipt will be rejected. The paid examination fee will not be refunded under any circumstances. (It is advisable to keep a photocopy of the receipt with the candidate for future reference).

11. **Method of application**

(a) Applications should be prepared in the following manner using papers of size A4 (21 X 29 cm) :-

- (i) Cages from 01 to 03 should appear on the first side of the page ;
- (ii) Cages from 04 onwards should appear on the other pages ;
- (iii) If an applicant applies for more than one post, should send separate applications for each post.
- (iv) Applications not conform to specimen and incomplete will be rejected without any notice. Applications of those who have not paid examination fee on or before due date will also be rejected. Candidates should be responsible for any loss incurred by them due to incomplete applications. It would be advisable to keep a photocopy of the completed application form and it is the responsibility of the candidate to make sure that the application is conform to the specimen given in the examination notice. Otherwise, the application could be rejected. The title of the examination appearing in the specimen should be indicated in English language as well, on both Sinhala and Tamil application forms.

(c) The completed application form for the examination should be sent by Registered Post to reach below mentioned address on or before 04th October, 2019.

The words “Recruitment to the posts of Technological Service to Central Provincial Public Service - 2019” should be clearly indicated on the top left-hand corner of the envelope enclosing the application. Any application received after the closing date will not be accepted.

(d) It is compulsory for the officers who are already in public service/ Provincial Public Service to submit the application certified by the Head of the Department under the Section 13.0 of the application.

12. Central Provincial Public Service Commission will notify about the Examination Centre in the admission card. A notice will be published in the newspaper by the Central Provincial Public Service Commission as soon as admission cards are issued to applicants. If the admission card is not received even after 2 or 3 days of such an advertisement, step shall be taken to notify the Secretary to Central Provincial Public Service Commission in the manner specified in the advertisement. It would be advisable to fax the certified copies of the application form and the receipt kept at your possession, receipt of registration and a letter of request furnishing a fax number to which the admission card should be sent.

13. Candidates shall get their signature on the admission card attested in advance and surrender to the supervisor of the examination hall on the date of examination. Candidates shall not be allowed to sit the examination without such admission card.

14. The signature of the applicant should be attested by a Principal of a Government School, Justice of the peace, Commissioner of Oaths, Notary Public, Attorney-at-Law or a Staff Grade officer in the Public or Provincial Public Service drawing an annual salary of Rs.240,360 or above.

15. The issuing of an admission card to a candidate does not necessarily mean that he/she has the required qualifications to sit the examination or to appoint to the post.

16. Candidates should furnish one of the following documents to the Supervisor of Examination in support of their identity.

- (i) The National Identity Card issued by the Department of Registration of Persons.
- (ii) A valid Passport

17. The Central Provincial Public Service Commission will make the final decision of any matter not covered by these regulations and decision on filling the vacancies, leave them vacant or filling a portion of vacancies.
18. In the event of any inconsistency between the Sinhala, Tamil and English text of this notification, the Sinhala text shall prevail as the accurate text.
