4.3 *Limited Recruitment* :

4.3.1. *Educational Qualifications* : Should have passed minimum 06 subjects in not more than two sittings in the General Certificate of Education Ordinary Level Examination with 02 Credit passes and passed 05 subjects in one and same sitting.

4.3.2. *Professional Qualifications* : Possession of a Driving License, issued by the Commissioner General of Motor Traffic for drive motor vehicles / jeeps / vans and possession of an efficiency certificate issued by the Commissioner General of Motor Vehicles to drive private / hiring vehicles and station wagons with less than tare weight 24 cwt. (Should possess “C” class driving license and “C1” driving license or “B” class new driving license issued by the Commissioner General of Motor Traffic prior to 03 years of recruitment)

Possession of a driving license issued by the Commissioner General of the Motor Traffic to drive lorry / tractor in the related group of motor vehicles. Should possess a transport bus driving license exceeding 34 cwt. tare weight and carrying not exceeding 32 passengers. (Should possess “A” class driving license issued before 11.03.2009 or “D” class new driving license issued by the Commissioner General of Motor Traffic prior to 03 years of recruitment)

5. *Terms of Employment :*

- (i) These posts are permanent and pensionable. Should abide to the policy decisions making the Government in future relating to the Pension Scheme.
- (ii) Contribution should be made to Widow's / Widower's and Orphan's Pension Scheme.
- (iii) These appointments will be subjected to a period of probation for 03 years. If the service found unsatisfactory within the probation period of service, the appointment will be terminated without making the appointment permanent.
