APPROVING OF QUALIFIED GARAGES FOR THE ISSUANCE OF FITNESS CERTIFICATES YEAR 2021

APPLICATIONS will be received from owners of Garages who have been registered as a business and having evidence of making relevant tax payments and from the Sri Lanka Transport Board Depots, to entrust the issuance of fitness certificates to commercial vehicles registered within the Central Province, for the year 2021, Granting of such approval will only be considered for garages situated within the Central Province.

1 Applications should have fulfilled the following qualifications :

i. Facilities

- a. Should contain either an inspection pit of 20 feet long 2 1/2 feet wide and 4 1/2 feet high in size or an inspection platform or a hoist with equal facilities
- b. Brake testing equipment
- c. Head lamps testing equipment
- d. Mechanical tools such as screw drivers, spanners, hammers etc, required for checking of under carriage, steering wheel functions, brake cables, etc and rusted parts.

ii. Staff

Persons having the following qualifications should be employed in the garage as certifying officer

- a. Specially mastered the auto engineering subject or National Technical Diploma on motor mechanism or obtained Junior Technical officer certificate with 05 years experience in the auto engineering field
- b. Followed and passed the four year course on motor mechanism at the Ceylon German Technical Training Institute (CGTTI) or any other equivalent qualifications along with 08 years experience in the Auto engineering field.

2. Following documents should be submitted with the applications.

- a. Certified copies of the relevant qualification certificates of the certifying officers
- b. A bank receipt received on crediting of a non refundable fee of Rs. **1,000/-** to the **A/C No.33965** of the Commissioner of Transport, Central Province.
- c. A sketched map depicting the specific situation of the garage for easy reaching by the inspection officer and the access road reachable from the town centre (summary of the road map)
