1. Corporate Information

1.1 Domicile and Legal Form

The University of Jaffna, Sri Lanka is a statutory body incorporated under the Universities Act, No. 16 of 1978 and it is located at Thirunelvely, Jaffna.

1.2 Principal activities and nature of operations

The principal activities of the University of Jaffna are promotion of teaching, learning and research activities in keeping with the National Policy by providing higher learning facilities for students.

1.3 Vavuniya Campus

The Northern Province Affiliated University College was amalgamated with University of Jaffna with effect from 01.04.1997 by *Gazette* notification number 968/6 of 26.03.1997 as a Campus of this University. The Financial Management of the Vavuniya Campus is under the purview of the University of Jaffna. Monthly imprest is released for Recurrent and Capital Expenditure by the University of Jaffna. Reasonable extent of Financial Powers has been delegated to the Vavuniya Campus. Which is manage by campus board headed by Rector. The financial transactions of the Vavuniya Campus are incorporated in the accounts of the University of Jaffna.

2. Accounting Policies

2.1 Basic of Preparations

The Financial Statements of the University of Jaffna, Sri Lanka are prepared in conformity with the Sri Lanka Public Sector Accounting Standards and are applied consistently on a historical cost basis. Subject to the fixed assets being bought into books on revaluation with computerizing fixed assets register. The Financial Statements for the year ended 31st December 2018 are presented in the formats that were introduced by the Department of Public Enterprises, General Treasury by Public Enterprises Circular No. PED/19 of 19.12.2003 adopted by the University Grants Commission by Finance Circular No. 2/2004 of 23.01.2004, Public Enterprises Circular No. PED/54 dated 19.01.2010 adopted by UGC Financial Circular No.3/2011 dated 1st March 2011 and Public Enterprises Circular No. 03/2013 dated 02.10.2013 adopted by the University Grants Commission by its Finance Circular letter No. 03/2014 with suitable modifications where necessary.

2.2 Accounting for Student Fees

The Student Registration Fees, Tuition Fees and Medical Fees are accounted on cash basis and other Incomes are on accrual basis and this is the practice adopted by the University from the inception.

2.3 Grant for Bursary and Mahapola

The Grant for Bursary is shown as income under the Recurrent Grant and the payment of Bursary is shown as Expenditure of the Welfare Services under 4.3.7.1705 as directed by the University Grants Commission by its letter No. UGC/F/BUR/87 dated 14.10.1987 and classified as a separate item as Financial Assistance to students in the statement of Financial Performance. The Grant for Mahapola (Treasury Component and Trust Component) is shown under Recurrent Grant and the payment is under Financial Assistance to students in the statement of Financial Performance.

2.4 Provision for Gratuity

Provision for Gratuity is made in terms of payment of Gratuity Act, No. 12 of 1983. The Provision for Gratuity is not represented by the investment since the Treasury does not provide financial allocation to make investment externally.

2.5 Depreciation and Provision for Gratuity

The net deficit for the year 2018 is Rs.717,788,058/= this includes the non-cash item of Depreciation and amortization amounting of Rs.678,704,056/=. Therefore the actual cash deficit is 39,084,001/=

2.6 Inventories

Inventories are valued at cost based on FIFO basis and the value of stock held by the Academic/Administrative Departments has been excluded from the Expenditure.

2.7 Expenditure of Capital Nature

Expenditure incurred for the purpose of extending or improving assets of the permanent nature of this University is treated as Capital Expenditure.

2.8 Write off and Losses

The following were written off with the approval of the Council in the year 2018 and reflected in accounts as unused item.

The loss of Books has been shown in the Loss on suspense - Books A/C. Legal action is being taken and the loss amount of Rs. 1,301,370.00 is expected to be recovered.

2.9 Fund from University Development Fund

Additional Fund of Rs. 90 Million for recurrent expenditure met out of University Development Fund.

2.10 Income and Expenditure from other activities

The Income and Expenditure of Self Financing courses have been shown on cash basis. The net Income from other activities has been shown in the statement of Financial Performance and the balances have been added to the opening balance of the respective activities and shown under current liabilities as seen financing courses.

2.11 Excess of Expenditure over Income

The Excess of Expenditure over Income is Rs. 717,788,058 occurred due to the inclusion of the following non cash items.

As per the approval of the Council. All assets categories other than Books & Periodical, depreciation and provision for depreciation as at 31.12.2018 had been adjusted based on verification and revaluation on assets made by M/S Carter De Costa Corporate Services (Pvt) Ltd who was assigned with preparation of Fixed Assets Register. Verification and revaluation of the Assets at 31.12.2014 and additions during the year 2015,2016 and 2017 and 2018 had been taken into accounts.

2.15 Depreciation

Depreciation is provided at the following rates as per the University Grants Commission Circular No. 649 of 05/10/95. No depreciation is charged for land.

Report of the Auditor General on the Financial Statements and Other Legal and Regulatory Requirements of the University of Jaffna for the year ended 31st December, 2018 in terms of Section 12 of the National Audit Act, No. 19 of 2018

1. Financial Statements

1.1 Qualified Opinion

The audit of the financial statements of the University of Jaffna ("University") for the year ended 31st December, 2018 comprising the statement of financial position as at 31st December, 2018 and the statement of financial performance, statement of changes in equity and cash flow statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, was carried out under my direction in pursuance of provisions in Article 154 (1) of the Constitution of the Democraic Socialist Republic of Sri Lanka read in conjunction with provisions of the National Audit Act, No. 19 of 2018 and Finance Act, No. 38 of 1971. My report to Parliament in pursuance of provisions in Article 154 (6) of the Constitution will be tabled in due course.

In my opinion, except for the effects of the matters described in the basis for Qualified Opinion section of my report, the accompanying financial statements give a true and fair view of the financial position of the University as at 31st December 2018, and of its financial performance and its cash flows for the year then ended in accordance with Sri Lanka Public Sector Accounting standards.

1.2 Basis for Qualified Opinion

(a) Accounting Deficiencies

Following observations are made.

- (i) Changes in non-current liabilities amounting to Rs. 582,273 had been accounted for as cash flows from operating activities in the cash flow statement for the year under review. Accordingly, cash flows from operating activities had been understated by similar amount.
- (ii) Rehabilitation of vehicles, equipment and others amounting to Rs. 25,027,908 had been accounted for as buildings under non-current assets, and as a result, the amount of buildings had been overstated by similar amount.

(b) Lack of Audit Evidences

- (i) According to the information made available to audit, annual board of survey on library books, valued at Rs. 53,184,556, had not been carried out by the management of the University for more than 30 years. As a result, the management was unable to identify the losses from non-receiving of library books timely. According to the audit tests conducted in 2011 on library books, it was observed a loss of Rs. 1,572,452 and however, that loss had not been settled and remained under suspense account.
- (ii) A sum of Rs. 5,480,177 had been paid as overtime to the employees, without confirming their working hours through the finger print attendance in accordance with the Establishments Circular No. 10/2017 of 10th July, 2017 of the University Grants Commission.

I conducted my audit in accordance with Sri Lanka Auditing Standards (SLAuSs). My responsibilities, under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements Section of my report. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified opinion.

1.3 Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation of financial statements that give a true and fair view in accordance with Sri Lanka Public Sector Accounting Standards and for such internal control as management determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the University's ability to continue as a going concern, disclosing, as applicable, matters related to going concern basis of accounting unless management either intends to liquidate the University or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the University's financial reporting process.

As per Section 16 (1) of the National Audit Act, No. 19 of 2018, the University is required to maintain proper books and records of all its income, expenditure, assets and liabilities, to enable annual and periodic financial statements to be prepared of the University.

1.4 Auditor's Responsibilities for the Audit of the Financial Statements

My objective is to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Sri Lanka Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Sri Lanka Auditing Standards, I exercise professional judgment and maintain professional scepticism throughout the audit. I also,

Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for my opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Company's internal control.

Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the management.

Conclude on the appropriateness of the management's use of the going concern basis of accounting and based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the University's ability to continue as a going concern. If I conclude that a material uncertainty exists, I am required to draw attention in my report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify my opinion. My conclusions are based on the audit evidence obtained up to the date of my auditors' report. However, furture events or conditions may cause the University to cease to continue as a going concern.

Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

I communicate with those charged with governance regarding, among other matters, significant audit findings, including any significant deficiencies in internal control that I identify during my audit.

2 Report on Other Legal and Regulatory Requirements

National Audit Act, No. 19 of 2018 includes specific provisions for following requirements.

Except for the effect of the matters described in the Basis for Qualified Opinion paragraph, I have obtained all the information and explanation that required for the audit and as far as appears from my examination, proper accounting records have been kept by the University as per the requirement of section 12 (a) of the National Audit Act, No. 19 of 2018.

The financial statments presented is consistent with the preceding year as per the requirement of section 6 (1) (d) (iii) of the National Audit Act, No. 19 of 2018.

The financial statements presented includes all the recommendations made by me in the previous year as per the requirement of section 6(1)(d) (iv) of the National Audit Act, No. 19 of 2018.

Based on the procedures performed and evidence obtained were limited to matters that are material nothing has come to my attention;

- **2.1** to state that any member of the governing body of the University has any direct or indirect interest in any contract entered into by the University which are out of the normal cause of business as per the requirement of section 12 (d) of the National Audit Act, No. 19 of 2018.
- **2.2** to state that University has not complied with any applicable written law, general and special directions issued by the governing body of the University as per the requirement of section 12 (f) of the National Audit Act, No. 19 of 2018 except for the observations given below.

- (a) According to the Procurement Guideline 8.10.1, procurement entity should publish the description of items/works for which bids were invited, total number of bids received, name of the successful bidder and, amount at which the contract was awarded promptly in its website or any other appropriate media. However, the University had not published above mentioned particulars relating to the contracts amounting to Rs. 102,255,525 awarded in the year under review in any media or website.
- (b) According to the Section 6.3.3 of Procurement guidelines, two bid opening committee members should present in bid opening. However, one member had not presented in bid opening committee meeting relating to the Construction of Lecture hall complex for the Faculty of Management Studies and Commerce.
- (c) A sum of Rs. 202 million had been paid for designing and constructing of the Sports and Recreation Complex at the Physical Education Unit of University. Also, it had planned to completed the construction works on or before 31st October, 2017. However, it was observed that the construction works had not been completed up to the date of this report.
- (d) A stock of construction materials had been handed over to the University in 2015 by the contractor when termination of the contract of Management Faculty Block A (stage 1). However, at the time when the same construction works re-awarded to a new contractor in 2017, a loss of Rs. 574,264 from the above-mentioned construction materials had been revealed. Accordingly, it was observed that the management of the University had failed to keep those items safely and, therefore, the management is responsible for the losses on replacement of those items in the new construction.
- (e) Kaithady Siddha Medicine Unit had been established at a 3 storied building which had been constructed at a cost Rs. 88.3 million and, in this construction a sum of Rs. 4,282,910 had been paid to the construction company as interest and interest on interest due to delays in settlement of bills. According to the audit inspection conducted in February 2019, it was observed that out of 2 lecture halls, 3 laboratories and 3 rooms available in that building, only 2 lecture halls and 2 laboratories had been utilized for the intended purposes. Further, it was revealed that the other spaces had been remained idle since 2015.
- (*f*) Even though a building, constructed at a cost of Rs. 192.36 million, had been handed over to the Faculty of Management Studies and Commerce, it had not been utilized for any economic activity for more than 3 years.
- (g) Idle, unusable and slow-moving items amounting to Rs. 162,431, Rs. 362,695 and Rs. 175,188 respectively had been remained idle in stores of the University for a period ranging from 04 to 20 years without using for any purposes.

3. Other Observations

- (*a*) Distress loan balances amounting to Rs. 859,291 outstanding for more than 5 yeas recoverable from retired staffs had been shown under accounts receivables in the financial statements without being taken proper actions to recover that dues.
- (*b*) Three (3) Refundable deposits received from students aggregating amount of Rs. 166,500 had been remained in general deposit account without being taken proper actions to settle them or more than seven (7) years.
- (c) An advance amounting to Rs. 100,000 paid to an officer of the University, out of funds received from United Nation Development Project, had not been settled and remained under advances in the financial statements over 5 years. Further, Advances aggregating Rs. 476,135 paid during the year under reviews to the officers such as sundry advance, supply advance, travelling advance and petty cash imprest had not been settled up to 30th June, 2019.
- (*d*) Outstanding balances of four items amounted to Rs. 1,990,474 had been shown under the non-current liabilities as restricted fund and specific reserve in the financial statements for more than 8 years without being taken proper actions to utilize them for intended purposes.

- (e) Due to non-payment of the acting salary to a former Assistant Registrar at the time of his retirements in 1998, a sum of Rs. 470,650 including an interest of Rs. 344,560, for delays in payment for 18 years, had to be paid by the University in response to a Court order.
- (*f*) Even though a decision had been taken by the Council to recover the loss of computers and multimedia amounted to Rs. 289,600 from the responsible parties, the management of the University had not taken proper actions to recover that loss.
- (g) Ninety-one (91) academic and non-academic staff of the University who had gone abroad on scholarship programmes had not reported for duty or left from the University after completion of the scholarships. However, the University had not taken action to recover the bond aggregating Rs. 68 million during the period from 1987 to 2019 from the officers who had breached agreements.
- (*h*) Total vacancies of Security Guard Officers had been filled on 05th April, 2017 with the intention of reducing the overtime payment. However, the overtime payment of security guard officers for the year under review had increased by Rs. 2,500,174 or 24% when compared with the preceding year.
- (i) According to the University Grants Commission (UGC) Circular No. 636 of 14th July, 1995, examination results should be released within three months after the examination. Nevertheless, the dates to hold the examinations for various courses conducted under each faculty of the University and target dates to release results of the examinations had not been pre-determined. It was further observed that there was a considerable period of delays in releasing of examinations results, *i. e.* ranging from 02 to 11 months by the faculties of Arts, Management Studies and Commerce, Agriculture, Technology, Medical Laboratory Science/Nursing/Pharmacy, Faculty of Applied Sciences, Faculty of Business Studies and Graduate Studies of the University during the year 2018. Therefore, the students had been deprived to get their employment opportunities in time. Even this matter was pointed out in my previous audit reports, the management had not taken proper actions to release results within three months after the examination held.
- (*j*) Periodicals worth USD 9,328 paid to purchase in the previous years had not been received to the University even up to 31st May, 2019.
- (*k*) Out of 12,660 of total allocated hours for theoretical and practical lectures, 2,380 hours had not been conducted by the academic lecturers of Departments of Tamil, Fine Arts, Sociology, Human Resource Management, Accounting, Financial Management and Commerce in the year under review.
- (*l*) According to the world ranking of Universities, published by an internationally reputed institution, the University was ranked at 8th and 4,384th places among the Sri Lankan Universities and International Universities respectively in the year under review. Even though the international rank had improved from the place of 4,560, the Island rank had dropped from the place of 7 when compared to the previous year.
- (*m*) The medium of the course followed by the student had not been mentioned in confirmation letters on degree certificates issued by the University. Therefore, it was observed in several instances that such confirmation letters had been returned by the respective institutions due to lack of basic information in that letters.
- (n) A sum of Rs. 43,577,638 had been incurred by the University to pay researchers in the year under review and previous three years. Even though the projected period of the above researches had been run out and also approximately more than 50 per cent of the research cost had already been paid, the progress of them and final reports of those researches had not been submitted to the University by researchers up to the end the year under review. Further, the analysis of progress of submission of final reports on researches, it was observed that 42 final reports relating to researches awarded during the period from 2015 to 2018, had not been submitted on or before the expected date of final reports.

- (o) The University had not taken proper actions to fill 258 vacancies in non-academic staff and 207 vacancies in key academic posts such as professor, associate professor, senior lecturer/lecturer etc. in seven faculties and other academic units of the University. Further, the University had not taken actions to fill 114 Academic and Non-academic staff vacancies in Vavuniya Campus.
- (*p*) Necessary actions to implement the recommendations of the Board of Survey for the year 2017 had not been taken by the management; further committee of Board of Survey had not verified 403 inventory items in 2018.
- (q) As per the FR 803, log books for the vehicles of the University had not been maintained properly.
- (r) According to the Strategic and Annual Action Plan prepared for the year 2018 in accordance with the requirements of Public Finance Circular No. 01/2014 dated 17th February, 2014, activities of the Career Guidance Unit and Staff Development Centre had not been included.
- (*s*) Four (4) out of 15 audit programmes had not been conducted by the internal audit unit during the year under review, such as Donation and Foreign Fund, Staff Loans, Staff Personnel files and Academic Programs.
- (t) In terms of Section 6.5.1 of the Public Enterprises Circular No. PED/12 dated 02nd June, 2003, and the Auditor General's letter No. AG Gen/Sec./2018/82, the financial statements and the draft annual report should be furnished to the Auditor General within 60 days from the close of the financial year. However, the financial statements of the University for the year ended 2018 had been furnished to audit only on 10th June, 2018.
- (*u*) Significant variations ranging 10 to 56 percentage were observed between the budgeted and actual income and expenditure thus indicating that the budget had not been made use of as an effective instrument of management control.

<u>Response to the Auditor General on the Financial Statements of the University of Jaffna, Sri Lanka for the year</u> ended 31st December, 2018 in terms of Section 12 of the National Audit Act, No. 19 of 2018

At the outset we wish to report that the issues raised in the report had been seriously discussed at the Audit Committee, Finance Committee and at the Council and follow up actions taken on a regular basis. Most of the issues highlighted in this report has already been rectified and tight control system has been implemented to prevent recurrence. Remaining issues too are taken very seriously and actions taken to correct these issues promptly.

We have been conducting regular Audit committee meeting and monthly Finance Committee meeting to address all the financial and non-financial issues very seriously and obtain Council directions and closely monitored. The Council of the University is very particular in preserving the image of the University through good governance practices.

Our detail response in respect of the issues highlighted in the report are attached while assuring you that all possible actions have been taken to prevent recurrence.

Detail Response on the issues highlighted in the report

1.2

(*a*) Accounting Deficiencies

(i) The amount of Rs. 582,273 was taken in to cash flow from operating activities by an oversight. Comments noted to exercise proper care in preparing the Cash Flow Statement.

- (ii) Although separate ledger accounts have been maintained for rehabilitation of Vehicles, Equipment and other which are work in progress, when disclosing these in the Financial Statement it has been shown under buildings. It did not affect the depreciation calculation as they were work in progress. Corrective action has been taken to show rehabilitation works under separate assets category in future.
- (b) Lack of Audit Evidences
 - (i) Action has been taken to complete the board of survey. The team members have verified each book and mark the identification of verification. More than 250,000 books and periodical are available in several locations.

The following branch libraries books and periodical board of survey has already been completed.

- 1. Faculty of Engineering Library 8557 books
- 2. Faculty of Technology 3146 books
- 3. Faculty of Agriculture 3760 books
- 4. Ramanathan Academy of Fine Arts more than 2500 books

Action has been taken to conduct board of survey of the following libraries books and periodicals as under tabling.

- * Faculty of Medicine will be completed 24th August, 2019
- * Siddha Medicine library will be completed 31st August, 2019
- * Main Library board of survey will be completed before 31st December, 2019.

Additional team has been appointed to conduct to the main library to complete the survey within the time frame.

2. Report on Other Legal and Regulatory Requirements

2.2. (a) Financial Regulation of the Democratic Socialist Republic of Sri Lanka

- (i) This matter had been deliberated at length looking for alternative options. We have now taken action to send salary slips to all departments and get the signature monthly without any delay. Currently all employees are signing the receipt of their salary payment on monthly basis without any default.
- (ii) Soon after the payment has been made vouchers are forwarded to audit whenever request made by the auditor in the past. We have taken action to submit the vouchers on a monthly basis in the future.
- (iii) We have taken strict action to settle advances soon after the event is completed. Close monitoring mechanism has been implemented to monitor unsettled advances and action has been taken to recover them from respective persons when there is any default.

(b) Public Enterprises Circulars

- (i) The annual report and Accounts of the University for the year 2017 have already been submitted to the Ministry of Higher Education on 28th June, 2019 in all three languages for Cabinet approval and to submit the same to Parliament, Cabinet approval is awaited.
- (ii) We have had 5 Audit Committee meetings during the year 2018. Due to the delay in the appointment of Assistant Internal Auditor we were unable to conduct the Audit Committee meeting during the last Quarter of 2018.

(c) University Grant Commission Circulars

(i) Annual Board of survey has taken more than six months due to the following reasons.

Academic activities are ongoing (lecturers and practical's) All Island Trade union action of Nonacademic staff in year 2018

Action has been taken to ensure the Board of Survey will be conducted on time in future.

(ii) Academic staff in the Sri Lankan University system do not generally sign in the Attendance Register. However, this matter was brought to the notice at its 372th meeting of the Council dated 29.09.2012 and it was pointed out at the meeting that nowhere in the world academic staff are expected to sign in the attendance register. Deans of Faculties endorsed this view. Also heads of the academic departments are confirming their presence and it was always monitored by respective heads of the department. This was also elevated at the previous COPE meeting.

2.4

- (*a*) The University has not published the details of the contract works awards in the University Website until 20.03.2019, but now action has already taken to publish in the University Website. We will take close monitoring and ensure this will continue in the future without any break.
- (b) On this Bid opening one of the bid opening Committee member was present in the bid opening with the other member and signed all necessary pages of bids documents but failed to sign the bid opening committee minutes. We have taken action to avoid these type of error in future.
- (c) Due to the scarcity of construction materials in Jaffna district project delayed and extension given up to 28.02.2019 including the following reasons;
- 1. Due to the shortage of Gravel & River sand in Jaffna Peninsula.
- 2. Changes in original design and inclusion of extra work.
- 3. Delay in releasing interim payments.
- 4. Adverse climatic conditions. Nature condition
- 5. Unexpected delays in imported supplies.
- 6. Labour deficiency.
- 7. Quality related issues of finishing works.

As of now all the civil works completed and rectification work is in progress.

- (*d*) The main reason for the deviation was calculation error while taking measurement of material. Certain material ware taken in to the counting where the measurement is incorrect. Action has been taken to correct the measurement report and it will get corrected as soon as possible.
- (e) In the completed 3 storied building, we have 3 laboratories, 2 lecture halls, and 3 rooms with lobby.

Two lecture halls and three laboratories (Department of Noi Naadal Chikitsai, Department of Virana Chikitsai and Research Laboratory) are being used from January, 2017 with the opening ceremony of the building and inauguration of NRCEIM (National Research Conference and Exhibition on Indigenous Medicine). The other rooms are being used from 2019 for administration office, Coordinator's Office and office of the maintenance unit and Health Centre as given below;

With the appointment of maintenance staff; electrician, plumber and other support staff, we assigned a room for maintenance Unit since January, 2019.

Administrative Officer for the Unit of Siddha Medicine is appointed since March 2019 and the Administration office is shifted to the new building in May, 2019 and Health Centre and an office for the Coordinator of the Department of Virana Chikitsai started to be operated.

Currently the whole three storied building is fully utilized.

- (f) Even though building work of block C completed, other buildings (A, B, D & E) were not completed and it took long time to complete due to contract was stopped and re advertised. Meanwhile, the building block C was utilized for other lecture activities of Faculty of Arts. Now block "C" and Block "D & E" have been completed and taken over by the University. The block "A" has not been completed so far. The Faculty of Management Studies and Commerce will be shifted to the new location once the associated works are completed by 15.10.2019.
- (g) We have taken action to reduce the idle, unusable and slow moving item and now the remained value of item has been reduced compared to previous years.

Also action had been already taken before placing the order consideration of the stock availability in the stores.

In addition to that we have requested to form a committee to identify unusable and non-movable item in the stores and report it to Competent Authority. Based on the committee decision memo will place to council and action will take to destroy those inventory items immediately.

(3) Other Observations

(a) As per the Circular the Loans recovery period is five years as sixty installments from the month of Loan granted. As a policy, the loan installments are not recovered from the salary of April and December month of every year. Only, the interest on the loans are recovered in the months of April and December every year. Due to the non-recovery of installments during the months of April and December, the loan recovery period exceeds 5 years.

In addition to that certain loans exceeded more than 5 years due to no pay leave, vacation of post, termination of service, retirement from the service etc. However, we have a clear control and procedure to recover it from the employee UPF when releasing the UPF fund.

(*b*) We have taken a clear mechanism to return the refundable deposit to the respective students immediately. If relevant student did not claim the refundable deposit within 5 years from the course completed period, we have taken action to transfer it to the University development Fund. Vavuniya Campus too has taken action to transfer this amount to university development fund.

(c) Advances

Following action has been taken to recover the unsettled advances immediately. Moreover, we have already strengthen our internal control system to closely monitor unsettled outside advances which are currently under control.

- (d) The University of Jaffna is receiving funds for various purposes from different well-wishers. When we receive the amounts those were credited to the respective ledger accounts and such funds are kept in Fixed Deposits on short term investment basis. The interest earned from the respective investment is taken into account and utilized for the particular purposes indicated by the donors when such event occurs. This fund of Rs. 1,990,474 was still not used for any specific purpose since the donor did not instruct any special tasks. As soon as we receive the instruction form the donor we will take action to use the fund immediately.
- (e) This was a case filed in District court in 1998 by a former Assistant Registrar against the University for his Acting Salary. The Judgment for the case has given only on 2017 and, based on the judgment and approval of the council the settlement was made for the former Assistant. Registrar in 2018.
- (f) Council decided to recover the loss of computer worth of Rs. 190,900 from the Head of Department. As he has not agreed with this Council decision, the matter has been referred to the Committee for Legal Affairs by the Council. The necessary action will be taken by the Legal Affairs Committee direction is awaited.

Council decided to recover the value of lost multimedia and Management already sent the consent letter regarding this to the responsible person. As soon as the consent letter is received action will be taken to recover the amount from the respective staff immediately.

(g) On the direction of the Council various measures have been introduced to improve the bond obligation through the Committee on obligations of Bond and Agreements. As a result, the number defaulters and amount outstanding has been reduced to a great extent in the past. Currently only 91 numbers of obligators have to settle the total outstanding amount of bond obligation amounting to Rs. 68 million. The meeting of the Committee on obligations of Bond and Agreements had been continously reviewing them and a policy paper

in this regard had been prepared codifying all the procedures to scrutinize the legal requirements to minimize the obligation in future.

(h) Currently University is having only 53 security staffs and out of this 50 staffs are employed in Unversity of Jaffna and the remaining 3 are employed in Kilinochchi premises. This carder capacity of the security staff is not enough catering the entire University. Therefore, it is being important for the University security staffs to work over time. The security staff service is required for all 30 days of the month. Ireespective of Saturday, Sunday or holiday's security service is unavoidable and it has to be delivered without any break, resulting in increasing the security staff over time payment.

However, management has already taken action to increase the carder requirement for the University and action taken to fill the balance carders immediately.

- (i) Most of the Exam results have been released based on the recommendation of Pre result Board, and the final result will be released along with second semester/yearly basis. Action has been taken to reduce the delays in releasing the exam results by sending reminders to the Deans of the Faculties and submitting the monthly reports on "the status of releasing the results" to the Senate.
- (*j*) Control mechanism has been already accelerated to control subsequent journal payments. Action already taken to deduct the journal value from the subsequent journal payment if the supplier fails to supply the periodicals within the two years' period. Current outstanding journal issues had been bought down to USD 9,328.
- (*k*) Following are the main reasons for the unused hours. However, it was ensured that unused hours did not affect the university student's education and standards of the course.

Sociology

The attendance was not taken when conducting field visit to fulfull the practical components of the course units. Also while conducting tutorial classes for some courses the attendance were not taken. Some lectures were not covered due to the situation in relation on holidays and unexpected students' unrests. Action will be taken to maintain attendance property in future.

Fine Arts

Some lectures have not been covered due to the situation in relation on holidays and unexpected students' unrests. Some lectures were cancelled due student's activities and university meetings. Lectures were not covered for public holidays.

Tamil

Due to lack of staff, unable to cover up lapsed lectures. Some lectures were not covered due to the situation in relation on holidays and unexpected students' unrests. Some lectures were cancelled due student's activities and university meetings. Lectures were not covered for public holidays.

Accounting, Financial Managment, Commerce and Human Resource Managment

The approved calendar of dates usually does not consider special holidays, strikes of students and staffs, student's educational tours & special events organized by students. Further if we have consecutive holidays in a week students failed to attend the lectures, specially the students who are coming from southern part of the Sri Lanka. Therefore, we are compelled to cancel the lectures due to poor attendance.

During the month of the December 2018 there was a natural disaster of the flood in Vanni region and our students engaged in relief activities, due to this some of the lecture works were cancelled by students.

Students conduct the management studies/commerce week (MASCO week). Most of the cultural and sports programs were conducted in the evening. Due to these some of the evening lecture were cancelled for one week.

Occasionally the staff has presentation session for students in their respective subjects for 2 to 3 hours continously. However, the attendance was signed by the students only for one hour. Therefore, this hour was not taken in to account.

However, entire syllabus contents were covered with in the lecture hours conducted and in future we will have well defined and proper contingent mechanism to avoid those lapses. Each staff should maintain complete records of student's attendance in the future. Reason for missed lecture hours and alternative arrangements to cover missed lecture hours from the forth coming academic year has been already planned well ahead. Therefore, in future we able to regularize the syllabus and maintain detail records for the lecture program.

(l) As maintained the University of Jaffna was at the rank 7 in the year 2017 howevr it stepped down to rank 8 in the year 2018 and again holding the position of 7 in year 2019. The drop of the Ranking in the year 2018 is mainly due to incomplete uploading or updating the e-repository of the University, which is used in the Webometrics to rank the University.

This matter was discussed at the Senate, Council and the then Vice-chancellor agreed to take initiatives to accelerate the uploading of the research papers however the uploading was not completed as expected since all the articles were not submitted to the Library in PDF forms.

This matter was discussed with the Librarian of the University of Jaffna and she said that mechanism is developed in the Library under section of e-resources to upload all the research articles in the e-repository. An Assistant Librarian is now given the task to upload the research papers and a staff is assigned to assist her in this task.

This was already discussed with the Competent Authority and planned to have coordinators in each faculty/ unit to collect all the research articles either abstaracts/full articles and send to the Library every month. This process will be monitored by the Internal Quality Assurance Unit (IQAU) and Internal Quality Assurance Cells (IQAC) of the faculties and Units. Further e-repository is now included in the agenda of the IQAU monthly meetings and the progress will be reported to the University Community, Senate and Council. Further respective Deans and Heads of Units are also informed to include this as an agenda in their faculty boards/ Board of Management/Department meetings. This will also be monitored by the IQAU monthly through the minutes of the faculty board summited to the Senate.

At last, every step will be taken to update the research articles in to the e-repository to bring the Universities ranking above.

- (*m*) Action would be taken to include the provision of medium of instructions in the Degree statement with the approval of he Senate. However, at present, the medium of the instructions is indicated in the Academic Transcript which is issued to the Graduates at the end of the course.
- (n) All payments were made with the recommendation of the University Research Committee (URC) based on the justification given by the grantee. Further, URC has also decided that new applications under University Research Grant (URG) will not be entertained, if final report of the previous grants had not been received. Action is also being taken to obtain the final reports of the researchers. The following table shows the current position of progress reports and final reports received upto now.

When URC approving new grants and payments for prior grants, it is considered the present position of the prior grants and the unutilized amount of the particular grantee for the previous year and requested him/her to complete the prior research within the stipulated grant period. In addition to the above, URC has also decided to request grantees, to submit the progress report and final reports of the previous grants, before awarding the new grant. Reminders for requesting progress reports and final reports are promptly sent. However, there are few instances grantees did not comply. Action has been taken to freeze the unutilized amount after the grant period, with the prior intimation to the grantee.

Year Current Position

- 2015 All researchers except one have submitted their final reports and those reports are available in the relevant research files. Further, the above mentioned researcher has now completed the research and awaiting for the final report.
- All researchers except two have now submitted their final reports and those final reports are available in the relevant research files. Further, URC has decided to freeze the unutilized amount of the above two grantees after 31st July, 2018 and awaiting for the final report of the above.
- 2017 All researchers except three have now submitted their final reports and those are available in the relevant research files. Further, URC has recommended extension for the above researchers, based on the reason submitted by the researchers.
- 2018 Eight nos. of researchers have submitted their final reports, up to now and 13 nos. of researchers have requested extension for various reasons and the URC recommended the extension based on the progress reports submitted by them.

Unversity Grant Commission allocates Research Block Grant, to Universities every year to finance their ongoing researches and new research projects. At the university level, University Research Committee is monitoring the University Research Grants and the research activities under the above grants. For the above monitoring purposes, the URC usually urges the grantees to submit the progress reports and final reports of the research projects, time to time, in order to monitor the financial and physical progress/performance of the funds allocated for each and every research activities.

Further, the URC at its 34th meeting held on 4th December, 2018 has taken decision to compile the details of research outputs (Abstracts, papers, equipment etc) of each grantees at the respective Departments, Faculties and Academic Affairs and Publication Branch in order to utilize the outputs/benefits of the researches for further continues researches and literature survey. Furthermore, URC allocates funds through the programme budget, for presenting papers at the National/International conferences and publication purposes in order to utilizing the outcomes or findings of the above researches. This will ensure not only efficient and effective utilization of the research funds but also utilizing the outcomes/findings of the researches in a manner to achieve desired outcomes towards social economic developments.

In the years of 2017 and 2018 more than 60% of final reports or progress reports on researches had not been submitted to the University by researches. Further, without obtaining the final reports, more than 50% of payments to researches had been made by the University in 2017, thus indicated management inefficiency.

Final report of the researches for the year 2017 and 2018 are being submitted now, and this details is being reported regularly to the URC for monitoring purposes. All progress reports, final reports and other related documents are available at the Academic Branch for verification, and action is being taken to freeze the unutilized fund, within the time frame. Furthermore, when granting funds for new applications, it is considered the submission of final report of the previous grant by the URC.

Initially, the fund is being released for the purchase of necessary equipment's and goods, which are essentially needed to start the preliminary works and it depends on the type of research. Further, the researcher has to disburse the fund and complete the research within the budget period, and to follow all financial rules ad regulations and purchasing procedures, when they purchase equipment's and goods for research and it will take much time to proceed the precedures for purchase. Therefore, on submission of certified bills and other related documents, on the recommendation of the URC, funds are released, in order to avoid considerable delays in payments, and to speed up the researches.

(*o*) Most of these Non Academic vacancies are minor grade employees. These vacancies are filled based on the list given by the Ministry of Higher Education. Last period there were 2 list received from the ministry and both the list were cancelled due to the changes of Ministers.

Now we have received the new Ministry list and based on that we have planned to fill 210 vacancies which was going to be filled within 2 months as the interview date has already been scheduled.

University has taken all the efforts to fill the existing cadre vacancies promptly. The University was unable to fill the 43 positions of Professor Chair except four which are in process as there was no application received with required qualifications despite of repeated advertisements. Such situation is prevailed even for the position of Senior Lecturers/Lecturers in some disciplines in all Faculties. In such circumstances the University filled these vacant positions by Temporary Lectures, Temporary Instructors or by Temporary Demonstrators in order to carry out the academic programs without interruption.

We have received the Ministry list to fill the Non Academic minor grade staffs and action already had been taken to fill the Non-academic staff in Vavuniya Campus.

Academic Staffs, we were unable to find suitable candidates with the expected qualifications and experience. In such circumstances the Vavuniya Campus has filled these vacant positions by Temporary Lectures, Temporary Instructors or by Temporary Demonstrators in order to carry out the academic programs without interruption.

(*p*) The following action has been taken to overcome this problem.

All support staff are requested to balance the inventory register, keep and maintain other relevant document for assets moving.

Remove the auctioned items which were approved by the council before the next Board survey. It will create the not verified items or shortage. Action will be taken to remove those items from the list immediately.

- (q) We have now taken effective action from August 2018 to maintain log books for vehicles properly.
- (*r*) Activities of the Career Guidance Unit and the Staff Development Centre were not included in the Strategic and Annual Action plan of the University in the past. Now activities of the Career Guidance Unit and Staff Development Center will be included in the Strategic and Annual Action Plan in the future.
- (s) We have been without the Internal Auditor during the last quarter of the year and human resources were not sufficient enough to cover all the chapters in the year of 2018. Only from June 2018 onwards the Audit Assistants were appointed to Internal Audit Division and still Deputy Internal Auditor vacant dispute constant follow up.

- (t) This was beyond the control of the University. There had been a system error in the Fixed Assets register which was introduced in the previous year. The error was unable to be rectified by the system providers for more than 2 months. Due to this the submission of the Financial Statement got delayed. However, we have corrected the error successfully and finished the report end of May, 2019 and placed it to the Audit committee. We have taken precautions and corrective action to avoid these types of errors in the future and action already had been taken to submit the Financial Statements on time in the future.
- (u) The Administration has taken action to have regular monitoring of variances at the Finance Committee on monthly basis and at Audit Committee on a Quarterly basis. Action has already been taken in this regard and all possible precautions are taken to minimize the variances.
