MUNICIPAL COUNCIL, BANDARAWELA

Constitution for Independent Group No. 01

01ST CHAPTER

1. The name of the party and power area	Should be renamed Bandarawela Municipal Council Independent Group No. 1 Bandarawela Urban Council area is the power area.
2. Symbol and the Colour	The symbol of that independent group is the clock and the colour is yellow. But the symbol and colour can be changed when needed.
3. Objective	To submit nominations for the Bandarawela Municipal Council for the local government elections in the Bandarawela Municipal Council area, after gaining power, take action to educate the people living in the area, manage the health conditions, upgrade, uphold universal suffrage and equal rights for all by recognizing the fundamental rights of the people and carrying out all ancillary activities related to the implementation of that objective.
4. On the date of enactment	Effective from 18th December 2018
5. Party membership	Candidates contesting from the Independent Group No. 01 of the Bandarawela Municipal Council and any other Member coming into competitive power are recognized as members under this constitution and it must be acknowledged that every such member has accepted this Act and will act in accordance with it.
5.1 Terms of membership	<p>Anyone who accepts membership, namely a candidate and/or member, must agree to the following :</p> <p>(a) Recognition of the party's principles, objectives and code of conduct.</p> <p>(b) Supporting all the candidates nominated by the party and not supporting other candidates who are contesting against each candidate.</p> <p>(c) If elected as a member, follow the legitimate orders of the team leader, Obedience is following and following the decisions made by the team leader.</p> <p>(d) Treating the so-called independent group 01 as a party.</p> <p>(e) Failure to support various other political parties and/or non-activism support to any political party that opposes the above agreements.</p> <p>(f) Do not publicity criticize the team leader and/or an elected member, make the necessary criticisms at the group meeting and do not criticize in a way that breaks the concept of going outside.</p> <p>(g) If a member is elected as a member he/she must agree to the decisions of the group leader in the House or at the meetings and not abstain from voting on the proposals of an opposing party or voting in a manner that would discredit the Independent Group.</p>

6. Disciplinary powers	<p>(a) Any member who abuses, insults, threatens or assaults another member/ group leader or publicly criticizes group policies or supports another political party or issues statements that bring and/or defame group policy and collective results Do not engage in any activities that cause public disrepute.</p> <p>(b) Independent Group Management Committee or its members should not be abused, threatened or insulted.</p> <p>(c) do not give political support to a member or member of another party or independent group and if the group gains power in the Bandarawela Municipal Council, support another party so as not to lose that power.</p> <p>(d) Every member should behave in an exemplary and dignified manner and always act in a manner that preserves the dignity of the Municipal Council.</p>
7. Management Committee	<p>Independent group and implementation of its policies a committee called the Management Committee should be set up to implement the policy formulation, implementation of regulations and advising and that committee should be composed of eleven members.</p>
8. Composition of the Management Committee	<p>Of the Management Committee it should consist of a teacher, a lawyer, a business professional, a retired civil servant and six other ordinary people and the group leader should be the head of the management committee.</p> <p>The committee is also the disciplinary authority.</p>
9. Management Committee Decisions	<p>The decision of the management committee is final and at a critical juncture the team leader must have a decisive vote in addition to his own.</p>
10. Powers of the Management Committee	<p>I. Preparation of nominations required for an election.</p> <p>II. Arranging to contest an election.</p> <p>III. Amendments to the Constitution, Imposition of Rules, Compilation of Standing Orders.</p> <p>IV. Taking Disciplinary action of the Members.</p> <p>V. Carry out all activities to implement the objectives of the party/independent group.</p>
11. Quota	<p>The quota of the management committee should not be less than 1/4 of the number of members.</p>
12. Leader of the group	<p>The Group leader is the chief of the group, The decision he makes legally becomes final, subject to the approval of the committee.</p>
13. Funds	<p>There should be not funding for Independent Group No. 01 and no member has the right to, raise funds. But a fund called the Members' Forum Fund can be started from the salaries of the elected members and deposited in the recognized bank. From that fund, money can be spent and invested according to the agreement of the group and it should be done in a very transparent manner. The group leader and one other member are authorized to activate the account.</p>

14. Appointment of Mayor and Vice Mayor	<p>The group leader should be the mayor and the appointment of the Vice mayor should be at the discretion of the mayor.</p> <p>The position of mayor to some extent,</p> <p>In the event of death, resignation, or due to another action, the Vice Mayor should be the Mayor and he or she shall be the Group Leader.</p>
15. Secretary	A non-member should be appointed to report on group meetings, file works, correspondence, disciplinary meetings and all independent group paperwork.
16. Membership and Loss of membership	<p>Groups that act in a manner that is intentional to the detriment of the objectives of the constitution, act contrary to the decision of the group leader and act outside the group spirit, approving a motion by another party or another</p> <p>Disciplinary action should be taken against those who make statements and statements that harm the existence of an independent group by party during a session, Who uses the ballot and uses the ballot to lose group power, appearing on social media and should be able to make decisions if found guilty and expelled from membership. If a member holds a post in the Municipal Council or party when he or she loses his or her membership, that post should also terminate.</p>
17. Abandoned facts	In the event of any issue or problem arising out of a provision which is not provided for in this Constitution, the Management Committee may, by means of the law recognized in the country, formulate the necessary rules, which shall be passed by a majority vote of the members of the Management Committee. Since every member is bound to accept any such rule as part of this Constitution, no member shall have the right to question it.
