Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

All Notices to be published in the weekly *Gazette* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 12th February, 2021 should reach Government Press on or before 12.00 noon on 29th January, 2021.

Declaration of Developed Areas

IN terms of Section 134 (1) of the Pradeshiya Sabha Act No. 15 of 1987, the Assistant Commissioner of Local Government, Matara has issued his No. මර/පපාසකො/සං / 08 / 02-11/2020 as the developed areas from A to D included in the following Schedule of the Pitabeddara Pradeshiya Sabha I, hereby announce to the public that it has been approved by letter dated 19.11.2020.

Area A

3KM 400M from Morawaka Milla-ela Junction to Akuressa Rambukana Bridge Deniyaya Akuressa Main Road from the Line to the Nilwala River in the East and Real Estate up to 75M in the West.

Area B

Morawaka Neluwa Road from the beginning to Neluwa, 300m to the entrance to the Morawaka Public Stadium.

Area C

1KM 800M from Pitabeddara Natthawila Junction to Akuressa Malpudanella Junction Deniyaya Akuressa Main Road from the Line to the East 75M Specific Property Area up to 75M West.

Area D

Pitabeddara Siyambalagoda Road From Dankoluwa Junction to Dankoluwa Bodhi on the left hand side. Specific property up to 75M on the Pitabeddara Pasgoda road and all specific property on the left and right 50m of all by roads connected to that road.
