NOTIFICATION UNDER STATE LAND REGULATION No. 21(2)

THIS is to inform hereby that Senerath Arachchilage Karunaratne has requested the 15 acres of land portion for Agricultural Purpose depicted in the draft sketch made by village Land Officer in Polathuwadiya in the No. 01, Kirioya Grama Niladhari Division in Ela - Hera Divisional Secretariat in the Polonnaruwa District

- (b) Annual lease Amount: When the appraised value of the land in 2021 is less than Rs. 5 million the valuation based on the Chief Assessor calculated as 2% of the undeveloped value of the land for that year. When the appraised value of the land in 2021 exceeds than Rs. 5 million. the valuation based on the Chief Assessor calculated as 4% of the undeveloped value of the land for that year. This tax amount should be revised every 5 years and should add 20% to the annual tax levied at the end of the previous 5 years.

Seasonal amount .- No seasonal amount is charged;

(c) This land is used only for the purpose of the Agricultural activities.

- (d) Within a year of the commencement of this lease, it should be developed in the interest for the Provincial Land Commissioner/ Deputy Land Commissioner / Divisional Secretary.
- (e) When the land is leased action will be taken to terminate the lease if the lessee fails to achieve the objective of acquiring the land within the stipulated time limit.
- (f) It is not allowed to interim lease our or conveyance of this property until o5 years from 27.09.2021;
- (g) The rent must continue to be paid and the agreement will automatically terminate in the event of tax evasion. In case of non - payment of tax a penalty of 10% penalty will be levied on the tax due;
- (h) Must comply with special conditions issued by the Department of Archeology.

If the relevant acceptable reasons is not submitted to me within 06 weeks from the date of publication in the *Gazette* set out the reasons for not to lease the property and submitted to me, the land will be leased as per the rquest.
