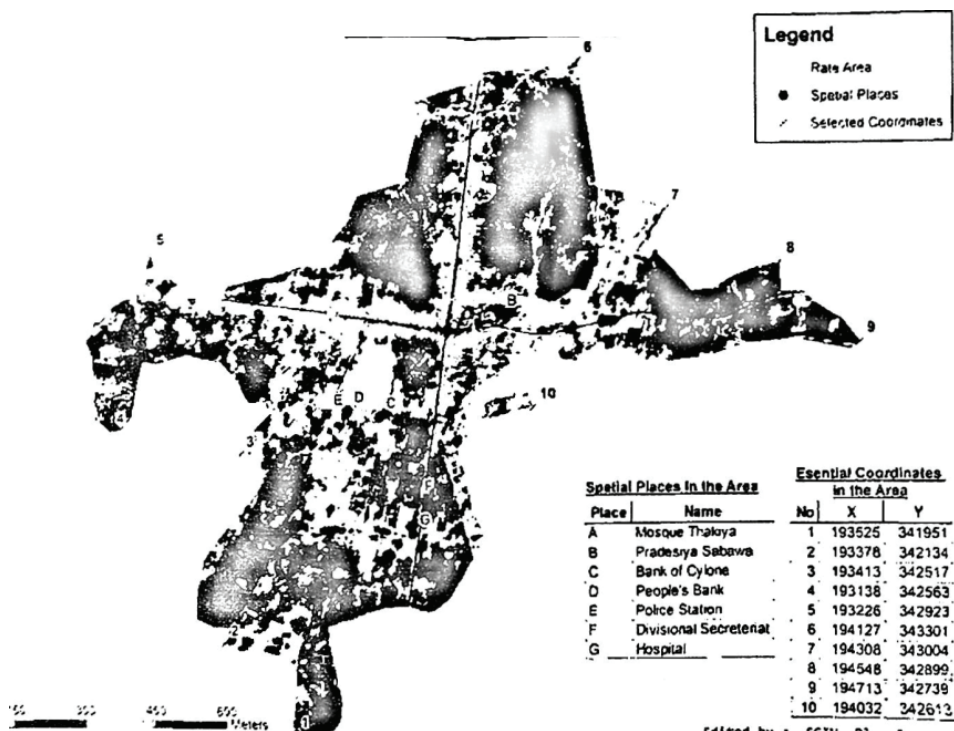
RESOLUTION
