Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 20th August, 2021 should reach Government Press on or before 12.00 noon on 06th August, 2021.

AN ACT TO INCORPORATE THE INSTITUTE OF DRAFTING TECHNOLOGISTS SRI LANKA

I, Gamini Waleboda, do hereby give notice under the standing order No. 53 (1) of the Parliament of the Democratic Socialist Republic of Sri Lanka, That I propose to introduce to Parliament a Bill entitled "An Act to incorporate the Institute of Drafting Technologists Sri Lanka"

The aim of the Bill is to incorporate the said institute which has the following objects :-

- (a) To promote and foster the advancement of Drafting Technology including techniques and skills thereof;
- (b) To secure uniformity in the vocation of Drafting Technology, and modify, supervise, advise and control the Drafting Technology Education in Sri Lanka in consultation with the Tertiary and Vocational Education Commission (hereinafter referred to as "the TVEC);
- (c) To conduct and promote courses in Drafting Technology provided that the Institute shall not at any time exceed any authority given to it by the TVEC to conduct such courses accredited by the TVEC pertaining to Drafting Technology;
