All Government Departments, Corporations, Boards, etc. are hereby advised that Notifications fixing closing dates and times of applications in respect of Post-Vacancies, Examinations, Tender Notices and dates and times of Auction Sales, etc. should be prepared by giving adequate time both from the date of despatch of notices to Govt. Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after three months from the date of publication.

All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* notices for publication in the weekly *Gazette* of 28thJanuary, 2022 should reach Government Press on or before 12.00 noon on 13th January 2022. Electronic Transactions Act, No. 19 of 2006 - Section 9





### SUGGESTION STANDARD

"The powers vested in the Pradeshiya Sabhas under Sub-section (1) of Section 134 of the Pradeshiya Sabha Act, No. 15 of 1987 are located within the jurisdiction of the Lankapura Pradeshiya Sabha, but within the boundaries described in the maps included in the following Schedule and with each map. The approval of the Assistant Commissioner of Local Government in the Polonnaruwa District Should be obtained for declaring the proposed areas as developed areas. 'To assess the annual value of all immovable and immovable property located in each area and to make assessments on such assessed annual value, the aforesaid Pradeshiya Sabha should be read in accordance with Section 2 of the Provincial Councils (Auxiliary Provision) Act, No. 12 of 1989. The Lankapura Pradeshiya Sabha proposes to seek the approval of the governor of the North Central Province under Subsection (1) of Section 134 of the Act."

- 1. All Notices and Advertisements are published at the risk of the Advertisers.
- 2. All Notices and Advertisements by Private Advertisers may be handed in or sent directly by post together with full payments to the Government Printer, Department of Government Printing, Colombo 8.
- 3. The office hours are from 8.30 a.m. to 4.15 p.m.
- 4. Cash transactions will be from 9.00 a.m. to 3.00 p.m.
- 5. **All Notices and Advertisements must be pre-paid.** Notices and Advertisements sent directly by post should be accompanied by Money Order, Postal Order or Cheque made payable to the Government Printer. Postage stamps will not be accepted in payment of Advertisements. Post Office Borella will be the paying office for Money Orders.
- 6. To avoid errors and delay "copy" should be on one side of the paper only and typewritten.
- 7. All signatures should be repeated in block letters below the written signature.
- 8. Notices re-change of name from Non-Government Servants and Trade Advertisements are not accepted for publication.
- Advertisements purporting to be issued under Orders of Courts will not be inserted unless signed or attested by a Proctor of the Supreme Court.
