All Notices to be published in the weekly *Gazette* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 29th July, 2022 should reach Government Press on or before 12.00 noon on 15th July, 2022.

PROPOSAL

As per Section (1) of 134 of Pradeshiya Sabha Act, No. 15 of 1987 proposed that the area from A to G described below of Dickwella Pradeshiya Sabha to publish as a developed area.

Area A -

From The Walasgala Kumara Stores junction up to Radampala junction in Matara direction 4.2 km in distance. The land within 100m in East and West from the middle line of Matara Main Road through the Dickwella Radampala Road to published as a developed area and

Area B -

From the Bathigama hospital junction up to Beliwattha Seethagalla (Pradeshiya Sabha limit) in Matara direction 6.940 km in distance. The land within 100m in South and North from the middle line of Dickwella Matara Main Road to published as a developed area and

Area C -

From Dodampahala Lahiru Ricemill junction (Pradeshiya Sabha limit) up to Nilwella junction in Tangalle direction 3.01 km in distance. The land within 100m in North and South from the middle line of Tangalle Main Road through the Dickwella Mahawela Road to published as a developed area and

Area D -

From Nilwella 'Orchid Vila' tourist resort up to Siyambalagaha junction in Nilwella direction 1.550 km in distance. The land within 100m in North West and South east from the middle line of Nilwella Road to published as a developed area and

Area E -

From the border of assessment area (near Buddha statue) of Welihitiya Sirisumana Mawatha up to Radampala junction in Aluthgoda direction 1 km in distance. The land within 100m in North and South from the middle line of Welihitiya Aluthgoda Road to published as a developed area and

Area F -

From the MR/Dickwella Methodist school junction up to sea beach direction 750m in distance. The land within 100m in east and West from the middle line of Dickwella Hiriketiya Road to published as a developed area and

Area G -

From the Pehembiya Road and 'vers' tourist resort up to sea beach 1.120 km in distance. The land within 100m in North east and South west from the middle line of Dickwella Pehembiya Road to published as a developed area.
