AN ACT TO INCORPORATE THE INTERNATIONAL INSTITUTE OF THERAVADHA

I Maithreepala Sirisena, do hereby give notice under No. 53(1) of the Standing Order of the Parliament of the Democratic Socialist Republic of Sri Lanka, that I propose to introduce to Parliament a Bill entitled "An Act to incorporate the International Institute of Theravadha".

The aim of the Bill is to incorporate the said Institute which has the following general objects :-

- (a) to train Buddhist monks and lay devotees to be enriched with doctrinal knowledge and knowledge in meditation that is adequate to attain the ultimate liberation according to Buddhist teachings, the Nibbāna alone;
- (b) to train Buddhist monks and lay devotees to be capable in guiding others to attain the ultimate liberation according to Buddhist teachings, the Nibbāna;
- (c) to train Buddhist monks to be capable in performing formal acts of discipline (vinayakammas), according to the Theravada tradition, in order to sustain the sāsana.
