1. General Qualifications required :

1:1 Every applicant must furnish satisfactory proof that he is a Sri Lankan. A Sri Lankan, is a citizen of Sri Lanka by descent or by registration as defined in the Sri Lanka Citizenship Act.

1:2 A candidate for any post for which the minimum educational qualification prescribed is a pass in the Senior School Certificate Examination or equivalent or higher examination, should have a pass in the Senior School Certificate Examination or equivalent or higher examination, should have a pass either in Sinhala language or Tamil language obtained, as the case may be, at the Senior School Certificate Examination or its equivalent if he is either a Sinhalese educated in Sinhala Medium or if he is a Tamil educated in Tamil Medium (This requirement will not apply to those who are in the public service from a date prior to January 01, 1961, and who seek appointments to other posts in the public service).

1:3 Application from the New Entrants, Public Officers, who are not either Sinhala or Tamil educated, whose probationary trial appointments have been terminated for failure to pass the prescribed official language proficiency tests will not be entertained unless they have obtained the qualifications which could entitle them to seek exemptions from the highest proficiency test prescribed for the post.

2. Conditions of Service-General :

2:1 All officers in the Public Service will be subject to the Financial Regulations, the Establishments Code, Departmental Orders or Regulations and any other Orders or Regulations that may be issued by the Governments from time to time.

2:2 A Public officer may be required to furnish security in terms of the Public Officers (Security) Ordinance, in such sum and in such manner as the secretary to the Ministry concerned may determine.

2:3 A Public Officer may be called upon to serve in any part of the Island.

3. Conditions of Service applicable to Public Officers holding permanent appointments :

3:1 In addition to the conditions referred to in Section 2 above Public Officer holding permanent appointments will be subject to the following further conditions:

3:1:1 All appointments will be on probation for a period of 3 years unless a longer period is considered necessary in respect of any post. Any appointment may be terminated at any time during the period of probation without a reason being assigned.

3:1:2 All public officers are required to conform to the provisions of the Chapter IV of the Constitution of the Democratic Socialist Republic of Sri Lanka and any other laws, regulations or rules that may be made from time to time to give effect to the Language Policy of the Government.

3:1:3 All Public officers who have not entered the Public Service either in Sinhala Medium or in Tamil Medium are required to acquire a working knowledge in one of the official languages.

3:1:4 Confirmation at the expiry of the period of probation of an officer who entered the Public Service in a medium other than Sinhala or Tamil will depend, inter alia, on the passing of the Grade I Proficiency Test in one of the Official Languages within one year; Grade II Proficiency Test within two years, and Grade III Proficiency Test (where applicable) within three years from the date of appointment.

Failure to pass a test within the prescribed period will result in the suspension of increments. Suspension will be converted to a stoppage if the test is not passed within a further period of six months beyond the prescribed period such stoppage operating until the test is passed or until such time as the provisions of Section 3:1:6 below apply.

3:1:5 Such officers should, on receiving appointment, be given facilities on full pay, for a period of 6 months to obtain proficiency in one of the official languages. He will thereafter, be required to sit the relevant proficiency examination and if he does not pass he will be given the opportunity to pass the examination within a period of 2 years immediately after the period of 6 months on full pay, while he performs his normal duties.

3:1:6 If he fails to pass the examination in this prescribed period of 2 1/2 years his services will be terminated.

3:1:7 A Public Officer already confirmed in permanent post in the Public Service will not normally be required to serve the period of probation on being appointed to another permanent post in the Public Service. Such Officers may in the first instance be appointed to act in the new post for a

specified period with a view to testing him in his new post.

3:1:8 Selected candidates (Other than those already holding permanent or temporary appointments in the Public Service) who have already been medically examined will be required to undergo a medical examination by a Government Medical Officer to test their physical fitness to serve in any part of the Island.

4. Terms of Engagement :

4:1 Public officers appointed to permanent and pensionable posts should contribute to the 'Widows and Orphans' Pension Scheme from their salary an amount equivalent to the percentage the Government requires to recover from their salary.

4:2 Public officers appointed to permanent or temporary posts on Provident Fund basis will be required to contribute 6% of their consolidated salary to the Public Service Provident Fund. The Government will contribute as its share of contributions an amount equal to 150% of the compulsory contributions credited to the fund at the close of the Financial Year.

4:3 Officers who hold pensionable appointments in the Public Service and who are released for appointments to pensionable posts in the Local Government Service and those officers in the Local Government Service who hold pensionable appointments and who are released for appointments to pensionable posts in the Public Service will be allowed pensionability in their posts in the Local Government Service and Public Service respectively.

4:4 Regular Force personnel in the Army, Navy and Air Force who are released for appointments to posts in the Public Service which are pensionable under the Minutes on Pension will be allowed pensionability in their posts in the Public Service. Notwithstanding anything to the contrary in these Minutes the unforfeited full pay service of any member of the Armed Forces who is released to accept an appointment as a Public Officer in a post which has been declared to be pensionable under these Minutes shall be reckoned for the purpose of any pension or gratuity payable under these Minutes.

5. Serving Officers in the Public Service :

5:1 Applications from officers of the Public Service who possess all the necessary qualifications must be forwarded through the Heads of their respective Departments. In the case of applications from Public Officers holding post in the permanent establishment in the Public Service. Heads of Departments in forwarding such applications should state whether the applicants could be released or not to take up the new appointment, if selected.

5:2 Candidates may be required to present themselves for interview at an appointed time and place. No travelling or other expenses will be paid in this connection.

5:3 Anyone desiring to recommend a candidate should do so by giving a testimonial. Any form of canvassing or any attempt to influence the selection of a candidate will disqualify such candidates.

5:4 Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before the selection and to dismissal if discovered after the selection.

5:5 Application not conforming in every respect with the requirements of the advertisement will be rejected.

6. Definition of Salary for the purpose of Eligibility :

6:1 Salary for purposes of eligibility means only the consolidated salary and does not include any action salary, allowances etc.

7. New National Policy on Recruitment and Promotions :

Recruitment and Promotion in the Public Service, Provincial Public Service, Public Corporate Sector and Companies fully owned by the Government will be done in accordance with the policy laid down in the Public Administration Circulars No. 15/90 of 09.03.1990, 15/90 (I) of 25.03.1990 & 15/90 (ii) of 15.06.1990 with effect from 01.01.1990 subject to amendments that will be done by subsequent Public Administration Circulars.

Rules and Instructions for Candidates

All candidates are bound to act in conformity with the provisions of the Examinations Act, No. 25 of 1968.

All candidates are bound to abide by the rules given below. A candidate who violates any of these rules is liable to one or more of the following punishments at the discretion of the Commissioner of Examinations :—

- (i) Suspension from the whole or part of the examination or one subject or a part thereof ;
- (ii) Disqualification from one subject or from the whole examination ;
- (iii) Debarment from appearing for an examination for a period of one year or two years ;
- (iv) Debarment for life ;
- (v) Suspension of the certificate for a specified period ;
- (vi) Reporting the candidate's conduct to his Superiors or handing over the candidate to the Police or making a complaint to the Police over his action.

The Commissioner reserves himself the right to take action at any time before the Examination or at any stage of it or thereafter, and his decision shall be deemed final. In the case of examinations for recruitment to the Public Service, the decision of Commissioner of Examinations shall be subject to the Supervision of the Public Service Commission.

1. All candidates should conduct themselves in a quiet manner in and around the Examination Hall so as not to disturb or obstruct the Supervisor, his assistants or the other candidates. They should enter and leave the Examination Hall as quietly as possible.

2. Candidates should obey the Supervisor. Therefore, when the Examination is in progress and before the commencement of the Examination as well as immediately after the end of the Examination they should act in accordance with the instructions of the Supervisor and his assistants.

3. Under no circumstances whatsoever will a candidate be allowed into the Examination Hall after the lapse of half an hour after the commencement of a paper. No candidate will be permitted to leave the hall till after half an hour from the time of commencement of the paper. Candidates who come late for Practical and Oral Examinations are liable to be refused admission.

4. Every candidate should sit at the desk bearing his/her index number and not at any other desk. Unless with the permission of the supervisor no candidate should change his/her seat. The occupation of a seat other than the one assigned to him by a candidate is liable to be considered as an act with a dishonest intention.

5. Absolute silence should be maintained in the Examination Hall. A candidate is forbidden to speak to, communicate with or have dealings with any person within or outside the Examination Hall other than a member of the Examination Hall Staff. If there is an urgent need for a candidate to communicate with another, prior permission must be obtained from the supervisor.

6. A candidate's answer script is identified only by the Index Number and his/her name should not be written on the answer script. Another candidate's index number appearing on the answer script of a candidate is considered as an attempt to commit a dishonest act. Answer scripts bearing an index number that is difficult to decipher is liable to be rejected.

7. Candidates should write only on the paper provided and should not write anything on the blotting paper, question paper, desk or any other place. Non conformity with this rule could be taken as an act with dishonest intentions.

8. Any paper or answer book supplied should not be torn up, crushed, folded or erased. Each and every sheet of paper used for rough work should be tied up with the answer script. It should be a part of the answer script. (Such rough work should be neatly crossed out.) Anything written inside the Examination Hall should not be taken out. If a question has been answered twice, the unnecessary answer should be neatly crossed out. Failure to abide by these requirements may be considered as an attempt to cheat.

9. When answering questions in Mathematics the submission of correct answers with incorrect working or with no working at all and in art if the work of art is similar or very close in resemblance to that of another candidate in concept, in form or in execution it is liable to be considered as a dishonest act.

10. The removal of any paper or stationery supplied to candidates out of the Examination Hall is prohibited. All such material remains the property of the Commissioner of Examinations. Breach of this rule shall be liable to be considered an act with dishonest intention.

11. While in the Examination Hall a candidate should not have with him or near him any book, note book, pocket note book, exercise book, sheet of paper or pieces of paper other than the stationery supplied to him. Nor should any handbag, travelling bag or parcel other than the candidate's boxes of colours and boxes of instruments where necessary or any file cover, card board pad, folded newspapers, brown papers should be brought into the Examination Hall. Breach of this rule is a punishable act.

12. A candidate is strictly forbidden to keep with him any book, note book or a sheet of paper with written notes once inside the Examination Hall. Should the Supervisor so requires, each candidate is bound to

declare everything he has with him/her. Breach of this requirement shall be considered as an attempt to commit an act of dishonesty.

13. Candidates are forbidden to copy or attempt to copy from the answer script of another candidate, a book, paper containing notes or any other source. A candidate should not attempt to look at the answer script of any another candidate. A candidate should refrain from helping another Candidate and also from getting help from another candidate or a person. Every completed answer sheet should be kept underneath the sheet on which the answer is being written. Sheets of writing paper should not be strewn all over the desk.

14. A candidate will under no circumstance whatsoever be allowed to leave the Examination Hall even for a brief period during the course of the paper. However in an emergency if a candidate needs to leave the hall, he/she shall be allowed to do under the surveillance of the supervisor or his assistant. He/she shall be subject to search before leaving the hall as well as before re-entering it.

15. Impersonation while answering a paper or before the commencement of the Examination is a punishable offence. Tampering with identity cards, presenting false identity cards or tampering with someone's identity are also such offences. Candidates are warned not to commit such offences.

16. Assistance given to a candidate in a dishonest manner by a person who is not a candidate, is considered a serious offence.

Candidates should adhere to the following instructions for their own safety :—

(i) Be at the Examination Hall well in time. It is sufficient to be at the Examination Hall 10 or 15 minutes before the commencement of each paper. If you have any doubt as to the location of the Examination Hall, make inquiries on a day prior to the date of Examination and be sure of its location.

(ii) In case of any doubt regarding your entry for a paper or eligibility to sit a paper you should bring it to the notice of the Supervisor and get your doubts cleared. Failure to do so may result in your candidature for the subject being cancelled.

(iii) When appearing for the Examination, candidates should produce their identity cards at every paper they sit. If a candidate fails to produce identification documents at the Examination Hall, his candidature is liable to be cancelled. In case a candidate forgets to bring such documents into the Examination Hall, it should be brought to the notice of the Supervisor and arrangements should be made to produce them before the Examination concludes.

(iv) Standard stationery (i.e. writing paper, graph paper, ledger paper, precis paper) will be supplied. If you receive any stationery that is different from the kind generally distributed or distributed to the others it should be promptly brought to the notice of the supervisor. No paper other than those issued at the Examination Hall should be used for answering questions. Excess paper and other material should be left on the desk, in good condition. When log tables are supplied they should be used with care and left on the desk when you leave.

(v) Candidates should bring their own pens, pencils, bottles of ink, erasers, pieces of cloth, rulers, geometrical instruments, coloured pencils, coloured chalk, etc.

(vi) When you start answering you should promptly write down your Index Number and the name of the Examination on each sheet of paper used. Write neatly and legibly on both sides of the paper. Leave a blank line after the answer to each part of a question. After the answer to a full question leave one or several blank lines. Do not crowd in your work.

(vii) The left-hand margin of the answer sheet is set apart for you to enter the number of the question you answer. The right hand margin is reserved for the examiner's use and nothing should be written there. Number your answers correctly as incorrect numbering leads to confusion.

(viii) You should read carefully the instructions given at the head of the question paper, with regard to the compulsory questions and the manner in which the other questions should be selected. Disregard to these instructions is often liable to affect you adversely.

(ix) When Mathematics Questions are answered, give all details of calculations and any roughwork, in their serial order as part of the working of the problem. Necessary sketches, diagrams and figures should be accurate and sufficiently large. In an answer running into several pages if reference must be made to a diagram drawn in an earlier page, that diagram should be drawn repeatedly.

(x) At the end of each paper, arrange your answer sheets in the order you answered the questions. Then using the piece of twine supplied, tie them up at the top left hand corner. Do not tie up at the top right hand corner.

(xi) You should personally handover your answer script to the Supervisor or to an Invigilator. Or else remain in your seat till it is collected. Failure to do so may result in the loss of your script and your being treated as an absentee for the paper. On no account should your script be handed over to a peon or an attendant.

(xii) If it becomes necessary for you to speak to the Supervisor or an Invigilator, or if you need stationery, remain in your seat and raise your hand.

(iv) Other Qualifications :-

- Applicant should be Sri Lankan citizens.
- Applicants should be having an excellent character.

Note : Applicants should have fulfilled all the required qualifications for the recruitment to the post in every aspect on or before the closing date of applications.

03. Conditions for engagement in Service and Service Conditions :-

iv) Should pass the spatial cognition test conducted by KDU.

m. Bachelor of Science (BSc) Honours in Quantity Surveying – Four years (Male)

For those who have followed three (3) of the following subjects at the Advanced Level Examination in **2021 or 2020**, obtained a minimum of three Simple Passes (S) at G.C.E. (A/L) and are eligible to apply for the university admission or obtained a minimum of three “D” Passes at Cambridge / Edexcel A/L or equivalent in 2022 or 2021. (A/L) and are eligible to apply for the university admission or obtained a minimum of three “D” Passes at Cambridge / Edexcel A/L or equivalent in 2022 or 2021. The result should be in one and the same sitting and a maximum of three attempts are allowed.

p. Bachelor of Technology Honours in Information and Communication Technology – Four years (Male)

For those who have followed **Physical Science stream (Combined Mathematics, Physics and Chemistry)**, Biological stream (**Biology, Chemistry, Physics**) or **Technology stream (Engineering Technology, Science for Technology AND one other subject)** at the Advanced Level Examination in **2021 or 2020**, obtained a minimum of three Simple Passes (S) at G.C.E. (A/L) and are eligible to apply for university admission or obtained a minimum of three “D” Passes at Cambridge / Edexcel A/L or equivalent in 2022 or 2021. The results should be in one and the same sitting and a maximum of three attempts are allowed.

In addition, candidates should satisfy the following minimum requirements at the Ordinary Level Examination.

Should have obtained minimum C passes for English, Mathematics and Science for GCE (O/L) Examination or obtained a minimum C pass for English and minimum of “D” Passes for Mathematics and Science at Cambridge / Edexcel O/L or any other equivalent foreign examination

3.5 Selected Officer Cadets/ Student Police Officers must follow common subjects relevant to the degree programme and it is mandatory to follow English, Management, Information Technology, Law, International Relations and military subjects.

3.6 In addition all selected Officer Cadets/ Student Police Officers must continuously must follow Exercises, Drill Activities, Weapon Training, and a Leadership course during their training.

4. (a) Basic eligibility requirements for Officer Cadets and Student Police Officers:

The candidate should:

- (i.) Be a citizen of Sri Lanka.
- (ii.) Be not less than 18 years and not more than 22 years of age by 26.09.2022.
- (iii.) Have Passed GCE A/L Common General Test. (Minimum 30 Marks)
- (iv.) Be eligible to apply for University admission in Sri Lanka.
- (v.) Be unmarried(No Officer Cadet/Student Police Officer will be permitted to get married whilst under training and until permitted to do so by Service/ SL Police Regulations)

(b) Other eligibility requirements:

- (i.) Obtained a minimum of a Credit (C) pass for English language at G.C.E. (Ordinary Level) Examination and obtain minimum of a (C) pass for English language at Cambridge / Edexcel or equivalent for all degree programmes except TESOL. Obtained a minimum of a (B) pass for English language at G.C.E. (Ordinary Level) Examination for BA in Teaching English to Speakers of Other Languages (TESOL).
- (ii.) **Educational qualifications for the Sri Lanka Air Force**
minimum of six Credit (C) passes at the GCE (O/L) examination with compulsory Credit (C) passes for English Language, Science and Mathematics, and a Simple (S) pass or above for Sinhala / Tamil Language in one sitting (additional and optional subjects are not considered).
- (iii.) Candidates who have Cambridge/ Edexcel or any other equivalent foreign qualifications should have obtained a “C” pass for the Sinhala/Tamil Language at the local G.C.E O/L Examination. If the candidate has not sat for the local G.C.E.(O/L) Examination at the time of submitting application, he/she should obtain a “C” pass for the Sinhala/Tamil Language within two years after enlistment as an Officer Cadet/

Student Police Officer. If the candidate fails to fulfil the above requirement within the specified time, he/ she will be discharged from the respective service/ SL Police.

7. Officer Cadets will be paid approximately Rs.45,000/= per month as pay and allowances. In addition, the following facilities will be provided free of charge:

9. Officers of the Army/Navy/Air Force/Police will be governed by the following regulations in respect of their pay prospects and conditions of service:

12. Officer Cadets/ Student Police Officers under training will be required to stay, in the accommodation provided and follow a routine laid down by General Sir John Kotelawala Defence University or by the respective service establishments or Police Department.
13. **Language Requirements** - Selected candidates will be required to comply with any rules and regulations already made or that may hereafter be made for giving effect to the language policy of the Democratic Socialist Republic of Sri Lanka.
14. **Proof of Identity** - Candidates will be required to produce proof of their national identity. 16. The applications without basic qualifications and are not duly filled in accordance with the conditions mentioned herein will be rejected without notification, and in such instances, the application fee will not be refunded. A board appointed by Vice-Chancellor will review all applications received and shortlist them according to qualifications of the candidates. Those who are shortlisted will be called for the preliminary interview.
17. Applicants from Government Service and Corporations or Statutory Bodies should forward their applications *via* online. However, they should produce a certificate issued by the relevant Heads of the Departments/ Corporations/ Statutory Bodies or relevant institutional head at the Preliminary Interview to the effect that the Officer would be released if selected.
18. Preliminary selection will be made from among those candidates who have achieved the required standards in accordance with the evaluation criteria determined by the Selection Committee appointed by the Board of Management of General Sir John Kotelawala Defence University. Candidates who are selected from the first interview will be required to undergo Officer Quality Test (OQT) as may be prescribed by the Board of Management of General Sir John Kotelawala Defence University. The final selection will be made by the Final Selection Committee appointed by the Board of Management of General Sir John Kotelawala Defence University.
19. Candidates who are selected for interviews and Officer Quality Test (OQT) will be informed *via* KDU website of the venues, times and the dates of such interviews. Travelling or other expenses for this purpose will not be paid to applicants.
20. The General Sir John Kotelawala Defence University shall not be held liable for any injuries sustained by candidates whilst undergoing the Officer Quality Test/ Military Training and no candidate shall make any claim whatsoever from the General Sir John Kotelawala Defence University or the Government of Sri Lanka for any injuries sustained whilst undergoing the Officer Quality Test/ Military Training.

(c) Novice Class.– Two (2) compulsory written papers to be undertaken at one sitting :

Paper I - Basic Electricity, Radio and Electronic Theory (02 hours) ; (MCQ Paper)

Paper II - Licensing conditions, operating Practices and Procedures (1 hour); (MCQ Paper)

The Examination for the issue of Amateur Radio Operator's License will be held in **February 2023**.

2. *Minimum Entry Requirements.*– Every candidate appearing for the exam should have the following minimum basic qualifications :-

- Every candidate entering for the examination must be fourteen (14) years of age or over on the closing date of applications.

Syllabus can be obtained from the Telecommunications Regulatory Commission of Sri Lanka or its official website.

5. Conditions of Examinations.– The following conditions shall apply to all categories of Amateur Radio License Examinations :

3. *Medium of Examination.*– The examination will be conducted in English medium only.

I. To pass the examination, the candidate should pass all parts of the examination. The minimum pass mark percentage is 50% in each paper.

4. *Scheme of Examination :*

- Advanced Class.*– The examination consists of 2 parts :

Part 1

Two (2) compulsory written papers to be undertaken at one sitting :

Paper I - Advanced Electrical Technology and Radio communications (3 hours) ;(Written Paper) ;

Paper II - Licensing conditions, operating Practices and Procedures (2 hours).

(MCQ Paper)

Part 2

Practical Morse Code Test (05 words per minute).

II. Candidates must pass the part I of the examination for Advanced Class License at the same sitting.

III. Only those candidates who pass Part 01 of the examination will be allowed to appear for Part II (Morse test) in case of advanced class.

6. *Fees :*

- General Class.*– Two (2) compulsory written papers to be undertaken at one sitting :

(a) Examination Fees (Fees to be paid to the Department of Examinations) The examination fee is Rs. 600.00. This fee can be paid only to any post office/District/Divisional Secretariat in the island under the revenue head 20-03-02-13 of the Commissioner General of Examinations. The receipt issued in this regard should be affixed on the relevant place in the application, so as not to be detached. Examination Fee should be paid separately for each and every application submitted by an individual applicant. The examination fee will not be refunded under any circumstances and money orders and stamps will not be accepted.

(*N.B.*– Should retain a photocopy of the receipt for future use.)

(b) *Testing Fees.*– (Fees to be paid to the Telecommunications Regulatory Commission of Sri Lanka). The testing fee is payable either by cash or Debit Credit (Master and Visa) card draft from any Bank drawn in the name of the "Telecommunications Regulatory Commission of Sri Lanka". The entry form must be sent by recorded delivery on registered post or delivered by hand. Official receipt must be retained as TRCSL will not consider any claim that form has been overlooked or lost unless proof of posting of delivery is produced.

The testing fee is not refundable or cannot be transferred from one test to another at a later date. Any candidate who withdraws his application or cannot appear for the test due to any reason whatsoever will be required to pay approximate testing fee for any subsequent entry.

7. All applicants who are in the age boundary mentioned in the notification and who have paid the prescribed examination fees and forwarded their duly perfected applications with the respective receipt on or before the prescribed date will receive calling letters to appear for the examination by the Commissioner General of Examinations on the presumption that only those who possess such qualifications as indicated in the *Gazette* notification have applied.

Once the calling letters are issued to the candidates, a press notice informing such issuance will be published by the Department of Examinations, Sri Lanka. Applicants who do not receive their calling letters, even after 2 or 3 days of such notification should inquire from the Administration branch of the Department of Examinations. Sri Lanka in the manner specified in the advertisement. When inquiring so, indicate accurately the name of examination the applicant applied for, full name of the applicant, National Identity Card Number and the address. In case of an applicant outside Colombo, it will be more effective to forward a letter

of request along with the above information, indicating a fax number to which the copy of the calling letter could be faxed in a rapid manner to the fax number indicated in the notice. When inquiring so, it will be advantageous to keep in hand the photocopy of the application form kept at your possession and the copy of the payment receipt received after paying the respective examination fee and the receipt of registration received when posting the application to prove any particulars asked by the Department of Examinations.

8. *Attestation.*– Candidate's signature must be attested by one of the following :

Applicant's signature should be attested on the application. The signature of an applicant by a head of a government school/retired officer, Grama Niladhari of the division. Justice of Peace, Commissioner of Oaths, Attorney-at-Law, Notary Public, a Commissioned Officer of three armed forces, a permanent government or local government staff grade officer, the incumbent of a Buddhist temple, chief monk or the incumbent of a place of worship or any clergy holding a recognized position.

9. *Identification of Candidates.*– A candidate will be required to prove his/her identity in the examination and for this purpose any of the following documents will be accepted :

- I. National Identity Card ;
- II. Valid Passport ;
- III. Valid Sri Lanka Driving License ;
- IV. Valid Postal Identity Card (Only for candidates below 16 years)

Also, candidates should arrive without covering the face and ears so as to verify their identity. Candidates who refuse to verify their identities will not be allowed to face the structured interview. Further, candidates should remain without covering the face and ears so as to be identified by the examination authority until the examination is finished and candidates are allowed to leave.

All candidates required to act in conformity with the provisions of the Examination Act, No 25 of 1968. Any matters which have not been provided for under these Rules and Regulations will be settled at the discretion of the Director General of Telecommunications.

10. Candidates are bound by the rules and regulations imposed by the Commissioner General of Examinations

on conducting the examination. He or she will be liable to any punishment imposed by the Commissioner General of Examinations for breach of such rules.

11. Closing Date of Application.– The examination will be held once a year. The date of examination will be informed by the Commissioner of Examinations. Applications must be made on the appropriate entry form obtained from the Telecommunications Regulatory Commission of Sri Lanka and submitted to the address given below on or before the closing date mentioned below :-
