As prayed for in the prayer of the plaint and entered in the decree dated 17.11.2021, it is hereby ordered decreed that the 1st and 3rd defendants, shall pay the plaintiff a sum of Rs. 380,752.21 together with interest at the rate of 4% per month from 01.11.2017 until the date of plaint and thereafter legal interest on the aggregate sum until payment in full.
