All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication i.e. Notices for publication in the weekly *Gazette* of 28th July, 2023 should reach Government Press on or before 12.00 noon on 14th July 2023 Electronic Transactions Act, No. 19 of 2006 - Section 9
