Local Government Notifications

LONG DISTANCE BUS STAND

THE decisions taken in the meeting regarding long distance bus stand held on 08.12.2021 at 03.00p.m, with the participation of 15 representatives including Hon.Mayor, Commissioner of Jaffna Municipal Council, Chief Engineer, Director of UDA Northern Province, OIC of Traffic and President of Northern Regional Transport Authority and president of private bus institution and representative of Archeological Department are as follow :-

1. It is decided to conduct 3 services (Local services, out district services and night service buses to Colombo) from private bus stand since 15.12.2021.
2. It is decided that direction sign boards will be fixed by Municipal Council. The traffic police should implement the rules regarding roads strictly.
3. It is accepted that the private local service buses to stay at current place for 10 minutes, after the departure from long distance bus stand. All local service buses have to drop passengers at long distance bus stand.
4. It is decided that the buses start their journey from CTB bus stand will reach saththira junction (color signal) through Hospital road and go to out district through k.k.s road and Main Street and the buses coming from out district will also have to use this way. The decision will be implemented immediately and the cooperation to it would be given by traffic police.
5. It is decided that the long distance buses, Start from CTB bus stand will not be allowed to travel through hospital road to reach vempadi junction.
